Vital to strengthen ties with Global South: PM

LIMA (PERU): Prime Minister Datuk Seri Anwar Ibrahim has stressed the importance of strengthening ties with the Global South, highlighting the vast untapped potential and

emerging opportunities in the region.

"It is crucial to shift course slightly and enhance collaboration with the Global South, tapping into the vast new potentials and opportunities," he said in his opening remarks during a roundtable with captains of industry from Malaysia and Peru on Wednesday. He said the focus has historically been on

a narrow set of partners, but the changing global dynamics present a compelling case for broadening the horizons and diversifying

He added that while the United States remains Malaysia's top investor, Putrajaya also has a strong trading partnership with China, "and we are collaborating effectively in multiple areas. That is the way forward".

"We should not be dictated to by anyone. Instead, we must be guided by what is best for our country, as determined by our own

people.
"I believe Malaysia and Peru share the same perspective. We need to remain open and neutral. In Asean, we call it centrality."

Anwar said both countries share several major concerns, as both are multiracial, and are working to bring about change and transition within the respective nations.

"Peru has policies on energy transition, environmental transition and multilateralism as well as investment, trade, governance and anti-corruption efforts. All these areas are critical, and I express that now is the time to

He said alignment of some of the policies

between Malaysia and Peru is encouraged, as both countries are members of the Comprehensive and Progressive Agreement for Trans-Pacific Partnership.

"We are now closely linked through Asean and the Asia Pacific Economic Cooperation.

Anwar also launched Yinson Holdings Bhd's Matarani Solar Park in Peru.

Yinson Renewables has completed the acquisition of the 97 MWp Matarani solar project in Peru from Grenergy Renewables, an international independent power producer, developer, and engineering, procurement and construction company

with a strong track record in Latin America.

The project is located in the Mollendo desert in the Arequipa region, one of the world's highest solar irradiation areas. Most of the project's energy has been contracted through a power purchase agreement with a bankable off-taker for the next 15 years.

Project Matarani had recently entered commercial operation, injecting about 260 GWh of renewable energy into the Peruvian grid annually, enough to meet the energy needs of about 62,000 Peruvian households and prevent the emission of more than 56,000 tonnes of carbon dioxide per year.

Anwar receives Peru's highest honour

LIMA (PERU): Prime Minister Datuk Seri Anwar Ibrahim received Peru's highest honour, the El Sol del Peru, during his first official visit to the Latin

American nation since assuming office in 2022.

The conferment was done by Peruvian
President Dina Ercilia Boluarte Zegarra at the

Government Palace on Wednesday.

El Sol de Peru (The Sun of Peru) is awarded to sovereigns, heads of state, government heads, foreign affairs ministers, state ministers, accredited foreign ambassadors or presidents of public

Anwar said he is deeply honoured to be conferred the prestigious Order.

"I understand that this distinguished award was established soon after Peru declared its independence from Spain in 1821, making it the oldest civilian honour in the Americas.

"As with any honour I receive in my role as prime minister, I accept this distinction on behalf of the people of Malaysia. We will cherish this as a symbol of the enduring friendship between our two nations," he said after receiving the Order.

Anwar, who is also finance minister, said Peru holds a certain familiarity that is hard to ignore.

"Like Malaysia, it is a thriving multicultural society, with a megadiverse ecosystem that mirrors our own. Both our nations strive to adapt amid growing geopolitical shifts and economic rivalries.

He said Malaysia sees immense potential in strengthening cooperation in areas such as trade and investment as well as promoting the interests of the Global South.

"The tyranny of distance will not hold us back

from building a fruitful partnership."

He added that it is his sincere hope that this would mark a new beginning in the relationship between both countries.

Anwar's visit to Peru, which includes his

participation in the 31st Apec Economic Leaders Meeting from yesterday to Nov 16, is expected to strengthen bilateral relations between Malaysia and Peru.

He is accompanied by Foreign Minister Datuk Seri Mohamad Hasan and Investment, Trade and

Industry Minister Datuk Seri Tengku Zafrul Aziz. Peru, a western South American country, is bordered by Ecuador and Colombia in the north and Brazil in the east. – Bernama

Peruvian president to visit M'sia next year

LIMA: Prime Minister Datuk Seri Anwar Ibrahim said Peruvian President Dina Ercilia Boluarte Zegarra has accepted his invitation to visit Malaysia.

He said the visit is expected to take place by the end of next year.

"I invited President Dina Ercilia to visit Malaysia and she immediately accepted my invitation," he said after their bilateral meeting at the Government Palace on Wednesday, Bernama reported.

The meeting with Dina Ercilia is a follow-up to the first meeting of the two leaders on the sidelines of the Apec Economic Leaders' Week in San Francisco in the United States in November 2023.

Plan to place Felda under ministry to be discussed

KUALA LUMPUR: The proposal for the Federal Land Development Authority (Felda) to be placed under the Rural and Regional Development Ministry will be presented to the Cabinet for discussion, Dewan Rakyat was told on Wednesday. Minister in the Prime Minister's

Department (Federal Territories) Dr Zaliha Mustafa said the ministry would require specific discussions with Prime Minister Datuk Seri Anwar Ibrahim through the Cabinet meeting.

"(The proposal) will be brought to the knowledge of the Cabinet and relevant ministers."

Felda is now under the Felda Regulatory Division of the Prime Minister's Department, Bernama reported.

Earlier, several MPs proposed for Felda to be regulated by the ministry, with Datuk Mohd Isam Mohd Isa (BN-Tampin) saying this would facilitate coordination with the Rubber Industry Smallholders Development Authority and the Federal Land Consolidation and

Rehabilitation Authority.

On the Settler Development
Programme, which is an initiative to
increase the income of Felda settlers through agricultural and livestock activities, Zaliha said in 2019, the government allocated RM1 billion for the programme's implementation and Felda has received RM253 million.

Commenting on the RM6 million allocation for the development of Kampung Baru under Budget 2025, she said it was an allocation for the continuation of projects next year to build amenities at the Kampung Pindah field reserve in Kampung Baru here.

Fuel prices remain unchanged

KUALA LUMPUR: Retail prices for RON97 and RON95 petrol will remain unchanged at RM3.19 and RM2.05 per litre,

respectively, from Nov 14 to 20.
The Finance Ministry said the retail price of diesel in Peninsular Malaysia will remain at RM2.95 per litre while in Sabah, Sarawak and Labuan, the price will remain at RM2.15 per litre during the

same period.
It said the price settings are fixed based on weekly retail prices of petroleum products, using the Automatic Pricing Mechanism.

"The government will continue to monitor the trends of global crude oil prices and take appropriate measures to ensure the continued welfare and wellbeing of the people." – Bernama

Demand for plant-based foods rising, say experts

PETALING JAYA: A surge in demand for plant-based foods, driven by the growing popularity of the "flexitarian diet", is reshaping eating habits worldwide, said food

science experts.
Universiti Teknologi Mara
(UiTM) Food Science and
Technology senior lecturer Dr Siti
Aimi Sarah Zainal Abidin said the shift reflects a mix of health and environmental considerations as more people embrace plant-based diets as a sustainable and nutritious choice.

"A growing number of Malaysians are adopting a plant-based diet for health and environmental reasons, particularly in the wake of increased awareness on sustainable development goals (SDGs) and the need to reduce carbon footprint." Shift reflects mix of health and environmental considerations in adopting sustainable and nutritious diet: Lecturer

She said health concerns are a major driver of this trend as plant-based foods offer a range of health benefits, especially in terms of cardiovascular health.

She also said a long-term plant-based diet could reduce blood pressure and cholesterol, help maintain a healthy weight due to its high fibre content and prevent conditions such as diabetes, hypertension and digestive issues. She highlighted the

She highlighted the environmental impact of reducing meat consumption as its production is a significant contributor to carbon emissions.

According to her, with SDGs

encouraging society to lower its carbon footprint, plant-based foods are emerging as a sustainable choice but there are some challenges associated with adopting such diets in Malaysia, with one barrier being the high prices.

Siti Aimi said since most raw materials are imported and sold at high prices, Malaysians could explore local ingredients.

She said there are lingering

misconceptions that limit the adoption of plant-based diets, with many believing they do not provide enough essential nutrients. "There is the perception that

intake, such as a lower risk of certain diseases and reduced impact on natural resources, they increasingly drawn plant-based options. "The younger generation of Malaysians are more open to plant-based foods, becoming more health-conscious and more health-conscious and environmentally aware. This trend is evident in the growing variety of plant-based products in grocery stores, more vegan and vegetarian

menu options, and an expanding presence of plant-based eateries and brands."

She clarified that although a plant-based diet has numerous health benefits, it is critical to consume sufficient nutrients, which are often obtained from supplements containing essential elements, such as vitamin B12, iron and omega-3 fatty acids.

"With a balanced nutritional plan, individuals could meet their

plan, individuals could meet their needs through carefully selected foods, fortified options and supplements, if needed."

She said taking small, manageable steps towards plant-based diets could support one's personal health and environmental goals.

App to ease checkpoint traffic down south

SINGAPORE: The Home Ministry has selected an app to facilitate immigration procedures for Malaysians at the Sultan Iskandar Building and the Sultan Abu Bakar Complex in Johor for entry and exit to Singapore, said its minister Datuk Seri Saifuddin Nasution Ismail.

The MyTrip, MyRentas and MyBorderPass apps are undergoing proof-of-concept (POC) trials at the Sultan Iskandar Building and the Sultan Iskandar Building and the Sultan Abu Bakar Complex to evaluate their effectiveness in reducing congestion at the Malaysia-Singapore border.

"The ministry has finalised one of

the three vendors that we trialled under the POC. We submitted our recommendation to the Finance Ministry last week for approval," he told Bernama at a gathering with the Malaysian diaspora in Singapore on Wednesday night.

He said an announcement regarding the chosen app will be made soon, adding that the POC trials showed that the app effectively reduced wait times and addressed congestion issues.

Upon implementation, travellers will still need to carry their passports for verification, although immigration procedures could be completed via

Initially, the app would be available for bus and motorcycle travellers at the Sultan Iskandar Building and the Sultan Abu Bakar Complex before it is expanded to serve all travellers across all 141 entry points in Malaysia.

According to data analysis, bus and motorcycle travellers make up nearly 80% of daily cross-border traffic while private and commercial vehicles account for the remaining 20%.

"This app will contribute

overcoming issues related to the development of the Johor-Singapore Special Economic Zone (JSSEZ), facilitating the movement of people and goods."

He said discussions are ongoing with Singapore regarding Malaysia's proposal for a single-entry immigration checkpoint for the Rapid Transit System (RTS) Link, which is under construction.
"The RTS Link will carry up to 10,000

passengers per hour, so it needs to be seamless. This will be a focus of discussions at my upcoming meeting with Singapore Home Affairs and Law Minister K. Shanmugam on Thursday."
The RTS Link is a 4km passenger rail

network with one station in Bukit Chagar, Johor Bahru and one in

Woodlands North, Singapore.

He said his ministry is open to considering a special pass for Singaporeans with residences in Johor, particularly with the development

Cancer society pushes on with education campaign

Efforts to focus on countering negative beliefs about breast screening among Malaysian women to increase uptake and reduce late diagnosis

PETALING JAYA: The National Cancer Society of Malaysia (NCSM) is determined in its aggressive public education campaign to

halt the growing incidents of the disease.
Its managing director Dr M. Murallitharan told *theSun* that one in 10 men and one in nine women are at risk of developing cancer, with the five most common variants being breast, colorectum, lung, nasopharynx and liver, in that order.

"This is a serious issue and it needs all parties to work together to bring about public awareness, especially since in 2020, Malaysia reported 48,639 new cases. Cancer incidence in the content of the

in the country is predicted to double by 2040." He cited a study titled "Breast Cancer and Breast Cancer Screening Use - Beliefs and Behaviours in a Nationwide Study in Malaysia", co-authored by Min Min Tan, Aminatul Saadiah Abdul Jamil, Roshidi Ismail, Michael Donnelly and Tin Tin Su, and published on July 10, 2023.

In the study, the authors said many

upper-middle income countries, including Malaysia, continue to face low breast cancer screening rates and patients with delayed presentation of the disease.

Murallitharan said the study investigated whether beliefs about breast cancer and the use of screening reduced the possibility of patients dying from the disease

He said 813 women aged about 40 were randomly selected and surveyed using the validated "Awareness and Beliefs about Cancer" measure.
"The association between breast cancer

screening, sociodemographic characteristics and negative beliefs about screening for the

disease were analysed.
"It was shown that seven out of 10 Malaysian women believed that breast cancer screening was necessary only when experiencing cancer symptoms.

"Women over 50 years old and from households with more than one car or motorcycle were 1.6 times more likely to attend a mammogram or a clinical breast examination, while about 23% expected to feel anxious about attending screening

sessions, leading them to avoid it altogether.

He said the study concluded that public health strategies or behaviour interventions targeting negative beliefs about breast cancer screening among Malaysian women may increase uptake and reduce late presentation and advanced-stage cancer.

He also said insights from the study suggested that women under 50 years old, in the lower income group without a car or motorcycle, and of Malay or Indian ethnicity are more likely to hold beliefs inhibiting breast cancer screening.

"This is why NCSM must continue with its awareness campaigns and raise funds to

support its work."

Muralitharan thanked UMW Toyota Motor Sdn Bhd (UMWT) for its RM200,000 donation, which was handed to NCSM on Wednesday.

"NCSM's collaboration with UMWT continues to raise awareness about cancer and the impact it has on patients and caregivers. Its commitment towards our cause has positively impacted many lives and we aim to continue the good work together."

He said the funds raised through the partnership would be used to ensure greater mobility for patients by providing them with reliable transport for treatment sessions.

"This would alleviate one of the significant challenges that many face in accessing the care they need. The funds would also help amplify our community outreach programmes, enabling us to extend our services to more areas and reach more individuals in need of support."

UMWT president Datuk Ravindran K. said Toyota believes in the power of mobility to improve lives.

"All the details (of trip expenses) will be examined by the state financial secretary," he said during the third reading of the Supplementary Supply (2024) Bill.

Kelantan set to better manage natural resources

KOTA BHARU: A proposal to prevent foreign companies from monopolising the management of the rare earth elements (REE) industry in Kelantan presents an opportunity for the state government to better manage natural resources, said Kelantan Deputy Menteri

Besar Datuk Dr Mohamed Fadzli Hassan. He said the federal government's suggestion grants the state administration the right to negotiate with any mining company.

"Kelantan warmly welcomes this proposal and many companies, not just Lynas Malaysia Sdn Bhd, have shown interest and held discussions with us," he told reporters after the state executive council meeting at the Kota Darulnaim Complex on Wednesday.

"We are identifying mining companies that are truly capable and can offer

He said the state government not only intends to carry out mining activities but also aims to set up processing plants in Kelantan to maximise profits

Natural Resources Earlier, Environmental Environmental Sustainability Minister Nik Nazmi Nik Ahmad was reported as saying Niki Nazmi Nik Anmad was reported as saying the government would utilise the Mineral Development Act 1994 and Federal Constitution in managing REE. He said the federal government does not

intend to encourage a monopoly company for managing REE, similar to how Petroliam Nasional Berhad operates in the oil and gas sector, Bernama reported.

Commenting on the proposal for the construction of a security and flood wall along

the Malaysia-Thailand border, he said the state government would cooperate with the federal government in discussing the matter.

"The border between Kelantan Thailand is not a state border but a national border, so it is the responsibility of the federal government.

"The construction of the wall would not only address security concerns but also involve the development of border towns, such as Rantau Panjang and Pengkalan Kubor." On Nov 5, the Kelantan government

announced plans to propose to the federal government the construction of a wall spanning about 100km along the state's border with Thailand.

The project is seen as crucial in addressing smuggling activities and flood issues.

Parties invited to join rare earth industry

SEREMBAN: Negeri Sembilan is prepared to welcome any company, including private landowners, interested in managing the non-radioactive rare earth element (NR-REE) industry in the state, said Menteri Besar Datuk Seri Aminuddin Harun

"What is important is transparency. We do not want people with no experience to do it. (For) government land, we have to choose only capable companies," he told reporters after chairing the weekly state executive council meeting at Wisma Negeri on Wednesday.

He said the state would give interested parties between one and six months to explore

an area for the project.

It was reported that two areas of about 400ha in the state have been approved for NR-REE mining, which will start soon.

Aminuddin said Negeri Sembilan is expected to earn higher revenue this year than the RM520 million target it set in last year's budget.

"The state's revenue has reached 95% and is expected to exceed the target by the end of the year." – Bernama

Swimming coach denies sexually assaulting boy

KUALA LUMPUR: A swimming coach pleaded not guilty in the Sessions Court here yesterday to a charge of sexually assaulting a

five-year-old boy last week. Ng Gwan Ho, 27, is accused of committing the act against the child for sexual purposes at a swimming school in Taman Sri Bintang, Sentul on Nov 7.

The man was charged under Section 14 (d) of the Sexual Offences Against Children Act 2017, which provides for a maximum prison sentence of 20 years and whipping, upon conviction.

Deputy public prosecutor Atiqa Nazihah Azmi proposed bail of RM10,000 with one surety and additional conditions for the accused not to approach the victim, report to the nearest police station once a month, and hand over his passport to the court until the case is disposed of.

Judge Azrul Darus allowed the accused to

be bailed at RM10,000 with one surety with the additional condition of having to hand over his passport to the court.

He fixed Dec 17 for case mention.

KOTA BHARU: The General Operations Force (GOF) confiscated three types of birds worth nearly RM40,000 that were kept without approval in Kampung Dusun Durian, Tawang in Bachok.

No council nod for 'patriotic' rally

Defence Minister Datuk Seri Mohamed Khaled Nordin said it is among eight improvement actions and prevention mechanisms that have been and are being taken to prevent incidents of bullying from beautority action. happening again.

He said meeting between cadet officers and

top officials of the academy and the university will also be held exclusively to provide a free space without fear to obtain information on

misconduct among cadet officers.

"This is to overcome the issue of cadet officers' reluctance to report inappropriate incidents," he said.

incidents," he said.

He was replying to Nordin Ahmad Ismail (PN-Lumut) regarding efforts to ensure bullying activities at the university are stopped during the minister's question time in the Dewan Rakyat yesterday.

Mohamed Khaled said the Armed Forces had also increased the staffing of officers and other ranker assigned to the grademy and the

other ranks assigned to the academy and the university. Trainers are also added to increase monitoring of cadet officers, Bernama reported.

He said the Armed Forces also assigned a trainer on duty for each company to enable closer monitoring of cadet officers on a daily

'Trainers on duty have been instructed to

patrol the accommodation of cadet officers after 11.59pm every day," he said, adding that action will be taken against cadet officers found guilty of abuse. Starting from February 2023, seven

closed-circuit cameras have been installed at several levels of accommodation blocks to detect suspicious activities, he said, adding that the ministry is planning to increase the number according to need and suitability. Meanwhile, first-year cadet officers, who are the usual target of abuse, have been isolated at

Bukit Putera since April, and are placed under full control of an instructor.

Mohamed Khaled said the cases of bullying reported in the academy only increased this year, while only one case each was recorded in 2022 and 2023.

The ministry will expose any forms of offences and impose severe punishments on bullies besides emphasising the seriousness of the offence of conspiring to hide bullying incidents in the academy, he added.

Don't fall for scammers' baits, tech grads told

MALACCA: Graduates with expertise, especially in information and communication, have been advised to exercise caution to avoid becoming victims of human trafficking syndicates or scammers looking to

exploit their skills for criminal activities.

Bukit Aman Criminal Investigation
Department (CID) Director Datuk Seri Mohd Shuhaily Mohd Zain said with technological advancements and the lure of attractive salaries, these individuals are increasingly at risk of being targeted.

"From my field research, we are dealing with more complex human trafficking cases. While these syndicates may not always need highly specialised skills, they do seek individuals with

at least basic knowledge of systems and

"Those with technology skills are also targeted," he said after officiating at the closing ceremony of the 2024 Attipsom Enforcement Seminar, themed "Awareness to Action: Mobilising Against Human Trafficking and

People Smuggling", on Wednesday.

He also advised recent graduates from higher learning institutions to be wary of high-salary job offers, especially from overseas.

"On average, we know that entry-level

salaries here range from RM1,500 to RM2,200, while scammers can offer between RM4,000 and RM5.000

"For young job-seekers eager to start their

careers, this is understandably enticing, and these job ads often appear legitimate, offering positions like customer service or technical support without any indication of involvement in online gambling."

He said authorities have also found that some Malaysians have been unintentionally involved by encouraging friends to work abroad, especially young graduates who are unaware that they are being drawn into syndicate networks.

Mohd Shuhaily warned that job offers in

countries like Vietnam, Cambodia, Laos or Myanmar should be approached with caution and need to be thoroughly verified by job-seekers. – Bernama

Police detain three, seize drugs worth RM2mil

TANJUNG MALIM: Police detained three individuals, including a married couple, and seized more than 51kg of methamphetamine at the Slim Perdana Business Centre in Taman Sri Jaya near Slim River on Monday.
Bukit Aman Narcotics Crime Investigation

Department (NCID) Director Datuk Seri Khaw Kok Chin said the arrests, made in collaboration with Perak and Perlis NCID, involved intercepting a rented Proton Preve at a parking lot at 3.35pm.

"Police apprehended two local men and one local woman, aged between 25 and 27, who served as transporters.

"They had concealed 50 plastic packets

containing methamphetamine powder and crystal chunks inside suitcases in the car's trunk.

"The 51.97kg drugs seized are valued at about RM2 million," he said at the Muallim

district police headquarters here yesterday. He added that it is believed the syndicate smuggles drugs from a neighbouring country and distributes them to the Klang Valley market via land routes.

via idilu routes.

Khaw said investigations found that the first suspect, aged 25, was paid RM2,000 for each drug delivery, while the third suspect, aged 27, received RM100.

He added that the syndicate had been active since January.

The seized drugs could supply to about

260,000 drug users.

Khaw said the suspects have been remanded for a week until Nov 18 to assist in investigations under Section 39B of the Dangerous Drugs Act 1952. - Bernama





Move to prevent 'marine roadkill' involving dolphins

PETALING JAYA: Malaysia needs to urgently implement a "boating code of conduct" to protect dolphins and other endangered mammal species before more of them wash up dead on our beaches, said a marine research and conservation NGO that studies mammals to enhance conservation and increase public awareness.

MareCet Research Organisation outreach

and education coordinator Aizatul Jasmine Azizan said protecting the mammals requires urgent action to manage marine

"Implementing such a code of conduct for dolphins is important, especially in their hotspots such as Perlis, Kedah and Langkawi Island, where tour boats, ferries and shipping vessels are prevalent.

"The code of conduct would introduce safety measures like speed limits in high-risk areas, helping to reduce threats like noise pollution, collisions and boat strikes."

Additionally, she called for the establishment of protected areas in core marine mammal habitats and protected

She was commenting on an incident on Nov 10 in which a dolphin carcass was found on Teluk Bahang beach in Penang. It is believed to have died from injuries possibly caused by a ship collision, breaking free from a fishing net or while hunting for food in shallow waters.

Aizatul Jasmine said it has become increasingly common for carcasses to wash up on shores, including those of dolphins, porpoises and even dugongs (sea cows). At

heast three cases are reported annually, with many others going unreported. She said one of the primary threats to dolphins is being caught as "bycatch", in which accidental entanglement in fishing nets results in serious injuries or even death.

"Dolphins often target the same fish that fishermen are after, so they may try to catch fish already trapped in the nets or simply feed in their natural grounds, which overlap with active fishing zones.

The impact goes beyond individual dolphins, as these incidents can affect their overall population and disrupt the balance of marine ecosystems."

Aizatul Jasmine said

Aizatul Jasmine said public and stakeholder support is critical, adding that nine out of 10 Malaysians are unaware that dolphins inhabit Malaysian waters.

University Putra Malaysia Department of Biology marine biologist Dr Wan Mohd Syazwan Wan Solahudin said public awareness about endangered species such as dolphins is relatively low, especially in rural coastal areas where the direct impact of

marine conservation is less visible.

"Fishermen and boat operators should also be trained to report dolphin sightings and strandings while learning to avoid harmful practices that threaten their survival.

"Additionally, promoting dolphin-watching tours as a sustainable and eco-friendly activity can raise awareness and provide an economic incentive for provide an conservation."

Wan Mohd Syazwan said dolphins in Malaysian waters are highly threatened by human activity, with plastic waste and

chemical pollutants posing serious risks to their health and reducing their ability to thrive in marine environments.

"As top predators, losing even one dolphin can throw the ecosystem off balance by allowing their prey numbers to grow unchecked.

"This can harm other species that are lower in the food chain and disrupt their hunting efficiency and reproductive success. In the long run, it could be harmful to dolphin biodiversity."

Wan Mohd Syazwan said while it is important to assist stranded or injured mammals, individuals should avoid approaching or touching them as this could

cause further stress or injury.
"Immediately contacting the nearest fisheries authorities or active NGOs for assistance is best as under Malaysian law, marine mammals including dolphins are protected under Section 27 (3) of the Fisheries Act 1985."

The Act states that they are not allowed to be fished, disturbed, touched, captured, killed or taken. Offenders face a fine not exceeding RM5,000.

Churches, temples live-stream prayers for stressed-out exam parents

SEOUL: Nine-hour prayer sessions, live-streamed speaking in tongues, bowing before a Buddhist altar 108 times, South Korean parents are turning to God as students sat for a crucial exam yesterday.

The "Suneung" university entrance exam is a major event in the educationobsessed country, and officials take extreme measures, from rescheduling flights to pausing construction, to ensure students can give their best performance.

At a church in Seoul's wealthy Gangnam district, parents gathered for a nine-hour prayer marathon, with specific requests to God tailored around the structure of the multiple choice exam, which will be taken by 522,670 students

"I was so nervous that I couldn't sleen last night but the praying session made me feel much better," said parent kang Soo-jung, adding that she planned to stay for the entire event

For the first session – Korean language priests prayed for students to read clearly, and when it moved to maths, parents asked God for their children to perform smooth calculations.

At a church on the outskirts of Seoul,

pastor Han Seung-woo was leading a prayer session for hundreds of parents. Many wept as he asked God to bless their test-taking offspring with "wisdom and

"I shared my hopes that, regardless of whether students do well on the exam. parents can find reassurance in knowing that God is with them every step of the way," Han said.

Pastor Lee Chan-soo, who has held "Suneung prayer sessions" since 1992, said he tried to use the sessions to prepare parents to face any exam disappointments with equanimity.

"The Suneung isn't everything in life. It's just the start. They are still our loving children and God's children regardless of the test scores," he said.

At the Bongeunsa Buddhist temple,

head monk Wonmyung comforted parents trying to help their children.

Some parents bowed 108 times before an altar to make wishes come true.

erice an aitar to make winses come true.

"I know this is one of the most important days in a parent's life," Wonmyung said, adding that it was all about "praying so that (the students) have peace and calm in their minds".

For parents who were unable to pray in person, many churches and temples streamed the sessions live on YouTube. Yoido Full Gospel Church, one of the

largest churches in South Korea with about 480,000 members, is holding a YouTube live session for the duration of the exam, featuring gospel songs and the faithful speaking in tongues. BTN, South Korea's largest Buddhist

television channel, broadcast chants that parents can join from home.

If parents donate, their hopes for their child's exam results and the student's name will scroll across the screen. – AFP

Philippines will not block ICC in possible Duterte probe

Ex-president defends deadly anti-drug crackdown

MANILA: Philippine President Ferdinand Marcos Ir said vesterday his government would not block the International Criminal Court (ICC) if former leader Rodrigo Duterte wants to be investigated for alleged crimes against humanity in his anti-drugs crackdown.

The Philippines will not cooperate with the ICC but it has obligations with Interpol, Marcos

"If that's the wish of (Duterte), we will not block ICC. We will not just cooperate.
"But if he agrees to be

investigated, it is up to him,"

Marcos said.

His remarks follow a marathon congressional hearing on Wednesday during which Duterte, president from 2016 to 2022, refused to applogise for his role in the bloodshed and urged the ICC to

start its investigation.

Duterte remained defiant during Wednesday's hearing as he defended his drugs crackdown, which was a key plank of his election campaign, during which he had promised thousands of drug pushers and criminals would be killed.

"I have nothing to hide. What I did, I did it for my country and for the young people. No excuses. No apologies. If I go to hell, so be it, said the 79-year old Duterte at the hearing, which was also attended by families of drug war victims

"I am already old, I might die soon. You might miss the pleasure of seeing me standing before the court hearing the judgment whatever it is," Duterte said, adding he assumed full responsibility for what happened.

All testimony provided by Duterte will be assessed to see their legal consequences, Marcos said.

Duterte unilaterally withdrew

the Philippines as a member of the ICC in 2019 after it announced it had started a preliminary examination into thousands of killings in his anti-narcotics campaign.

He questioned its authority to

conduct an investigation, and insisted during Wednesday's hearing it no longer has jurisdiction over the Philippines.

Marcos said the government was

monitoring developments because

responsibility for the extrajudicial

killings had not been established.
"And we had the mothers of some of the victims that were there, and up to now, they have not seen the justice for the murders of their children," he said.

Under Duterte, police said they killed 6,200 suspected dealers who had resisted arrest during their anti-drug operations.

But human rights groups believe the real toll to be far greater, with thousands more users and peddlers gunned down in mysterious circumstances by unknown assailants.

Authorities at the time said those were vigilante killings and drugs gangs eliminating rivals. Rights groups and some victims accuse police of systematic cover-ups and executions, which they deny,

Sri Lankans vote with economic reforms at stake

COLOMBO: Sri Lankans began voting yesterday in a snap election to decide if the island would give its new leftist president greater strength to help the poor as it recovers from a financial meltdown.

Just over 17 million Sri Lankans are eligible to elect lawmakers to the 225-member parliament for a five-year term. A record 690 political parties and independent groups are in the fray across 22 electoral

"I think we are seeing the first signs of a positive political change in Sri Lanka after the president was elected and we should give him the chance to continue that change, said Umeshi Perera, 32, who queued to vote in a Colombo suburb

The president, Marxist-leaning Anura Kumara Dissanavake, 55, was elected in September but his National People's Power (NPP) coalition had just three of parliament's 225 seats, prompting him to dissolve it and seek a fresh mandate.

proceeding Voting was smoothly, a police spokesman said.

"The military is also on standby to assist the police but we do not expect any incidents," said the spokesman, Nihal Thalduwa.

Analysts say Dissanavake's coalition is expected to draw significant support, while a victory for a rival could lead to a policy logjam the country cannot afford. A political outsider in a country

dominated by family parties, Dissanayake backs policies to fight

poverty, such as bigger welfare schemes, as well as battle graft. Sri Lanka typically backs its president in general elections, especially if they are held in quick succession.

The president wields executive

power but Dissanavake still requires a parliamentary majority to appoint a fully-fledged Cabinet and deliver on key election promises to cut taxes, support local businesses and fight poverty.

This election is critical as it is a test for the NPP to get the numbers needed for the IMF package and to take forward promised governance constitutional and economic reforms," said Bhavani Fonseka, a researcher at Colombo's Centre for

Policy Alternatives.

The main challenger to
Dissanyake's coalition is the Samagi
Jana Balawegaya party of
opposition leader Sajith Premadasa, who favours a mix of interventionist and free-market economic policies.

Also a key contender is the New Democratic Front, backed by former

president Ranil Wickremesinghe.
A nation of 22 million just across A nation of 22 million just across the southern tip of India, Sri Lanka was crushed by a 2022 economic crisis triggered by a severe shortage of foreign currency that caused its economy to shrink by 7.3% in 2022 and 2.3% last year.

Boosted by a US\$2.9 billion (RM13 billion) bailout programme from the International Monetary Fund, the economy has begun a tentative recovery, but the high cost of living is still a critical issue for many voters, especially the poor.

"In September people gave us victory," Dissanayake said on Sunday near the end of campaigning.
"The next task is to unite people

from the four corners of this country and build a powerful people's and build a powerful movement." – Reuters



Flights to Bali resume following volcanic eruptions

JAKARTA: Several airlines resumed flights to Bali yesterday, after cancelling trips to and from the resort island due to huge eruptions at a nearby volcano.

Eighty-three international routes were cancelled on Wednesday, Bali's international airport general manager Ahmad Syaugi Shahab said in a statement after Mount Lewotobi

Laki-Laki spewed a 9km tower of ash. The volcano has erupted more than a dozen times over the last two weeks, killing at least nine people and forcing the evacuation of thousands.

Qantas and Jetstar were resuming their services to Bali, Australia's Qantas Group said.

Two delayed Qantas flights from esterday were among those set to

"We will continue to monitor the changing conditions and volcanic activity," it said in the statement.

AirAsia planned to resume some flights to and from Bali yesterday, the company said, while Virgin Australia said it would resume flights to and

from Denpasar starting today. Singapore's Scoot airline said it had rescheduled flights from Singapore to Bali and Surabaya as well as their return flights due to Lewotobi Laki-Laki's volcanic activity.

New Zealand parliament debates contentious rights Bill

SYDNEY: New Zealand's parliament yesterday began a heated debate on a contentious Bill aimed reinterpreting the country's founding agreement as hundreds of protesters continued their march towards the country's capital.

The ACT New Zealand party, a junior partner in the country's centreright coalition government, last week unveiled the Bill which aims to define the principles of the Treaty of

First signed in 1840 between the British Crown and more than 500 Maori chiefs, it lavs down how the two parties agreed to govern. The interpretation of clauses in the document still guides legislation and policy today.

The proposed Bill passed its first reading yesterday and will now be sent to a select committee.
Associate Justice Minister David

Seymour said the Maori are being given different rights than non-

indigenous citizens, who lose out because of policies specifically designed for the uplift of Maori. Seymour said people who oppose the Bill want to "stir up" fear and

division.

"My mission is to empower every person," he said. The legislation, however, is seen by

many Maori and their supporters as undermining the rights of the Maori, who make up around 20% of the population of 5.3 million. Hundreds have set out on a nine-day march, or *hikoi*, from New Zealand's north to the national capital of Wellington in protest over the legislation, staging rallies in towns and cities as they move south.

Introduced by Seymour's ACT New Zealand party, which won 8.6% of the vote in last year's election, the Bill is expected to fail.

Coalition partners the National

Party and New Zealand First, are only supporting the legislation through

the first of three readings as part of the coalition agreement. Both parties have said they will not support it to become legislation.

Prime Minister Christopher Luxon

said his government's top focus will be on the economy and improving

law and order.
"You do not go negate, with a single stroke of a pen, 184 years of debate and discussion, with a Bill that I think is very simplistic," he said.

World's largest coral found near Solomon Islands

Standalone structure is longer than a blue whale

SYDNEY: Scientists say they have found the world's largest coral near the Pacific's Solomon Islands, announcing yesterday a major discovery "pulsing with life and colour". The coral is so immense that researchers

sailing the crystal waters of the Solomon archipelago initially thought they had stumbled across a hulking shipwreck.

"Just when we think there is nothing left to discover on planet earth, we find a massive coral made of nearly one billion little polyps, pulsing with life and colour," said marine ecologist Enric Sala.

The standalone structure had been growing for some 300 years, the researchers said, formed from a "complex network" of tiny coral polyps.

It was distinct from a coral reef, which is

made from many distinct coral colonies, they explained.

Measuring 34m wide and 32m long, the team said the "mega coral" was three times bigger than the previous record holder - a coral dubbed "Big Momma" in American

"While Big Momma looked like a huge scoop of ice cream plopped down on the reef, this newly discovered coral is as if the ice cream started to melt, spreading forever along the seafloor," said lead scientist Molly Timmers.

It was longer than a blue whale and was thought to be "so colossal" that it could "be seen from space".

The coral was discovered at the

southeastern tip of the Solomon Islands in an area known as the Three Sisters.



life and colour.

It was spotted by a National Geographic team embarking on a scientific expedition in the region.

Hotter and more acidic oceans have drained the life from corals in many of the region's tropical waters, including Australia's famed Great Barrier Reef.

But this latest discovery offered a small glimmer of hope, the research team said.

"While the nearby shallow reefs were degraded due to warmer seas, witnessing this large healthy coral oasis in slightly deeper waters is a beacon of hope," said coral scientist Eric Brown.

The lush rainforests and pristine waters of Solomon Islands have long been celebrated for their ecological diversity.

Wildlife observations made in Solomon Islands in the 1920s helped prove a key part of Charles Darwin's theory of evolution.

"There is so much to learn about the

richness of marine life and the ocean ecosystem, but this finding opens doors of knowledge," said top Solomon Islands official Collin Beck.

"More scientific research is needed to better understand our rich biodiversity and our planet."- AFP

Man on trial over 'pink cocaine' import

SYDNEY: A man has been charged after allegedly attempting to import 252kg of a

anegeury attempting to import 252kg of a dangerous illicit drug cocktail into Australia. Federal Police said the seized substance, known as "pink cocaine" or "tusi", is a mix of ketamine, MDMA, and other adulterants, and typically contains little to no cocaine.

Police launched an investigation last month following the discovery of the drug in an air cargo consignment, which was labelled as containing an industrial saw and destined for a western Sydney suburb.

The 21-year-old man was arrested early this

month.

The man has been charged with attempting

to possess a commercial quantity of unlawfully imported border-controlled drugs, police said, a crime carrying a maximum penalty of life imprisonment.

He appeared in court last week, where bail was formally refused. His next court appearance is scheduled for January.

Acting Superintendent Stuart Millen expressed concern over the size of the seizure, warning of the significant risks to users.

"Pink cocaine is made up of an unpredictable

cocktail of illicit drugs, meaning anyone who consumes the drug has no idea what they are putting in their body. It rarely contains cocaine," Millen said.

"The dangers of all illicit drug consumption can be severe, including loss of consciousness, stroke, heart attack and even death." – Bernama

JAPAN KEEPS DEATH PENALTY **FOR HEINOUS CRIMES**

TOKYO: The Japanese government does not plan to open a discussion on abolishing the death penalty. Chief Cabinet Secretary Yoshimasa Hayashi said: "The majority of the public believes that the death penalty is inevitable for extremely heinous crimes. Murder of many people, murder for robbery – these heinous crimes are still not a thing of the past, the death penalty is inevitable for those who have committed such vicious offences. The government does not consider it appropriate to abolish the death penalty at this time and will not open a debate on it." In Japanese judicial practice, the death penalty is usually applied in cases of multiple murders, and there are about 10 such sentences each year. - Bernama

TEL AVIV: Israel suffered one of the deadliest days of its ground offensive against Hezbollah in Lebanon on Wednesday when six of its soldiers were killed in combat near the

The soldiers "fell during combat in southern Lebanon", the army said in a statement. Their deaths mean 47 Israeli troops have been killed in combat with Hezbollah since Sept 30, when Israel sent ground forces into Lebanon.

The army's announcement came after new Israeli Defence Minister Israel Katz said there would be no easing up in the war against Hezbollah. Israeli Prime Minister Benjamin

Netanyahu shared on X an image of the "Golani" Brigade symbol - the unit the soldiers killed belonged to -a green olive tree against a yellow background, with a broken heart

Israeli forces launched airstrikes on Beirut for a third consecutive day yesterday, hitting locations in the capital's southern suburbs early in the morning after a night of heavy bombardments.

Plumes of smoke rose over Beirut as the strikes continued, while raids also reached southern Lebanon's Bint Jbeil, where overnight airstrikes and artillery shelling inflicted heavy damage on buildings and residential complexes, according to Lebanon's

National News Agency (NNA).

Five people were killed in airstrikes on the towns of Bazourieh and Jumayjimah, NNA reported.

'Evacuation orders amount to war crime'

TEL AVIV: Human Rights Watch said in a report released vesterday that Israel's repeated evacuation orders in Gaza amount to the "war crime of forcible transfer", and to "ethnic cleansing" in parts of the territory.

"Human Rights Watch has

"Human Rights Watch amassed evidence that I officials are ... committing the war crime of forcible transfer," the report

"Israel's actions appear to also meet the definition of ethnic cleansing" in the areas where Palestinians will not be able to return, HRW said.

return, HRW said.
Nadia Hardman, an HRW
researcher, noted the 172-page
report's findings are based on
interviews with displaced Gazans,
satellite imagery and public
reporting conducted until August.

Although Israel says the displacement is justified for civilians' safety or by military imperatives, Hardman said that "Israel cannot simply rely on the presence of armed groups to justify the displacement of civilians".

"Israel would have to demonstrate in every instance that displacement of civilians was the only option", to fully comply with international humanitarian law.

According to the United Nations, 1.9 million Palestinians were displaced in Gaza as of last month. Before the start of the war on Oct 7 last year, the official population figure for the territory was 2.4

million inhabitants.
"Systematically rendering large parts of Gaza uninhabitable ... in some cases permanently ... amounts to ethnic cleansing," said Ahmed Benchemsi, spokesman for HRW's Middle East division.

The HRW report pointed in particular to the Philadelphi and . Netzarim corridors, running along

the Egyptian border and cutting Gaza along its east-west axis respectively, which have been "razed, extended, and cleared", by Israel's army to create buffer zones and security corridors.

Benjamin Prime Minister Netanyahu has repeatedly insisted that Israeli forces must retain long-term control over the Philadelphi Corridor.

Hardman said Israeli forces have turned the central Netzarim corridor, between Gaza City and Wadi Gaza, into a buffer zone 4km wide mostly cleared of buildings.

The report excludes developments in the war since August, particularly an intense Israeli offensive in northern Gaza since early last month.

The operation has forced the displacement of at least 100,000 people from the Palestinian territory's far north to Gaza City and

areas, said UN refugee surrounding Palestinian spokeswoman Louise Wateridge. Ragheb al-Rubaiya, a 63-year-old

Palestinian from north Gaza's Jabalia Camp, said that he had been driven from his home after "bombing started from the air and the tanks,

and they drove us out".

"They're destroying everything in Jabalia, and the goal is clear even to the blind: to wipe out the north and cut it off from Gaza," Ragheb said.

French minister to shun COP29

PARIS: France's Environment Minister Agnes Pannier-Runacher said she will stay away from the COP29 climate change conference in Baku after "unacceptable" attacks by Azerbaijan's president Ilham Alivey.

Ilham had accused France of
"crimes" and "human rights
violations" in overseas territories
including New Caledonia in the south Pacific, where 13 people have been killed this year in protests that broke out in May over a contested voting reform.

"Ilham's words against France and Europe as the COP29 opened in Baku are unacceptable," Pannier-Runacher told the French Senate.

Ilham on Wednesday accused

France of holding Mediterranean island Corsica and Paris's far-flung overseas island territories "under the colonial yoke".

Azerbaijan has played host to a Azerbaijan has played nost to a group of pro-independence movements from French overseas territories in an apparent bid to needle Paris, which has long supported Baku's arch-rival Armenia.

Ilham had on Tuesday called oil and gas "a gift of the God" in his COP opening address.

Pannier-Runacher hoped to spotlight a "positive dynamic" at the conference in petrostate Azerbaijan, where Brazil and Britain announced new emissions targets.
"France's negotiating teams will

spare no effort to protect the planet and our populations," she said.

"We will argue for the implementation of the Paris Accord." – AFP

TAJIKISTAN LOST 1,000 GLACIERS

DUSHNABE: More than 1,000 glaciers have disappeared in Tajikistan over the last three decades. The thousands of glaciers across mountainous glaciers across mountainous Central Asia are crucial to the region's food and water security, typically draining fresh water into rivers to replenish them. Energy and Water Resources Minister Daler Juma Resources Minister Daler Juma said: "Over the past 30 years, out of 14,000 glaciers in Tajikistan, more than 1,000 glaciers of vital importance to the region have disappeared. The rapid melting of glaciers is a serious threat in the global context of protecting water resources." UN scientists say glaciers could disappear from Central Asia by the end of the century. – AFP

IRAN READY TO TALK TO NUCLEAR AGENCY

DUBAI: Iran is willing to resolve disputes with the UN nuclear agency over its compliance with safeguards but will not do so under pressure, its foreign minister said after meeting the International Atomic Energy Agency head yesterday. European powers are pushing European powers are pushing for a new resolution against Iran by the agency next week to pressure Tehran over what they view as its poor cooperation. Foreign Minister Abbas Araqchi said: "The ball is in the EU court. We are willing to negotiate based on our national interest and inalienable rights." – Reuters

Q: Our two daughters, ages 13 and seven, argue and bicker constantly. We have talked to them many times about the importance of being kind, loving and forgiving, and they always promise to do better but nothing seems to change. How can we help them overcome this sibling rivalry?

Focus on the Family Malaysia: Most families deal with sibling conflict at some point and usually at the most inconvenient times. Resolving this rivalry takes consistency, patience and time. Keep these three things in

- patience and time. Reep these times timing as you work through it:

 Stay calm: Dealing with bickering children can feel like "ninja-level" parenting. Take a deep breath and remind yourself that you are teaching them essential skills for handling relationships and resolving conflicts - skills they will need throughout life. It is important to take time to understand each daughter's perspective, keeping in mind their ages and personalities
- Listen and teach: Listen carefully to your children, help them identify the real issue, and involve them in finding solutions and setting consequences. For example, you could set up a system where, after five minutes of arguing, they can hire a parent for RM1 per minute to help them resolve the conflict.

Encourage them to take turns listening, practise empathy ("What is it like to be with me?"), and ask themselves, "What do I really

Strategies for managing sibling conflict

self-reflect and consider the other person's perspective. It will not always be perfect, but developing these skills takes time, and it will be a challenge for everyone.

Provide consistent limits: If the children are

being rude, mean or physical, it is important to intervene with consequences.

For example, we have heard of families where the child acting as a bully has to clean the toilets, symbolising that the issue needs to be "flushed out" of the home.

There are many other options for consequences as well, such as time-outs or losing privileges or toys - though these should come with the opportunity to earn them back.

Q: My wife and I don't argue frequently, but when we do, things tend to escalate quickly. I think we are both to blame - one of us says something snarky, and the other responds with something angrier or louder, which just makes it worse. How can we prevent this from escalating and handle conflicts more calmly?

Focus on the Family Malaysia: Most couples have experienced this – escalating a disagreement without meaning to. A relationship expert I once heard called it "climbing the crazy ladder".

The idea is that fighting as a couple is like climbing an emotional ladder. It is easy to go up quickly, but coming down is much harder. Once an argument heats up, it becomes much more difficult to calm things down.

Additionally, the higher you go, the more unstable things become. When a disagreement escalates, it only makes it harder to resolve the issue constructively.

Couples are encouraged to avoid climbing the ladder for the sake of their marriage and, if they have children, for their well-being. Research shows that children exposed to chronic, poorly handled conflict can suffer lifelong emotional consequences.

The best advice is to avoid climbing the crazy ladder in the first place. Instead, focus on staying calm, discussing differences rationally, and finding solutions that strengthen your

relationship rather than weaken it.

A good first step will be to simply acknowledge it: "Honey, we are climbing the crazy ladder again."

Place health at the core of climate change policy

AS leaders gather for the 29th Climate Conference (COP29) in Azerbaijan, they must face the reality that the climate crisis is also a health crisis for millions of the most vulnerable people on our increasingly warmer planet.

To respond effectively, it is crucial to place

health at the centre of discussions, policies and funding decisions while also drawing lessons from insights in Southeast Asia.

My colleagues at Medecins Sans Frontieres/Doctors Without Borders (MSF) work in some of the most climate-vulnerable regions, serving populations who already lack access to basic healthcare or are deliberately excluded from it.

The climate crisis is hitting them the hardest. We see this firsthand, with more and more people seeking care in our clinics. We can see how failures in climate action are creating ripple effects that are worsening healthcare outcomes in humanitarian settings. Adamo Armando Palame, an MSF health

promotion supervisor in Mozambique explains it this way: "Those who wonder what climate change looks like should come to Mozambique. We are bearing the brunt of actions by the world's most polluting countries. We now have malaria all year round and we are struck by cyclone after cyclone."

Climate change increases the risk of illnesses for vulnerable populations, both directly – through harm from extreme weather events or the spread of vector-borne, waterborne and human-to-human communicable diseases – and indirectly, by eroding social and economic coping mechanisms such as livelihoods, healthcare systems and access to water and

Communities most at risk often have the least capacity to adapt to the complex and compounding impacts of climate change while humanitarian responses to their growing needs become increasingly challenging.

In South Sudan, an MSF team observed how unpredictable seasonal patterns and rains forced a usually sedentary community into semi-nomadism for survival, complicating the roll-out of a three round multiantigen vaccination campaign.

Most of the 25 countries most vulnerable to climate change and least equipped to adapt are also affected by armed conflict.

Recent analysis by the Peace Research Institute Oslo shows that state-based armed conflict is at its highest level in 30 years. With ongoing wars in Burkina Faso, Ethiopia, Gaza, Myanmar, Nigeria, Russia and Ukraine, Somalia, Sudan and Syria, this portends more suffering.
Conflict instability and the politicisation of

healthcare are compounding factors for communities already at risk from climate-driven disasters, as they struggle with inadequate infrastructure and limited preparedness and response capacity.

In 2023, Cyclone Mocha - the largest to hit Myanmar in a decade - made landfall in Rakhine state, where many people have been internally displaced by ongoing conflict and are living in temporary shelters.

Before the cyclone hit, thousands of people were already grappling with severe seasonal water shortages. Skin diseases, caused by lack of clean water for washing, accounted for 20% of our patient consultations during the dry season.

The cyclone damaged essential infrastructure, and the contamination of the already limited water supply quickly followed.

My MSF colleagues prioritised preventing waterborne diseases, distributing drinking water to 9,000 people per week and damaged latrines and water systems. and repairing

We also resumed our pre-disaster activities, including mobile primary health clinics and emergency medical referrals. But the response was only a fraction of what was needed and what could have been done. Why?

Weeks after the cyclone, travel authorisations were still blocked and when they were

were still blocked, and when they were eventually granted, they were limited to activities pre-approved by military authorities.

The military then demanded that aid groups nd over relief supplies for their own distribution, violating the principles of impartiality and neutrality in humanitarian assistance.

assistance.

In the past two years alone, my colleagues have responded to widespread flooding in Africa's Sahel region and parts of Asia, severe tropical cyclones in Madagascar and Mozambique, and relentless heat and drought that have pushed millions to the brink of starvation in Somalia and Ethiopia

During the same period, we also responded to concurrent cholera outbreaks in more than 10 countries where poor access to clean water, inadequate sanitation and weak healthcare infrastructure were exacerbated by rising temperatures and intensifying cycles of floods

According to the World Health Organisation (WHO), 35 countries experienced cholera outbreaks in 2023 –13% more than in 2022.

A deadly combination of malaria and malnutrition has kept our pediatric wards full across the Sahel region. In Chad, our teams now provide year-round prevention and treatment for malnutrition, instead of only during the seasonal peaks as we did before.

From Niger to Mozambique, and from

Honduras to Bangladesh, we are treating more patients for malaria and dengue as the vectors of these diseases – mosquitoes – adapt to new environmental conditions and migrate to previously unaffected areas due to climate change. This exposes more people to infection for longer periods.

Dengue is the most common and particularly concerning. Today, over 3.9 billion people are estimated to be at risk, with that number likely to increase by another billion by 2050, according to

Dengue is already endemic in Southeast Asia, and MSF has successfully replicated some of the innovative vector-control methods trialled in Indonesia, Malaysia, Thailand and Vietnam in other regions.

In Honduras, where more than 10,000 cases of dengue are reported annually, the transmission potential has increased significantly, and MSF teams have responded to transmission seven outbreaks in the past 14 years.

Traditional chemical vector-control methods are less effective now; mosquitoes have become resistant to them.

Last year, MSF and the Honduran Health Ministry launched new vector-control studies, including a pilot of the Wolbachia method, similar to those conducted in Singapore and Southeast Asia. The mosquito population in a district of Tegucigalpa is being replaced with mosquitoes inoculated with the Wolbachia bacteria that blocks dengue viruses from replicating and helps reduce transmission.

Previous studies in other endemic areas have shown that Wolbachia can reduce dengue transmission by up to 95%. The method appe to be environmentally safe, self-sustaining and cost-effective.

I hope that trialling practical solutions in

Southeast Asia, in ways that humanitarian groups like MSF can replicate elsewhere, becomes a hallmark of the future humanitarian landscape. This region has the potential to offer solutions for areas where institutions are often weaker or less reliable. Such efforts would be a powerful expression of solidarity through

Other steps should include producing and sharing knowledge to fill gaps. An MSF review of the latest assessment reports by the authoritative Intergovernmental Panel on Climate Change highlighted that meningitis, snakebite, leishmaniasis, measles, Ebola and human African trypanosomiasis – all climatesensitive diseases and humanitarian health problems – were under-reported or absent in the latest edition.

While health does not feature prominently in international decision-making processes, it urgently needs to be at the centre of all multilateral climate negotiations, policies, commitments and action. This means bringing health organisations and stakeholders to the negotiating table. Southeast Asia can also play a significant role.

Finally, coherence on planning for and responding to climate health emergencies is essential since efforts still often remain siloed. with little coordination and coherence across sectors - perhaps most of all, in terms of

A key focus of COP29 will fall on finance, and we already see some countries choosing to cut humanitarian funding and divert that money to climate programming. This should not be.
Coherent climate action must fill gaps

and enhance humanitarian and development assistance, not be set up to compete with it.



M'sia set to become SE Asia's packaging for manufacturing hub: Reed Exhibitions

KUALA LUMPUR: Malaysia is expected to become Southeast Ásia's packaging for manufacturing hub within 10 years said Reed Exhibitions (RX) China chief operating officer Josephine Lee.

PUTRAJAYA: The government is staying committed to national environmental, social, and governance (ESG) development despite concerns that the newly elected Trump administration in the US may dismantle ESG regulations.

Natural Resources and Environmental Sustainability Minister Nik Nazmi Nik Ahmad said "climate change is real, no matter who the American president is".

"We recognise Malaysia is already witnessing the impact of climate change. Today, we have villages on the East Coast being swallowed by the sea. We're seeing seawater in the drains in Klang. So it's real, it's out there, no matter who the American president is," Nik Nazmi said in his keynote speech at the launch of IOI Properties Group's IOI Sustain Roadmap 2030 and the official unveiling of Malaysia's

largest mall solar photovoltaic system at IOI City Mall yesterday. He added: "We know that climate change presents a wide range of effects on the environment and society, impacting businesses as well."

Nik Nazmi said the National Climate Change Bill is expected to be tabled in Parliament by the first quarter of 2025.

"For Malaysia to thrive and maintain climate resilience, gover-nance plays a crucial role." Currently, he said, the Natural Resources and Environmental Sustainability Ministry is conducting stakeholder engagement sessions as well as producing consultation papers for public comment until Nov 18. "You can go to our website

and see the draft of the papers so that we can get your views from the private sector, from the public." Nik Nazmi said the government

views nature-based solutions as an important aspect in addressing climate change

"Our commitment to naturebased solutions has led us to protect and restore our forests, wetlands, and coastal ecosystems, which serve as natural buffers against climate impacts," he said.

Nik Nazmi pointed out that Malaysia is home to some of the world's oldest rainforests, and Malaysia is determined to preserve them as crucial carbon sinks and biodiversity hotspots. "These ecosystems play an indispensable in maintaining the delicate

balance of our climate and are a cornerstone of our resilience strategy," he said. Nik Nazmi said that during a

town hall session in July, more than 30 local universities and research institutions expressed strong support for the establishment of a biodiversity centre and natural history museum.

"We have submitted a plan of the development budget through the Ministry of Economy to construct a biodiversity centre and natural history museum costing from the government side ... RM140 million."

He added "But that, I think, is a very bare basic. And that is why we have to get the private-public partnership to get more funding and receive commitments from many big companies so that we can really have a state-of-the-art biodiversity centre, which is, I would say, in line with what we can showcase to the world with the collections that we have."

Nik Nazmi said that almost every megadiverse country has centres of excellence for biodiversity manage-ment. However, Malaysia is one of the few countries without a national biodiversity centre. "Although Sabah, Sarawak and Pahang established state-level biodiversity centres earlier, there is an undeniable need for a nationallevel centre to complement the state efforts."

Nik Nazmi said it will have several core functions, including the management of scientific collections and biodiversity data-bases, the coordination of scientific research for the science and policy interface, the establishment of centres for advanced training in biodiversity, the organisation of exhibitions and outreach pro-grammes, the provision of advisory and consulting services, and as a major visitor attraction.

whereby the 4,005 kWp (4 MWp) solar photovoltaic (PV) system is expected to generate 19,279 gigajoules of energy with an expected carbon emissions reduction of 4,059.34 total carbon dioxide content (tCO2)

Tera is one of IPG's partners in its journey of sustainability, particularly in renewable energy investment and

emissions reduction. In January, IPG appointed Tera to house, install and maintain a solar PV system to supply renewable energy for IOI City Mall's day-to-day operations. The installation of the panels began in January and was completed in March.

IPG chief operating officer (property investment) Chris Chong said the newly energised solar PV system complements the mall's existing 3.5 MWp system with 3,358 tCO2 emissions avoidance per year.

Tera managing director Michael Leong said the energising process followed feed-in tariff approval from the Sustainable Energy Development Authority Malaysia for the solar PV panels, which cover 188,674 square

feet on the mall's rooftop.

"This extensive rooftop installation required our engineering expertise to deploy optimised solutions that deliver high yield and sustained reliability, ultimately reducing the total cost of ownership," he added.

IPG group chief operating officer (property development) Teh Chin Guan said the company is dedicated to designing sustainable homes and commercial buildings that prioritise green features and minimise environmental impact.

'We are investing in solar energy generation for properties within our portfolio, including sales galleria, retail malls, office towers and landed residential products. These invest-ments contribute significantly to overall emission reductions towards our low carbon objectives,.'

Besides IOI City Mall, installation of

a 250.4 kWp solar PV system at IPG's Palm Garden Golf Club in Putrajaya has been completed, while a larger 2,336 kWp system at IOI Mall Puchong is nearly finished, expected to reduce emissions by 2,367.4 tCO2 annually.

Altogether, Tera's solutions will enable IPG to avoid 6,680.01 tCO2

emissions per year.

IPG is also working on installing a

solar PV system at IOI City Mall II. With the completion of solar panel installations at IOI City Mall Phase II and Palm Garden Golf Club, IPG's total installed solar capacity is set to reach 9,048.9 kWp by year-end, projected to offset 9,170.53 tCO2 in emissions annually. - by HAYATUN RAZAK

MISC third-quarter earnings ease but nine-month bottom line rises

KUALA LUMPUR: MISC Bhd's net profit eased to RM338.9 million in the third quarter ended Sept 30, 2024 (Q3'24) from RM430.4 million Q3'3.

Revenue was 11% lower at RM2.96 billion, compared with RM3.37 billion previously, due to lower revenue recognition from the conversion of a floating, production, storage and offloading unit (FPSO) in the offshore business segment as well as lower freight rates and earning days in the petroleum and product shipping segment in the current quarter.

In a filing with Bursa Malaysia, MISC attributed the lower revenue from its offshore business segment to the lower project progress during the quarter.

"The segment recorded an operating loss of RM33.2 million compared to an operating profit of RM58.1 million in 3Q 2023 due to lower construction profit following lower project progress as well as an increase in construction costs of the FPSO," it said.

Meanwhile, the company said the revenue for the petroleum and product shipping segment dropped due to currency translational loss from the strengthening of the ringgit against the US dollar in the current

Nonetheless, for the nine months ended Sept 30, 2024 (9M'24), MISC registered a higher net profit of RM1.64 billion versus RM1.5 billion in 9M'23.

However, its revenue decreased to RM9.93 billion compared to RM9.99 billion in 9M'23 due to lower profit in the offshore business

from lower construction profit.

"The gas assets and solutions segment also recorded lower profit from lower earning days and charter rates, coupled with higher vessel operating costs," it said.

MISC declared a third interim dividend of eight sen per share for the financial year ending Dec 31, 2024, with the entitlement date set for Nov 28, and payable on Dec 17.

On prospects, the company said the petroleum and product shipping segment's

operating income is projected to remain steady, underpinned by its fleet of long-term chartered vessels and the potential to capitalise on opportunities in the spot trading market.

The medium-term outlook for the offshore business segment remains positive, supported by stable oil prices, with projects in South America, West Africa and the Asia-Pacific regions driving demand for newbuild FPSO units," it said.

Moving forward, its offshore business segment wi opportunities segment will actively pursue new opportunities in the market while maintaining a strong focus on the timely and efficient completion of existing projects to mitigate potential cost overruns, MISC added.

L & P Global posts nine-month net profit of RM9 million

JAYA: Integrated industrial packaging solutions provider L&P Global Bhd reported revenue of RM104.4 million for the reported revenue of RMI104.4 million for the nine months ended Sept 30, 2024 (9M'24), compared to RM123.1 million in the corresponding period last year (9'23), primarily due to reduced demand for pallets and boxes and crates from customers in the renewable energy sector

Net profit for 9M'24 stood at RM9 million compared to RM15.7 million in 9M'23. The decline reflects the decrease in revenue, which offset the cost advantages and operational efficiencies previously achieved the economies of scale. Additionally, through

MAA projects 2024 vehicle sales to reach 800,000 units

KUALA LUMPUR: The Malaysian Automotive Association (MAA) has projected Malaysia's 2024 total industry volume (TIV) for motor vehicle sales at 800,000 units, an increase of 35,000 units or 4.57% from the previous estimate of 765,000 units.

MAA president Mohd Shamsor Mohd Zain said that the positive outlook for the coming months is driven by ongoing promotions from car manufacturers.

"Achieving the initial 765,000 target should not be an issue. In fact, I anticipate a figure slightly higher, reaching 800,000 units. The initial forecast of 765,000 units was made around May or July when we expected a dip in momentum.

"However, we did not fully

account for backorders, especially for certain models, primarily from national car manufacturers," he said at a press conference during the media launch of the Kuala Lumpur International Mobility Show 2024 (KLIMS 2024) yesterday.

Mohd Shamsor said that the

2025 TIV has not been discussed. "We have yet to discuss it with our members. As usual, an official announcement will be made in January 2025," he added.

Credit growth of Malaysian banks to improve to 6% in 2025: S&P Global

KUALA LUMPUR: The credit growth of banks in Malaysia is projected to improve to 6% in 2025, benefiting from higher economic growth and an increase in corporate demand led by key infrastructure projects, according to S&P Global.

to S&P Global.

In its Global Banks Country-By-Country Outlook 2025: Cautiously Confident report, S&P Global said the industry's non-performing loan ratio could rise by 20-25 basis points (bps) by end-2025 from 1.6% as of end-June

"This could come from restructured loans, especially to low-income households and small to midsize enterprises. Any further rollbacks in fuel subsidies would have a further impact on these two vulnerable

groups.
"The level of restructured loans has 2% at end-June 2024," the report said.

S&P Global said that the credit costs should stay at 15-20 bps, similar to the pre-pandemic average, given

adequate provisioning.
It said net interest margins could decline by three to five bps due to intense competition for both loans and deposits.

'Over the next two years, we forecast return on assets to stay at 1.2-

1.3%.
"Upside potential to profitability could come from lower credit costs if large banks choose to write back pandemic-related provisions," it noted. Moving forward, S&P Global said

Malaysian banks' asset quality is closely correlated to employment levels, given a large share of household loans.


"High household leverage poses some risk. However, some risk. However, stable employment and adequate household financial assets are mitigating factors,"

Regarding the property sector, S&P Global said banks have material exposure to real estate development and construction at about 8% of total

It said oversupply in the commercial real estate market and elevated office vacancy rates remain structural challenges.

"Banks have been cautious lending

to the sector and have gradually reduced exposure," it said. – Bernama

SINGAPORE: Singapore Telecommunications posted a 6% rise in underlying net profit for the half-year and gave improved guidance for the full year, underpinned by strength at its Australia unit Optus and technology services business NCS.

Southeast Asia's largest telecoms provider also said it expects its earnings before interest and tax (EBIT) to grow at a low double-digit rate for fiscal year 2025, an improvement over earlier guidance which gave a wider range of high single-digit to low double-digit growth.

SingTel shares closed slightly lower at S\$3.18 yesterday.

Optus benefited from higher mobile service revenue, price increases and better cost management, while the NCS segment reported strong demand for its services, the

company said.

EBIT for Optus surged 58% for the half-year while the NCS segment's EBIT

"Optus is benefiting from Telstra's 4% to 5% (price) hike in July 2024.

NCS also benefits from growth in its Gov+ and Telco+ businesses, and cost-reduction efforts," said Sachin Mittal, global head of telecom, media and tech research at DBS

Telstra, one of Australia's top telecom firms, increased prices for postpaid mobile

plans in early July this year.

Near-term growth for Singtel will be driven by Optus and NCS, Mittal added.

SingTel's infrastructure unit, Digital InfraCo, "will start delivering growth in 18 to 24 months from ramp up of data-centre

capacity".


Demand for data centres has risen in recent years as firms adopt artificial intelligence to streamline operations.

"We will continue scaling NCS and building out Nxera's data centres, which will commence operations from mid-2025 to meet increasing demand."

SoftBank first to receive new Nvidia chips for supercomputer

receive the first chips using Nvidia's latest Blackwell design for its supercomputer, the California-based chip designer said, as Masayoshi Son looks to ride the artificial intelligence boom.

SoftBank Corp is also planning to use Grace Blackwell chips for a further supercomputer, said Nvidia, which held an Al event in Tokyo on Wednesday featuring SoftBank Group CEO

Son and Nvidia CEO Jensen Huang.
Son is pushing to expand his conglomerate's exposure to the Al wave, taking a stake in OpenAl and acquiring chip startup Graphcore, after a turbulent few years that forced the ebullient billionaire to retrench.

at the event, with Jensen recalling Son had once offered to lend him money to buy Nvidia as its value was not understood by the market.

"He wanted to lend me money to buy Nvidia. All of it. Now I regret not taking it,"

Huang said, laughing.
Son said the offer was made a month after he acquired chip designer Arm. The Japanese billionare later built and sold

down a stake in Nvidia and attempted the sale of Arm to Huang's company which foundered on regulatory hurdles.

Nvidia, once best known as a designer of graphic chips for gaming, has gone on to become the world's most valuable company

powered by insatiable demand for its chips. While Son has built a reputation as a far-sighted investor with relationships with leading entrepreneurs and bets on companies such as Alibaba, he has also made high profile slips such as backing office space sharing firm

With telcos around the world look for new growth drivers, SoftBank has partnered with Nvidia to pilot a network that can run both 5G and Al services.

"It's the same vision that we can smell, right? It's like a wolf smell wolf," Son said of the similarities between the two men.

"I have two puppies. I don't like that mental image," Huang joked in response. - Reuters

TSMC sued for alleged discrimination

WASHINGTON: More than a dozen US-based employees of Taiwanese chipmaking giant TSMC have sued the company for apparent discrimination against non-Asian workers, according to a recent lawsuit.

The suit alleges that the world's largest contract manufacturer of chips – used in everything from Apple iPhones to Nvidia's Al hardware – unfairly favours Asian staff in terms of hiring, firing and working standards.

Initially filed in August, the suit was refiled last week as a class action case with 13 plaintiffs

Taiwan Semiconductor Manufacturing Company declined to comment on the litigation but said in a statement yesterday that it "believes

strongly in the value of a diverse workforce."

The company is at the forefront of a generative Al revolution, churning out the world's most advanced microchips needed to

power products made by Silicon Valley. It has secured billions of dollars in US funding and has agreed to operate three factories in

The suit alleges that TSMC routinely subjects those who do not hail from Taiwan or China to a "hostile work environment where verbal abuse, gaslighting, isolation, and humiliation is common, and oftentimes leads to the constructive discharge of these employees". The 13 plaintiffs – whose backgrounds include the United States, Mexico, Nigeria, Europe and

Korea – were seeking damages to redress TSMC's apparent discrimination practices.

The lawsuit was first filed in August by TSMC

recruitment manager Deborah Howington, alleging bias towards Asians, and particularly Taiwanese citizens, in decisions on hiring and termination of employment.
It claims that non-Asian workers are "frequently

excluded from business discussions, as conversations are often conducted in Mandarin, and business documents are routinely written in Mandarin".

TSMC said in a statement that "we hire and promote without regard to gender, religion, race, nationality, or political affiliation because we respect differences, and believe that equal employment opportunities strengthen our competitiveness". – AFP

Tencent's gaming rebound drives Q3 revenue up 8%

BEIJING: Chinese technology giant Tencent Holdings posted a 8% rise in third-quarter revenue, extending momentum in its gaming business, while growth in its fintech segments softened amid China's economic headwinds.

Tencent reported revenue of 167.19 billion yuan (RM104 billion) for the quarter ended Sept 30, in line with the average analyst estimate of 167.8 billion yuan, according to LSEG data.

Domestic gaming revenue rose 14% to 37.3 billion yuan, extending the previous quarter's 9% growth and marking two straight quarters of expansion after earlier declines.

International gaming revenue increased 9% to 14.5 billion yuan.

The result was partly driven by *Dungeon & Fighter Mobile*, a marquee title launched in May, as well as the release of a new shooting game,

Delta Force, in September.

The company's fintech and cloud services reported modest growth of 2% to 53.1 billion yuan, with its payments business declining amid weak consumer spending in China.

Tencent's net income rose 47% to 53.23

billion yuan. Analysts had on average expected net income of 52.89 billion yuan. - Reuters

AMSTERDAM: Europe's largest tech firm, computer chip equipment maker ASML, said yesterday it expected sales growth to average 8% to 14% over the coming five years, as a boom in Al fuels strong demand for its most advanced tools.

The guidance, which analysts said was reassuring, came in a statement ahead of the company's investor day at Veldhoven in the Netherlands, when it will face questions on prospects for sales to China after Donald Trump was elected as US president.

elected as US president.

"We expect that our ability to scale EUV technology into the next decade ... positions ASML well to contribute to, and leverage the artificial intelligence opportunity," CEO Christophe Fouquet said in a statement, referring to the company's most advanced chip making equipment.

This would allow ASML to deliver

significant revenue and profitability growth, he added.

Allianz beats forecasts with 22% rise in profit

FRANKFURT: Germany's Allianz on Wednesday beat expectations with a 22% rise in third-quarter net profit, helped by lower claims from natural catastrophes, and it gave an improved outlook for 2024.

The property and casualty division was cited as a particular area of strength because claims from natural catastrophes were down from a year ago, even though such damages remained high, the company said.

Allianz reported net profit attributable to shareholders of €2.47 billion (RM11.75 billion) in the three months through September, compared with a profit of €2.02 billion a year earlier.

The figure surpassed a €2.37 billion consensus forecast.
Allianz said its 2024 operating

Allianz said its 2024 operating profit would now land in the upper half of its target range of between €13.8 billion and €15.8 billion.

"Natural catastrophes have tested Allianz's financial and operational resilience, tests which we have passed," CEO Oliver Baete said.

Assets that Allianz manages for third parties rose by €37 billion from the end of the second quarter to €1.84 trillion, helped by market gains and net inflows.

Reuters reported last month that Allianz was weighing options for its smaller asset management division, Allianz Global Investors

Those options include a merger or partial sale of the division. – Reuters

Workers stage walkout at US maker of 'Fallout' video game

SAN FRANCISCO: Hundreds of US workers at the video game giant behind Fallout staged a one-day strike on Wednesday over outsourcing and remote work policies, their labour union said.

"We are not afraid to do what's necessary to make sure that Microsoft meets us at the bargaining table over key issues like remote work options and outsourcing," ZeniMax Workers United said on X.

"Today, we are on strike."

The group, part of the Communication Workers of America (CWA), said hundreds of ZeniMax employees in Maryland and Texas were on strike through the work day to "tell Microsoft to stop dragging their feet" when it comes to worker demands about job security and improved conditions.

Concerns of strikers included requiring workers who had been working from home some or all of the time to return to offices, the union said.

Microsoft acquired ZeniMax Media for US\$7.5 billion (RM33 billion) in 2021, marking a major expansion for its Xbox division.

ZeniMax is the parent company of Bethesda Softworks, publisher of the Fallout and Elder Scrolls franchises. – AFP

Super Micro delays filing financial report as delisting looms

SAN FRANCISCO: Super Micro Computer said on Wednesday it would delay the filing of its financial report for the September quarter, as the Al server-maker seeks a new auditor amid a delisting threat following its failure to submit its annual report.

Super Micro's share price is down 55% since Ernst & Young resigned as auditor last month after earlier flagging concerns about the company's governance, transparency and internal control over financial reporting.

Earlier this month, the company said a special committee set up to probe the issues raised by Ernst & Young in late July had not found evidence of fraud.
Super Micro said on Wednesday it

Super Micro said on Wednesday it needs additional time to select and

engage a new auditor and for management to complete its assessment of internal controls over financial reporting as of June 30, 2024.

The Nasdaq on Sept 17 notified the company of non-compliance with listing rules and it had 60 days to file its annual report or submit a plan to regain compliance.

A partner for leading chipmakers such as Nvidia and AMD, Super Micro's shares jumped more than three-fold in 2023, making it one of the biggest beneficiaries of a rally in Al-linked stocks.

However, the shares have come under pressure this year on concerns over its accounting practices, while Hindenburg Research disclosed a short position in August, alleging "accounting manipulation". – Reuters



Crypto market capitalisation hits record US\$3.2 trillion

Bitcoin takes a breather after breaking US\$90,000

SINGAPORE: The value of the global cryptocurrency market has topped US\$3 trillion (RM13 trillion) as the election of Donald Trump as US president spurred bets that friendlier American regulation could usher in a new boom for all corners of the asset class.

The sum market value of cryptocurrencies

touched a high of US\$3.2 trillion early yesterday in Asia, according to analytics and

data aggregator CoinGecko.

That puts it above the heady days of 2021, when pandemic-era stimulus pumped up speculative investments, and marks a stunning revival from just a few months ago when crypto prices and turnover had been flatlining.

Bitcoin dominates the market and the market value milestone coincided with the token's rise to a record US\$93,480.

"Generally the way this market goes is bitcoin will break out and then the rest of the altcoins will follow," said Matthew Dibb, chief investment officer at cryptocurrency asset manager Astronaut Capital

"So there is that gradual rotation of capital ... and then we can expect the total market cap to increase." Trump's election, and that of several pro-crypto lawmakers to Congress, has driven the wave of euphoria by apparently clearing some of the uncertainty around US regulations.

Bitcoin has doubled this year and is up 30% since the US election on Nov 5 to US\$90,000.

Smaller cryptocurrency ether is up about 33% since the vote to US\$3,220.

Dogecoin, an alternative and volatile token romoted by billionaire Trump-ally Elon

Musk, has gained 140%.
Crypto exchange-traded funds have also been heavily bought, market participants said, possibly an indicator of buying by financial institutions which tend to shy away from directly holding cryptocurrencies.
"Bitcoin enthusiasts are known for bold

predictions, but hitting US\$100,000 by year-end seems feasible," said Carl Szantyr, managing partner at Blockstone Capital.

The explosive rally is the latest in the boombust roller coaster that had bitcoin below

US\$20,000 at the start of last year, in the depths of the "crypto winter" that followed the collapse of brokerage FTX and other crypto projects

To be sure, cryptocurrencies' market value is dwarfed by traditional asset classes.

At current prices, the value of the 209,000 tonnes of gold the World Gold Council says has been mined in history is worth nearly US\$19

The market capitalisation of the S&P 500

index is US\$50.6 trillion.

Some parts of the ecosystem do also not show signs of recovery and others point to a degree of caution.

Average sales prices for non-fungible tokens have been around US\$2,000 since May, according to NonFungible.com, which tracks the Ethereum and Ronin blockchains, and

have kicked up, but only to about US\$2,700. In Singapore, DBS Bank, which operates a digital exchange, said while trading had surged and it had executed more than one-third of last year's total volume in the first ten days of November, investors were not yet heading into the more obscure parts of the market.

"We've not seen our clients shift their assets towards more exotic platforms or decentralised exchanges," said David Hui, chief commercial officer of DBS Digital Exchange.

Still, those in the industry say the renewed attention will bring momentum.

"There's increased interest and willingness to look at DeFi and other possibilities associated with blockchain," said Danny Chong, a co-founder of decentralised asset tracking platform Tranchess.

"The heightened market capitalisation, which if sustained for a longer period, would likely also invite deeper interest into new and existing themes," he said, including tokenisation of real world assets and blockchain-based payment services. - Reuters



Bank of France head urges united EU front

PARIS: Bank of France governor Francois Villeroy de Galhau on Wednesday urged European states to work together following the impending return of Donald Trump to the US

presidency or face economic isolation. "Europe must wake up," de Galhau told

France Inter radio station.
"That was true before the election of Donald Trump - but it is all the more so today" now that the former president, who has promised to hit all imports to the US with at least 10% tariffs, is set to return to the White House in January.

"If I had to sum up the European route map, I would say first off that Europe must get back

"And let's stop castigating ourselves in the process.
"We have assets in Europe. Europe must also

unite and beef up," he said, citing recommendations from a recent report by former Italian prime minister Mario Draghi to expand the single market, mobilise savings across the EU bloc and simplify a multiplicity of overly complex standards

If European nations do not work together, "in particular France and Germany, then we will remain on the sidelines of the global economic match", de Galhau warned.

Turning to the French economy, he found "the landscape neither bleak nor uniformly rosy", with "the economy confirming a certain resilience month after month".

De Galhau stressed "there is a great deal of uncertainty among entrepreneurs about the budgetary and fiscal debate in France, and now also the future American policy". – AFP

Guardian quits X, citing 'disturbing content'

LONDON: British news publisher The Guardian said on Wednesday it will no longer post to X, citing "disturbing content" on the social media platform, including racism and conspiracy theories.

The left-leaning *Guardian*, which has 10.7 million followers on X, becomes the first large UK media company to retreat from the platform that Elon Musk purchased in 2022.

Critics say Musk's hands-off approach has allowed lies and hate speech to spread on the platform formerly known as Twitter.

"We think that the benefits of being on X are now outweighed by the negatives and that resources could be better used promoting our journalism elsewhere," The Guardian said in an editorial published on its website.

"This is something we have been considering for a while given the often disturbing content promoted or found on the platform, including far-right conspiracy theories and racism.

In response, Musk posted on X and said of The Guardian: "They are irrelevant."

Musk, who supported Donald Trump ahead of his US election victory this month,

has said he is defending freedom of speech. Trump on Tuesday named Musk to a role aimed at creating a more efficient government.

The role of X and other platforms came under the spotlight in Britain this year when far-right and racist violence broke out after online posts falsely claimed that an attack in the northern English town of Southport. where three young girls were killed, was the work of a migrant.

Reuters was first to report last month that a British police force had quit posting on X, with several more reviewing their involvement.

In recent months, some British charities, health and educational establishments have

said they will no longer post to X.

The British government continues to post on X but does not use it for paid communications.

It does, however, advertise on Meta's Instagram and Facebook, a government source said last month. – Reuters

Nokia buys world's largest API hub to cash in on 5G

HELSINKI: Nokia said on Wednesday it had bought the world's largest application programming interface (API) hub and marketplace from US company Rapid as it seeks to boost revenues from its 5G and 4G networks.

Like other telecom gear makers, Finland's Nokia has been looking for ways to monetise its 5G equipment or diversify its market, as it hopes to attract investments linked to the rise of artificial intelligence.

Nokia said it will own the US tech start-up's technology and research and development unit under the deal, enabling its clients to integrate their networks, control their API usage and collaborate with the platform's developer base.

API are strings of code which enable standardised communication, exchange of data and functionality between software

Their use on advanced 5G networks provides faster, safer and more accurate access to data such as a users' location or connectivity status. - Reuters


"As investors remain cautious, capital flows continue to favour the US market, which is seen as a safe haven amid prevailing uncertainties in both domestic and regional markets," he told

Kelington posts higher profit for Q3 despite lower revenue

KUALA LUMPUR: Kelington Group Bhd posted a net profit of RM32.9 million for Q3 ended Sept 30, 2024, up by 3.94% from

RM31.66 million posted in the same quarter last year.
Revenue for the integrated engineering solutions provider declined 23.52% to RM307.31 million in Q3'24 from RM401.82 million posted in Q3'23.

The lower revenue is mainly due to key projects in Singapore and Malaysia nearing completion.

The Industrial Gases division maintained its strong performance in Q3'24, with revenue rising 30.9% YOY to RM39.4 million, driven by robust demand, reflecting sustained market strength. In Q3'24, the Ultra High Purity division continued to be the group's primary revenue driver, contributing 68% of total revenue.

The Industrial Gases division was the second-largest contributor, representing 12% of total revenue.


The General Contracting division accounted for 10%, while Process Engineering contributed 6%. Equipment and Materials

comprised the remaining 4% of total revenue for the period. In 9M'24, Kelington achieved a net profit of RM84.4 million on the back of revenue of RM967.8 million. This represents a YoY net profit growth of 26.1% compared to RM66.9 million in 9M'23. Kelington CEO Raymond Gan with a strong earnings

performance in the first nine months, the company is confident of achieving another record-breaking year in FY24, driven by the steady execution of existing orderbook across key markets and the continued momentum in its Industrial Gas business.

The group's balance sheet remains strong with a cash balance of RM359.7 million exceeding total debt of RM174.7 million results in a net cash of RM185 million as of Sept 30, 2024.

Energy intensity in FY23 (1.09 MWh/employee vs FY22: 1.33) was also markedly lower. Data collection for Scope 3 emissions is also underway in FY24. CTOS' "E" score has the potential to improve further once it starts

collecting waste management data/metrics. Notwithstanding CTOS' digital business model that allows it increased scope for a high level of female representation in its lean workforce, the proportion of women in its employ decreased YoY in FY23 at both senior mgmt level (4ppts) as well as a percentage of total workforce (-6ppts). Ringgit, emerging market currencies slide against dollar

THE ringgit, along with other emerging market currencies, continued to depreciate against the greenback yesterday as uncertainties over Trump 2.0 policies and their impact on the US Federal Reserve's (Fed) monetary policy looms large, an economist said.

At 6pm, the local note slid to 4.4840/4870 against the US dollar compared with Wednesday's close of 4.4450/4495.

Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid said the "bottom line is about the US interest rate decision, ie, whether the Fed will continue to cut rates in 2025, pause or even raise them."

"This will depend on whether US policies would be inflationary, which could warrant the Fed to remain open to tightening its grip on monetary stance. Hence, the US dollar looks increasingly constructive, leading to weaker emerging market currencies, including the ringgit," he told Bernama.

At the close, the ringgit traded mostly lower against a basket







HEN we think of car enthusiasts, we often think of those with a thirst for power, speed, grip and loud engines. But the reality is quite different than that, because car enthusiasts come in all shapes and forms.

Delve deeper into the topic and you will realise there are different types of enthusiasts.

Some like drag racing with thousand horsepower monsters.

Others like lightweight karts, and some like

winged cars creating unimaginable downforce, all in the pursuit of posting the fastest lap time. That is of course, oversimplifying it.

But there is one group of enthusiasts that this

writer met recently that opened my eyes to a whole new world of automotive passions - the 4X4 lovers, or sometimes known as the off-roaders, or "off-road kaki".

For context, this writer grew up loving 4X4's, those gigantic machines with large tyres that could dig themselves out of a trench, a winch dangling at the front and heavy metal bumpers that threaten to rip the radiators or taillights out of regular cars on the road.

In fact, I had a poster of one of the scenes

from Camel Trophy on my bedroom wall. Staring into that adventure poster as a boy and fantasising about the adventures that awaited in some far away land was how I escaped from the mundanity of school life.

Little did I know that I would have the chance to experience something similar years

I recently returned from the 2024 edition of the Borneo Safari, and it was one of the greatest adventures I have ever experienced.

Days spend pulling cars out of the mud and nights spent sleeping under the stars with the daily baths taken in the cool rivers reminded me of that very poster on my wall.

The Borneo Safari has been running for 32 consecutive years, and out of that, 16 have been officially sponsored by Isuzu Malaysia.

Taking place in and around the rainforest of

Sabah, Borneo Safari is considered to be one of the most difficult 4X4 races in the world. I was told that it is among the 40 most difficult races in the world. And after what I witnessed, I don't doubt that at all.

The 2024 edition of Borneo Safari attracted a The 2024 edition of Borneo Salari attracted a record breaking 620 registered vehicles with over 1900 participants. The participants are divided into two categories - the Competition Category and the Expedition Category is made up of teams that tackle challenges and special stages as quickly as possible. The fastest team with the processor of the control of the con

most accumulated points at the end of the eight-day competition is crowned champion.

Those that compete in this category do so in highly specialised offroad vehicles that share nothing in common with the road going cars they are based on.

They are powered by big capacity V8 diesel or petrol engines, feature long travel suspension and tyres that look like they were built for the surface of Mars

Their winches cost as much as a Perodua Alza and they even have all-wheel-steering, to make it easier to manoeuvre around obstacles. And as brutish as they may look, these cars typically cost between RM250,000 to RM400,000.

The Expedition Category on the other hand is also known as "Tag Ons". This category too requires highly modified offroad vehicles to tackle the challenges of the jungles of Sabah but they are mostly road-going cars with jacked up suspension, mud tyres and winches that can pull up to five tons. But unlike the competitors, they do not take part in the special stage and there is no winner in this category.

The tag ons are made up of people with a knack for adventure, and includes the media team as well, which includes us as well as journalists from other countries.

This group also includes individuals who pay to experience the Borneo Safari, which means that even you can participate in the Borneo Safari for a price just to experience the

vilderness of Sabah as well as the challenges of driving offroad.

I attended the 2024 of Borneo Safari as a guest of Isuzu Malaysia. As transport, my team and other guests were provided with the latest-generation Isuzu D-Max X-Terrain, which was modified for the specific purpose of surviving the Borneo Safari.

The modification list includes uprated suspension that also gave the car higher ground clearance, mud tyres, metal bumpers, side bars to protect the car from impact, a snorkel so that the engine can breathe if the car were to be submerged, and even some electronic upgrades as well.

The terrain was unforgiving, but I was told this year was relatively okay since it did not rain that much. But still there was more mud that you can possibly imagine, enough to stop a car dead in its track and leave it there if it wasn't for the rescue vehicles that tag along as well.

Before you think that the Isuzu D-Max X-Terrain was incapable of tackling the challenges because it needed a rescue team, let me just clarify that all cars had a rescue team. It is impossible for one car to manage everything alone and a rescue team is a must. Even for the competitors and their specialised cars.

specialised cars.

The Isuzu D-Max X-Terrain is already a very capable pick-up truck. With a virtually indestructible 3.0-litre, four-cylinder, turbocharged powertrain, the truck puts out 190PS and 450Nm of torque, transferred to the wheels through a six-speed automatic transmission. transmission.

While the powertrain is tried and tested, the latest-generation X-Terrain features a technology that seemingly no other pick-up truck has. Called the Rough Terrain Mode, this new system is designed to allow the car to pull itself out of a tough situation.

It works by sending power to individual wheels that have traction. That is the beauty of this system. While most 4X4 machines transfer power from the front or rear axle, the Rough Terrain Mode is unique since it is able to send power to a single wheel, and that is why the X-Terrain is so perfectly adapted to the great outdoors.

In total, I spent eight days in the jungle, completely disconnected from the world but yet

perfectly happy at the same time.

There was a chuck wagon that tagged along and acted as a moving cafeteria, providing three meals a day with multiple snacks and limitless coffee, tea and drinks. The food was beyond good.

There was also a Camping Team whose focus was to look for locations that were suitable to set up camp for about 50 people. They did a stellar job, the group slept on riverbanks and under the canopy of the trees.

Even when I thought there was no place for a

camp to be set up, they simply got their machetes out and levelled the ground for camp. Of course, that also meant our camp site was paradise for alien like critters such as a centipede as long as one's forearm.

Despite all the challenges, the Isuzu's clawed, powered and heaved their way out of everything in their path. The line-up included the new X-Terrain, the previous generation X-Terrain and even the single cab model.

And if there is anything that I learnt from this, it

is that the Isuzu powertrain remains as one of the most dependable in the business, even if there are





The Borneo Safari is an event that deserves more recognition than it has now. I particularly salute the fact that they have a team dedicated to ensuring that no rubbish is left behind, and that environmental impact is minimised.

The team even had to ask for permission

before setting up camp in some places, just to ensure that the trees and shrubs were not damaged.

The event does not only bring together like-

minded individuals from near and far, but is a testament to the resilience of the human spirit

when facing a seemingly impossible situation.

The drivers that were tasked with taking the group around were professionals with unique skills honed over years of surviving in the jungles, and that made my trip all the better as there was always a sense of being in control, even though it sometimes seems as if mother nature was

winning.
Borneo Safari is an international event that takes place every year around October and November, and judging from the sheer number of people that take part every year and Isuzu Malaysia's dedication to the event, it is set to keep growing.

"Today I really wanted to step on the court and just think about tennis, try to play a high level... When I played the first match I felt like I did not entertain the

McIlroy aims for glory

Irishman motivated to keep pace with Scheffler, Schauffele in Dubai



ORY MCILROY gave himself an eight out of 10 for the 2024 season that promised much but delivered only two titles, but on a Dubai course where he has always brought his A-game, things can get a lot better come Sunday.

Only one player in the field –
Thriston Lawrence – has enough
points to prevent the world No. 3 from
winning a sixth DP World Tour Order of Merit crown to match Spanish legend Seve Ballesteros and get closer to Colin Montgomerie's all-time record of eight.

However, the South African's only

chance is to win the title and hope that McIlroy finishes tied for 11th or worse.

McIlroy leads Lawrence by 1,785.02 points after finishing tied third last week in Abu Dhabi

The winner at the season-ending US\$10 million (RM45m) DP World Tour Championship receives 2,000 points and the runner-up gets 1,335

However, McIlroy rules the Greg Norman-designed Earth course with an iron fist.

He may have won only twice in 13 starts, but he is a combined 179-under-par in 13 starts (3.44-under-par each round), with two wins in 2012 and 2015 and seven other top-six finishes.

In the 56 rounds he has played on the course, he has shot only four over-par rounds.

Only one player has a better record than McIlroy on this course – Jon Rahm – and he is not in the field.

McIlroy said he was aiming to win the tournament for the third time and not to share the 18th green on Sunday with any other player.

Last year, he had already wrapped up the Order of Merit before Dubai and

outing, finishing tied for 22nd - his worst result in the tournament. Denmark's Nicolai Hojgaard won the biggest prize on the DP World Tour. "I think it's a nice time to reflect on

the year when you come here and you're on the cusp of doing something that, to me, is still pretty meaningful, and just thinking about the body of work you've put together over the last 10 or 11 months," said McIlroy, who won the Hero Dubai Desert Classic at Emirates Golf Club in January this

"When you get to the business end of things at the end of the year, you start to realise at least I've put together a year that I'm pretty proud of, even if it hasn't culminated in some of the things that I've wanted to achieve."

McIlroy has failed to add to the number of majors under his belt, which is why he said his season was just a pass.

He said he had been "incredibly consistent" but "thinking about the ones that got away. I could be sitting up here with a fifth major title and I am not. So that stings and that's something that I have to come to terms

"You've got two guys at the top of the World Rankings with Xander (Schauffele) winning two majors and Scottie (Scheffler) winning a Masters and a Players and the Olympics.

"They certainly separated themselves from the pack this year. I'm very aware of that, and it only makes me more motivated to try to emulate what they did this year."

Lawrence has his own score to settle with the course. He made three birdies in his final three holes on Sunday of last year's DP World Tour Championship, but that fell agonisingly short by one shot in his effort to secure one of the 10 PGA Tour cards on offer.

At least he won't have to worry about that as he is guaranteed to be in the top 10 regardless of his finish this

"If someone doubts that, it's about just looking at the past. Sporting (went) about 20 years without winning the league, and he got back to win the league, and he won it two times in four years with a really youthful team, in a moment of

Fans may have to be patient in waiting to see United take their rivals apart in such a manner but Fernandes backed Amorim to find a way to mould the team in his style.

"He's a really smart manager that has done really good things for Sporting tactically,

"But obviously as we always say, you can't bring or transform what he has done at Sporting into here, because you have different players, you have different ways of playing and everything.
"I'm pretty sure that the idea of football he has,

independent of the way he wants to play, is going to be a good one and it's going to bring us success.

Already eliminated Namibia had 15 goal attempts, but only one on target against Onana, who has conceded only once in five qualifiers.

Cameroon, who clinched a place at the 2025 finals in Morocco by defeating Kenya twice last month, have 11 points with a home fixture against Zimbabwe to come on Nov 19.

By holding Cameroon, Namibia secured their first point of a disappointing campaign

having reached the last 16 at an Afcon for the

naving reached the last 16 at an Aicon for the first time in the Ivory Coast this year.

Zimbabwe play Kenya on Saturday (12.01am Malaysian time) and a draw will ensure they finish at least second and accompany Cameroon to the 24-team

A victory for Kenya will take them within one point of Zimbabwe, and keep alive hopes of a first Afcon appearance since 2019.

Holders Ivory Coast and Equatorial Guinea became the latest countries to qualify for next year's Africa Cup of Nations finals but did not have to kick a ball to do so, as the penultimate round of qualifiers began yesterday

The Ivorians, winners at the last finals which they hosted at the start of the year, are certain of finishing in the top two places in Group G after Sierra Leone were held to a 1-1 draw by Chad in

The Ivorians sit on nine points from four matches, with Zambia second in the group on seven from four. Sierra Leone have five points with one game to play and Chad are eliminated.

Ivory Coast, Equatorial Guinea book Cup of Nations berths without playing

Chad moved the clash to the Ivory Coast because they are one of 18 countries barred from hosting international matches because of the poor state of their stadia.

They went a goal behind to Abu-Diaby Dumbuya's stunning 29th-minute effort but equalised with a Panenka-style penalty from

defender Mahamat Thiam five minutes later.

A 1-0 win for Liberia over Togo in Monrovia in Group E eliminated both countries and guaranteed Equatorial Guinea progress to the tournament in Morocco, which is to be played from Dec 21, 2025 to Jan 18, 2026. The top two sides in each of the 12 qualifying groups

Equatorial Guinea, who were a surprise package at the last finals, sit on seven points from their four matches, while Liberia who have four points from five games and Togo have

Even if Liberia finish with same points tally as Equatorial Guinea, they cannot overhaul them in the standings because of the head-tohead record between the two. Equatorial Guinea beat Liberia home and

Equatorial Guinea beat Liberia home and away last month, but yesterday substitute Mohammed Sangare, who came through the ranks at Newcastle United but now plays his club football in Switzerland, tucked away an 83rd-minute penalty to ensure Liberia's first win of the group.

PL clubs 'seeking compensation' if City found guilty

ARSENAL, Liverpool, Manchester United and Tottenham have reportedly lodged legal notices reserving the right to claim compensation if Manchester City found to have breached Premier League financial rules.

The Times said the notices had been lodged now over concerns that the clubs could be out of time to do so under the statute of limitations if they waited for an outcome in the

City were charged with 115 breaches of top-flight rules in February last year, charges which the club have always strenuously denied.

An independent commission hearing in the case began on Sept 16 at the International Dispute Resolution Centre in London.

The hearing was reported at the time to be scheduled for 10 weeks. No outcome is expected until the New Year.

The clubs are reported to have been advised that the sixyear statute of limitations could potentially date back to November 2018, when German magazine *Der Spiegel* first published allegations against City, prompting the Premier League to open investigation.

The Times said the clubs

could look compensation to claim under the league's arbitration rules in the event City are found guilty of some of the serious charges facing them.

PGMOL taking new **Coote allegations** seriously

To realise the aspiration, Youth and Sports Minister Hannah Yeoh said KBS will transform the National Youth Skills Institute (IKBN) in Kuala Langat into the National Sports Skills Institute (IKSN) next year to provide the necessary education and upskilling in the field of sports technology in Malavsia.

Yeoh said among the programmes that can attract attention in Sports TVET education at IKSN are in the field of construction and maintenance of sports facilities, sports motoring and sports photography. but it is a good start. Even though we want to try it now, we have to make sure that the instructors are ready," she said after attending the Sports TVET Engagement Session in conjunction with the Skills Symposium of the Institute of Youth and Sports Skills Training (ILKBS) 2024 (SKIL'24) near Puchong on Wednesday. Yeoh said the introduction of Sports TVET

could also reduce the country's dependence on foreign expertise and help reduce number of foreign workers in the sports

industry.

Yeoh had earlier said Sports TVET will be more sports-related: "... for example, we have already offered skills in sports massage, golf caddying... So, we are exploring all sports science-related TVET programmes to ensure that the direction is focused."

She said the reduction of the foreign workforce at sports facilities is also seen a able to reduce the cost of workers' wages, thus ensuring that the price of access to sports remains affordable and does not burden fans

On Wednesday's engagement session, Yeoh said it was aimed at gathering feedback from stakeholders comprising the industry, sports associations and lead agencies to ensure that the planned Sports TVET is in line

with the needs of the industry.

She said the ministry is focusing on empowering youth with skills that can provide income, such as the KLAS Renang programme which provides free swimming lessons for B40 youths and a career for former swimmers. – Bernama

HE rapid advancement of digital transformation today requires nations to adapt artificial intelligence (AI) technology to remain competitive.

Zaidatul, affectionately known as Adeq, said she has relied heavily on a smart watch from a leading Chinese brand since last year to optimise her rest periods during training, whether at the

gym or on the track.

"I received this smart watch as a reward for winning bronze in the women's 4x100 metres at the Hangzhou 2022 Asian Games, and since then, I've been using this device, especially during training sessions.

"Since the smart watch can read my heart rate, it notifies me of any changes and such. Interestingly, the smart watch also alerts me if I sit or stand too long, reminding me to resume training," she told Bernama.

According to Cheng Hoe, some equipment he has used includes GPS vests and other devices for monitoring player performance, condition, and fitness.

He noted that the data collected is crucial to ensure that all decisions made benefit not only the individual players but also the team as a whole.

"Thirty years ago, we relied on players' facial expressions to gauge fatigue, but now we can monitor fitness

levels using GPS trackers.
"I don't use AI 100 per cent but employ it to gather player data, especially during training sessions and match days, he said.

Cheng Hoe said that the data obtained allows him to plan training sessions more effectively to ensure his team is at its best

"But we also can't rely solely on AI because it only serves as a guide; the actual insight comes from the coach

himself," he added.

Former national men's hockey coach A. Arul Selvaraj said live

video assistance technology technology during matches when he led the Speedy Tigers helped him analyse players' performance on the pitch.

Although there is an AI element in the technology, he still relies on human input to monitor the video to during

to monitor the video to ensure that decisions made are precise and effective.

"In hockey (in

"In hockey (in Malaysia), I am unsure how extensively AI is used, but I have mostly used GPS tracking and heart rate monitoring systems," he said.

Arul Selvaraj, who now resides in Ireland, revealed that some hockey clubs there have begun using more advanced AI technology compared to what is available in Malaysia.

He said that technology used in

Ireland through match video recordings not only tracks players' mistakes but also

ball movement.

However, the former UniKL hockey team coach noted that the use of AI in hockey at the international level is not as advanced compared to football, where some teams in Belgium have cameras installed throughout stadiums monitor movements and conduct live analysis of players.

analysis of players.

While acknowledging the benefits of technology, Arul Selvaraj, echoing Cheng Hoe's view, said these tools cannot be fully relied on, as their effectiveness still depends on the coach's expertise and how players adapt to decisions, including tactical changes, to achieve positive outcomes in matches. - Bernama
