PM launches Visit Malaysia Year 2026 campaign

Involvement of all states, parties would help achieve projected income of RM147.1b and 35.6m tourist arrivals: Anwar

SEPANG: Prime Minister Datuk Seri Anwar Ibrahim wants all ministries to focus on enhancing capabilities in the fields of tourism, investment and the economy, with the involvement of all states through the Visit Malaysia Year 2026 campaign.

Anwar, who is also finance minister, said every state and district has its own strengths to

attract visitors.

"In fact, as we strive to make a success of the

Asean chairmanship, we will ensure our programmes will equip all states, with no exceptions, to become tourism destinations this year and next year, in particular," he said at the launch of the Visit Malaysia Year 2026 (VM2026) campaign yesterday.

Anwar said the comprehensive involvement

of all parties would help the nation achieve a

projected income of RM147.1 billion as well as

targeted tourist arrivals of 35.6 million.

He said for the campaign, inclusivity becomes a major approach in promoting the country's sustainability and harmony in terms of a multicultural legacy with a strong cultural

"So, the impact of Visit Malaysia 2026, as I've sol, the impact of visit (Malaysia 2025, as I ve said, will go far beyond the tourism industry to include hospitality, transport, retail and food industries, while the economic benefits will be shared by urban and rural communities."

He said the Madani framework itself is about inclusivity in championing sustainability concurrently with the attainment of a higher quality of life and development and nature. and harmony between

Anwar described Malaysia as a unique

destination that is environment-friendly and has a charming multicultural identity, which is culturally divergent and rich.

He commended the VM2026 theme song titled *Surreal Experiences*, adding that it perfectly encapsulates Malaysia's uniqueness while being appealing to the younger generation.

"If we look at the theme song, it captures the inclusiveness of all districts and states in the Peninsula, Sabah and Sarawak,

problem of heavy vehicle overloading

Move to stem

PUTRAJAYA: The Transport Ministry will focus this year on efforts to address the issue of overloading involving heavy vehicles, which has been occurring for years, said its minister Anthony Loke.

He said the ministry would study the need to amend and improve laws such as the Road Transport Act 1987, Land Public Transport Act 2010 and the Commercial Vehicles Licensing Board

He added that this includes exploring the need to review the rates of compounds and fines for overloading offences.
"I want to state here my desire and

determination to, once and for all, tackle and resolve this issue of overloading.

"It needs a lot of integrated action," he told a media conference after delivering the ministry's 2025 New Year message yesterday.

He said the ministry would review the

logistics ecosystem, apart from collaborating with port authorities to resolve the issue of overloaded vehicles.
"We are also studying the suitability of

imposing liability on the consignee, who may be responsible in the ecosystem for the offence of overloading."

Loke said the ministry would also look

at the legal framework to gazette regulations for pick-up vehicles to carry goods or loads safely as long as they do not exceed the permitted weight limit.

"This is to ensure uniformity from the aspects of legislation and enforcement in the field."

Loke added that the ministry would review its policy on the registration and use of rebuilt vehicles to ensure that only heavy vehicles with the best integrity, safety and quality are allowed on the road.

"For this, the ministry will collaborate with the Investment, Trade and Industry Ministry to comprehensively review

He said based on Road Transport Department records, there were 145,836 rebuilt vehicles with active status and 38,000 units that are inactive nationwide

Bodycams for RTD enforcement officers

PUTRAJAYA: Transport Minister Anthony Loke has announced that the Road Transport Department (RTD) will introduce bodycams for its personnel to enhance enforcement transparency.

Speaking at a media conference following the ministry's 2025 New Year briefing, he said this would improve their effectiveness, particularly concerning

heavy vehicles.

He added that the measure was specifically requested by RTD directorgeneral Datuk Aedy Fadly Ramli to ensure the highest standards of image, safety and integrity for officers on duty.

"The use of body cameras not only

protects the image and integrity of RTD but also safeguards the officers themselves.

"As I have mentioned before, officers sometimes face criticism, humiliation and various accusations. With the body cameras, RTD officers are protected, as any evidence during their enforcement actions can be captured.

Govt urged to address fishing vessel regulation concerns

SIBU: The government decision to mandate the installation of mobile tracking units (MTU) on Class C fishing vessels has drawn criticism from fishing industry stakeholders.

Two days ago, more than 200 members of the Sarawak Fishing Vessels Association in the state suspended operations for a week, with its chairman Harry Tan stating that the move was to protest what they view as unfair treatment and policies imposed by the Fisheries Department.

Tourism, Arts and Culture Minister Datuk Seri Tiong King Sing called on the relevant authorities to initiate immediate and effective dialogue with the fishermen to find appropriate solutions and prevent the issue

from escalating.

Tiong, who is also Bintulu MP and Dudong assemblyman, said the situation could potentially disrupt the food supply chain in Sarawak and with the Chinese New Year

approaching, it would affect the supply of fish.
"If the authorities do not promptly implement a better solution, there will likely be a shortage of supply, forcing the public to pay higher prices for fish," he said in a statement yesterday.

Tiong said the Fisheries Department had

said it would not approve the renewal of licences for Class C trawlers without satellite trackers as of Jan 2, and vessels found operating without them would face enforcement action.

He said fishermen in his constituencies had repeatedly voiced concerns, emphasising that the measure would add to their financial

"The cost of installing the MTU alone

exceeds RM6.000. Then, there's another RM2,000 annually for rental and maintenance, he said, adding that the fishermen face added challenges adapting to climate change and increased minimum wages while enhancing

their competitiveness in the market.

He emphasised that Prime Minister Datuk Seri Anwar Ibrahim had called on the government to prioritise resolving the fundamental issues faced by the people and had directed the secretaries-general of all ministries to address public concerns personally.

"I sincerely hope that the director-general of the Fisheries Department and Agriculture and Food Security Minister Datuk Seri Mohamad Sabu will address this issue and resolve it appropriately to ensure fishermen can continue to make a living." - Bernama

Cabinet to discuss incident involving **Palestinians**

SEPANG: A commotion involving Palestinians at Wisma Transit Kuala Lumpur (WTKL) will be discussed at a Cabinet meeting tomorrow.

Communications Minister Fahmi Fadzil said: "In several Cabinet meetings before, the issue of relocation (of the Palestinians) to new premises was raised.

The Cabinet has not been informed of the updates but I am sure there will be some for the media after the meeting."

On Sunday, the Armed Forces confirmed that the commotion, which occurred on Saturday and was widely discussed on social media, stemmed from the wish of the Palestinians to expedite their return to Palestine.

A similar incident occurred in October last year, involving Palestinians expressing dissatisfaction over being housed at the transit centre and the restrictions on their movements.

On Aug 16 last year, Malaysia brought in 127 Palestinians, including 41 injured individuals affected by Israeli attacks in the Gaza Strip, here for medical treatment.

The injured were treated at the Tuanku Mizan Armed Forces Hospital while their relatives were accommodated at WTKL.

When asked about the ministry's actions following the spread of videos on social media, including one that occurred at Masjid At-Taqwa in Taman Tun Dr Ismail, Fahmi said the public is often exposed to online content that has uncertain authenticity.
"I call on everyone to make an effort to

seek and understand the true context of such content.

"It is important that we exercise patience to obtain or fact-checking." – Bernama

Penang launches townhouse design

Bid by Najib on addendum remitted back to High Court

PUTRAJAYA: In a 2-1 majority decision, the Court of Appeal has remitted Datuk Seri Najib Abdul Razak's bid to the High Court for a hearing on its merits, regarding his claim of the existence of a royal addendum allowing him to serve the remainder of his six-year prison

Justices Datuk Azhahari Kamal Ramli and Datuk Seri Mohd Firuz Jaffril allowed the former premier's appeal to overturn the High Court dismissal of his application for leave to commence a judicial review on the matter.

Justice Datuk Azizah Nawawi, who led the panel, dissented, stating the appeal had no merit.

Azizah also denied Najib's application to adduce additional evidence to support his claim whereas Azhari and Mohd Firuz allowed it. allowed it.

Najib, 71, is appealing the Kuala Lumpur High Court decision on July 3 last year, which dismissed his application for leave to commence a judicial review of the purported addendum issued by the 16th Yang

di-Pertuan Agong.

In delivering the decision,
Mohd Firuz said the court took note of the reasoning of the High Court judge for dismissing the leave application, which was largely application, which was largely based on Najib relying on hearsay evidence. "Premised on the new evidence

admitted by the applicant, we find that the issue of hearsay can no

longer stand.
"Bearing in mind that an applicant in a judicial review only needs to show that he or she has a good, arguable case premised on Premised on new evidence admitted by applicant, panel finds issue of hearsay can no longer stand

the fact that his interest or rights have been aggrieved and the case is not frivolous and vexatious, we are minded to allow the appeal.

"We order the matter be remitted to the High Court for a hearing of the substantive judicial review application."

Regarding the application to adduce additional evidence, Mohd Firuz noted that Najib had written to respondents seeking confirmation of the existence of the addendum order but they did not respond.

"The High Court judge had decided that the information obtained from these various sources were hearsay."
Azizah, in her minority decision,

said there was no appealable error made by the High Court in ruling that the evidence presented in the hearing was hearsay, Bernama reported.

"I agree with the finding of the

High Court judge that there is no legal duty imposed on the respondents, particularly the respondents, particularly the Pardons Board, to confirm the existence or produce any order related to the exercise of the power of pardon.'

She said neither the written law nor the Federal Constitution contains any provision requiring the Pardons Board to confirm or disclose the existence of a

pardon order, including the addendum order.

Earlier during proceedings, Najib's counsel Tan Sri Muhammad proceedings Shafee Abdullah produced a letter from the Pahang Sultanate Council regarding the addendum while submitting the application to present additional evidence.

"The letter, dated Jan 4, was addressed to Najib's eldest son Datuk Mohamad Nizar by the Comptroller of the Royal Household of Sultan of Pahang, Datuk Ahmad Khirrizal Ab Rahman.

Senior federal counsel Shamsul Bolhassan, representing the government and respondents, said the addendum was never discussed or brought up during the Federal Territory Pardons Board 61st meeting on Jan 29 last year. "The main order, as announced

in February, had agreed to reduce Najib's jail sentence from 12 years to six, and the fine from RM250 million to RM50 million. "That (main order) is the only

one signed and sealed by the 16th Yang di-Pertuan Agong Al-Sultan Abdullah Ri'ayatuddin Al-Mustafa Billah Shah and this order was directed to the then minister.'

Meanwhile, Home Minister Datuk Seri Saifuddin Nasution Ismail said the Prisons Department has never received any directive

from the Federal Territories of Kuala Lumpur, Labuan and Putrajaya Pardons Board to allow Najib to serve the remainder of his prison sentence under house arrest. He said on Feb 2 last year, the

Prisons Department only received meeting minutes and an order to implement the decision made by the board during its meeting on Jan 29. 2024.

He added that the directive, signed by Al-Sultan Abdullah and witnessed by Minister in the Prime Minister's Department (Federal Territories) Dr Zaliha Mustafa, merely instructed the Prisons Department to reduce Najib's prison sentence to Aug 23, 2028 and cut his fine to RM50 million.

The order also stated that if the

fine is not paid, the prison sentence will be extended by another year, making his release date Aug 23,

2029, he said.
"The letter received by the Prisons Department does not mention house arrest. As a department tasked with implementing the directive, the Prisons Department must act with integrity in executing the order.

"It is important to clarify that the Home Ministry and the Prisons Department have not concealed any decision made by the Pardons Board or failed to comply with it. We only act based on authentic and official directives, as received," Saifuddin Nasution said during a special press conference yesterday.

"With this, I hope to make it clear that the Home Ministry has fully carried out Tuanku's (Al-Sultan Abdullah's) directive. Any claims to the contrary are untrue.

Licence requirement sparks debate on rights of web users

Regulation for social media platforms could serve as cornerstone for building trust, enhance security in digital space: Specialist

PETALING IAYA: As Malaysia enters 2025, internet messaging and social media services providers with eight million or more users are mandated to hold an Applications Service Provider class licence (ASP (C) Licence).

This has sparked a nationwide debate about online safety versus freedom of expression.

Cyber security specialist firm Novem CS CEO Murugason Thangaratnam said the new licence is required pursuant to the Communications and Multimedia Act 1998 for providers to make their services available in Malaysia.

"Licensing is a way to create a trusted ecosystem, provided it is not biased or has a hidden agenda.

So transparency in its implementation is the key to its

He said online safety and freedom of expression are not mutually exclusive, but jointly achieve harmony, and that the new licensing requirement could serve as a cornerstone for building trust in the digital space.

Murugason emphasised that democracy thrives on the free exchange of ideas which enables the public to make informed decisions.

"However, the ease of online communications has led to abuses such as cyberbullying, threats and the spread of extremist content, which should not be protected.

"Online users are increasingly aware of the importance of safety. Most are willing to accept additional security measures, such as the need their rights and privacy are protected."

Murugason said "overreach" is a pressing concern and may discourage some Malaysians from expressing their opinions online out of fear of surveillance or content takedown.

"Social media platforms that are now accountable for moderating harmful content must navigate the fine line between removing illegal and preserving lawful system is critical to ensuring that platforms respect users' rights while adhering to the new licensing requirement.

He said licensing should incentivise platforms to create robust review systems that respect free speech while effectively addressing harmful content since this is crucial to fostering trust in the digital space.

The new licensing requirement focuses on social media and messaging platforms as it aims to enhance child safety and curb harmful behaviour, he added.

In contrast, the European Union's (EU) Digital Services Act (DSA) applies to a broader spectrum, including e-commerce platforms and

online marketplaces. He said the DSA imposes stricter transparency and accountability requirements, such as annual independent audits for those designated as "very large online platforms".

Besides that, India's IT Rules 2021 mandate swift action where social media platforms must remove illegal content within 36 hours of receiving a complaint.

Murugason said the comparisons highlight opportunities for Malaysia to refine its approach by to refine its approach by incorporating lessons from more comprehensive frameworks in the EU and India.

"A core difficulty lies in defining

harmful content.

"Cultural, social, and political differences influence perceptions of what constitutes offensive material."

"For instance, critical commentary on governments may be considered harmful in some countries but viewed as legitimate dissent that is protected by 'free speech' in democracies." He said a universal definition of

"harmful content" is nearly impossible to achieve due to cultural and societal differences, so Malaysia's approach should be context-sensitive and adaptable to local needs.

Murugason said cyber threats

such as deepfakes and online scams pose significant risks, and countries that have successfully tackled them can offer valuable insights.

"Leveraging advanced like technologies like artificial intelligence-driven moderation and blockchain programmes for content verification could enhance the

efficacy of our licensing regime."

Murugason added that investing in cutting-edge technologies and fostering public-private collaborations will be crucial to combating such emerging threats.

The new licensing requirement is pivotal step to shaping the country's digital future and its success hinges on striking the delicate balance between safety and freedom, he said.

No cause for panic over hMPV cases, public told

KUALA LUMPUR: The public need not panic about the presence of human metapneumovirus (hMPV) as it is known for its seasonal recurrence patterns.

Molecular virologist Assoc Prof Dr B. Vinod said hMPV lacked the high transmissibility and asymptomatic spread observed with Covid-19

Vinod, who is also a lecturer at Monash University Malaysia Jeffrey Cheah School of Medicine and Health Sciences, said although China is experiencing seasonal respiratory illness spikes, including hMPV, respiratory syncytial virus (RSV) and influenza, there was no evidence to suggest that these posed a global pandemic threat like Covid-19 had.

Vinod said Malaysia had a pre-existing circulation of hMPV and other respiratory viruses, adding that the arrival of tourists was unlikely to introduce a new or unknown pathogen.

"Unlike SARS-CoV-2 (which causes Covid-19) in 2020, hMPV does not spread asymptomatically as extensively, and its severity is generally manageable in healthy populations." Vinod said the high-risk groups

Vinod said the high-risk groups identified for hMPV infection include infants and young children, particularly those under one year old, elderly individuals who may have a generally weaker immune system, as well immune system, as well as immunocompromised individuals such as those undergoing chemotherapy or managing chronic illnesses.

"hMPV. Covid-19 and influenza are all respiratory viruses but differ in severity.

"Covid-19 and influenza range from mild to severe conditions.

"hMPV, on the other hand, only generally causes mild to moderate respiratory illness.

'However, in high-risk groups, it could also lead to severe conditions like bronchiolitis or pneumonia."

Elaborating on the symptoms of hMPV, Vinod said the infection typically resembled the common cold, which might include a cough, fever, runny or stuffy nose, sore throat, wheezing, shortness of breath and sometimes a rash. To reduce the risk of hMPV

infection, Vinod advised regular hand washing with soap and water for at least 20 seconds, using an alcohol-based hand sanitiser when soap and water are unavailable. Vinod also advised the public

to refrain from touching the eyes, nose, or mouth with unwashed hands. - Bernama

Hobby becomes joyful pursuit for hotel reviewer

KUALA LUMPUR: Burhanuddin Abdul Jalil, 55, a senior executive at a financial firm, spends about RM1,000 from his salary each month to stay at different hotels and write reviews of his experiences on his website.

"But when travel restrictions were imposed during the Covid-19 pandemic, I booked hotel rooms around the capital city as accommodation was still allowed under certain standard operating procedures at that time."

What began as a way to cure boredom during the pandemic has now turned into an "addiction" and a source of joy, prompting him to

continue the activity to this day.

"My friends often ask for recommendations on good hotels to stay at, so I decided to start writing reviews for every hotel I visit. Since I'm also good at photography, it felt like a natural fit," he said.

"I write my reviews in the form of short essays using simple, easily understood Rahasa Melavu Alhamdulillah, I've received many positive feedback, and my reviews have helped others make informed decisions about choosing hotels that suit their needs," he said.

He shares his observations on

hotel facilities through his website hanuds.wixsite.com/hanudds and contributes articles to the "Hotel Review Malaysia" Facebook page.

Based on his experience, Burhanuddin noted that hotel prices can vary greatly, sometimes being very affordable and other times skyrocketing.

Be courteous to people of all faiths, Muslims urged

Experts highlight importance of compassion and Islamic ethics in handling sensitive situations

PETALING JAYA: An academic and expert in Islamic ethics has reminded Muslims that their religion requires them to act courteously and respectfully towards individuals of all

Universiti Islam Antarabangsa Tuanku Syed Sirajuddin rector Prof Dr Muhamad Rozaimi Ramle made the statement in response to a recent video showing a man disrupting a congregation at At-Taqwa Mosque in Taman Tun Dr Ismail, Kuala Lumpur.

The incident, which occurred during early morning prayers on New Year's Day, has sparked widespread concern and online debate over the appropriate response to such situations.

The 160-second video shows the man, reportedly suffering from mental health issues, wandering inside the mosque despite being asked to leave.

The situation escalated, resulting in the

man being harassed, kicked and shouted at by several individuals.

Muhamad Rozaimi said Muslims should avoid harsh actions, regardless of who the allegedly offending individual is, their

altegeny offending individual is, their behaviour or their mental state.

"If necessary, let security personnel or police handle the situation. Beating or harassing the individual is inappropriate. I understand the anger and emotions involved, but we must respond in a manner befitting the situation," he said.

He emphasised that hostility is against Islamic principles, irrespective of race, religion or health, and urged Muslims to follow the teachings of Prophet Muhammad.

"From the *Sirah* (Prophet's biography), it is evident that non-Muslims were allowed by the Prophet to enter mosques. In one *hadith*, a bedouin urinated in a mosque. While the Prophet's companions wanted to react harshly, the Prophet instructed them to leave him alone.

Instead of punishing the man, the Prophet gently explained that mosques are sacred spaces and such actions were inappropriate."

Muhamad Rozaimi called on Muslims to

embody Islamic manners and ethics, treating others with kindness to reflect the beauty of

Perlis Mufti Datuk Dr Mohd Asri Zainul Abidin also advised Muslims to avoid sending the wrong message to non-Muslims.

"Some people visit mosques out of curiosity and without any hostile intent. They

should be welcomed and Islamic practices explained to them. It is neither wise nor appropriate to harass any visitor.

"Sharing videos of such incidents can lead to misunderstandings, with the public questioning such behaviour, and families or communities feeling hurt by the lack of compassion," he said.

Mohd Asri added that mosques are open

for everyone to reflect and learn.

If someone behaves inappropriately, they should be escorted out respectfully

"This does not mean non-Muslims can enter and behave as they please. They too must show respect when entering a mosque, as it is a sacred place for Muslims."

In a statement on Jan 2, mosque officer Ahmad Fakhruddin Mohd Tahir said the man damaged a television set and rushed towards the front of the prayer hall.

"The man appeared to be in an 'abnormal' state. Eventually, a brief struggle ensued involving him, security personnel and several others who attempted to apprehend and hand him to police," he said.

Brickfields OCPD assistant commissioner Ku Mashariman Ku Mahmood confirmed a police report had been lodged.
"The man has been suffering from mental

MANILA: Up to 300 Afghans arrived in the Philippines yesterday on temporary stays while waiting for their documents to be processed for US resettlement.

The Philippines and the United States signed an agreement last July allowing Afghans to stay in Manila while their US Special Immigrant visas were being processed.

This was despite domestic opposition over security and other concerns.

"The Department of Foreign Affairs issued the appropriate Philippine entry visa to these applicants," said its spokesperson Teresita Daza.
"All amplicants completed extensions

"All applicants completed extensive security vetting by security agencies."

A US State Department official,

speaking on condition of anonymity, would not be specific about the number involved other than to say "up to 300". Under the deal, the US government

will shoulder the cost of stays in Manila, including food, housing, medical care,

security and transport.

The Afghans will stay at a facility run by the State Department Coordinator for Afghan Relocation Efforts. Daza had previously said the Afghans

Wild elephants have killed 227 people, including tourists, in the past 12 years, according to the Department of National Parks, Wildlife and Plant Conservation.

An elephant killed a 49-year-old woman at a national park in Loei province in northern Thailand last month.
While encounters between villagers

and wild elephants are common, attacks at sanctuaries remain rare.

Bathing elephants is a popular activity among visitors in Thailand.

However, animal rights groups argue that bathing elephants can cause them distress and some sanctuaries in the country do not allow it. - AFP

Prabowo's free-meal programme takes off

Indonesia aims to combat stunting

JAKARTA: Indonesia launched an ambitious US\$4.3 billion (RM19.4 billion) free-meal programme vesterday to combat stunted growth due to malnutrition, a key election promise of President Prabowo

Prabowo has pledged to provide free nutritious meals to tens of millions of schoolchildren and pregnant women, saying it would improve their quality of life and

boost economic growth.
"This is historic for Indonesia, for the first time conducting a nationwide nutrition programme for toddlers, students, pregnant and nursing mothers," said presidential spokesman Hasan Nasbi

At least 190 kitchens run by third-party catering services opened nationwide, including some run at military bases, were tasked with preparing meals from midnight before distributing them to schoolchildren and pregnant women.

Second-grader Khalifa Eldrian was seen beaming after finishing his free lunch of rice, chicken, vegetables and a banana at a primary school in East Jakarta.

"I'm happy because the food was delicious. I can concentrate better now when studying," he said.

The government has allocated

10,000 rupiah (RM2.80) per meal and has a budget of 71 trillion rupiah (RM19.40 billion) for the 2025 fiscal year. It is set to deliver meals to almost 83 million people

Stunting affects 21.5% of children in the archipelago of some 282 million people. The Southeast Asian nation aims to reduce the rate to 5% by 2045.

Staff at a kitchen in Bogor, West Java, had worked tirelessly since just after midnight.

"We serve different menus every day. It has to be different so children won't get bored," said staff member Ayu Pertiwi.

She said they were able to serve fairly nutritious meals such as eggs and fish even with the limited budget, although meat would likely only be served twice a month.

"We can still create various

menus, but the options are limited. For us, the most important thing is

the meal is nutritious," she said.

The programme was met with scepticism from experts and the public when it was first announced

during campaign election last vear's

Tan Shot Yen, a Jakarta-based nutritionist and doctor, said trials late last year were mostly conducted in urban centres and assessments were not made available to the public.

She said the government needed

transparent monitoring and robust food safety management to prevent hazards and the inclusion of unhealthy processed products, such as instant noodles and

sausages.
"I hope this programme is not just a temporary charitable effort to fulfil political promises," she said.

"To continue it for the long term, the government should focus not only on funding but also on empowering communities so (recipients) are not simply reliant on free meals once a day while struggling to find food for the other two meals," she said.

Prabowo has championed the

programme since the presidential campaign and his team has said the poorest and most remote areas would be prioritised.

He travelled to several countries. including the United States and the United Kingdom seeking funding support, after he was sworn in last October.

He secured a US\$10 billion deal with Chinese leader Xi Jinping in November for support in several sectors, including the free-meal

programme.

However, analysts have said the scheme is not sustainable in the long term.

I am pessimistic if everything is shouldered by government.

"Economically, it's not sustainable," said Aditya Alta, a public policy analyst from the Centre for Indonesian Policy Studies think tank.

"Stunting is a multidimensional issue and addressing it through one approach is insufficient." – AFP

S\$1m worth of drugs seized, four arrested

SINGAPORE: The Central Narcotics Bureau (CNB) seized drugs estimated to be worth over \$\$1 million (RM3.27 million) on Saturday, potentially enough to fuel the addiction of around 4,590 drug abusers for a week

CNB said in a statement that four Singaporean suspects – three men and a woman – were arrested in connection with the drug haul, included

ketamine, ecstasy and cannabis.

Two of the male suspects, aged 25 and 27, were arrested by CNB officers at a car park in the vicinity of Cassia Crescent.

A third suspect, a 25-year-old man, was arrested following a short pursuit after he fled upon witnessing the arrest of the two men. A weapon was also seized.

25-year-old Meanwhile. woman, suspected of being a drug abuser, was arrested in a raid at the suspected hideout of the 27-year-

old man, a residential unit in the same vicinity. CNB said investigations into the drug activities of the arrested

suspects are ongoing.
CNB Intelligence Division director deputy assistant commissioner Aaron Tang said the bureau would pursue drug traffickers and bring them to justice. "Drug traffickers have no concern for the thousands of lives their deadly wares would have destroyed had the drugs reached the streets," he said.

Under Singapore law, a person found guilty of trafficking more than 15g of diamorphine or "pure heroin", or more than 250g of methamphetamine, or more than 500g of cannabis, faces the death penalty. - Bernama

More than 260 displaced Rohingya arrive in Aceh

BANDA ACEH: More than 260 Rohingya, including women and children, have arrived in Indonesia's easternmost province of Aceh.

An East Aceh official, Iskandar, said the group of refugees arrived on a beach near the town of West Peureulak on Sunday night.

"There are 264 of them – 117 males and 147 females," Iskandar said, adding around 30 arrivals were children.

He said they had initially been on two boats, one of which had sunk off the coast while the second managed to move closer to shore.

They were able to walk to the shore when the tide was low, he said.

Iskandar said the local government officials had not decided where to move the arrivals.

Rohingya arrivals in Indonesia tend to follow a cyclical pattern, slowing during the stormy months and picking up when sea conditions calm down.

In November, more than 100 refugees were rescued after their boat sank off the coast of East Aceh.

In October, 152 Rohingya were brought ashore after being anchored for days off the coast of South Aceh

district while officials discussed whether to let them land.

Indonesia is not a signatory to the UN refugee convention and says it cannot be compelled to take in displaced people from Myanmar, calling instead on neighbouring countries to share the burden. - AFP

Canadian PM Trudeau likely to announce resignation

Ruling Liberals trailing badly in polls

OTTAWA: Canadian Prime Minister Justin Trudeau is increasingly likely to announce he intends to step down, though he has not made a final decision, a source familiar with Trudeau's

thinking said on Sunday.

The source spoke to Reuters after the Globe and Mail reported that Trudeau was expected to announce that he would quit as leader of Canada's ruling Liberal Party after nine years in

The source requested anonymity because

they were not authorised to speak publicly.

Trudeau's departure would leave the party without a permanent head at a time when polls show the Liberals will badly lose to the official opposition Conservatives in an election that must be held by late October. Sources told the Globe and Mail that they did

not know definitely when Trudeau would announce his plans to leave but said they expect

it would happen before an emergency meeting of Liberal legislators tomorrow.

An increasing number of Liberal parliamentarians, alarmed by gloomy polls, of Liberal have publicly urged Trudeau to quit. The prime minister's office

immediately respond to a request for comment outside regular business hours. The prime minister's published schedule said he would participate virtually in a Cabinet committee meeting on Canada-US relations.

It remains unclear whether Trudeau will leave immediately or stay on as prime minister until a new Liberal leader is selected, the *Globe* and Mail report said.

and Mail report said.

Trudeau took over as Liberal leader in 2013 when the party was in deep trouble and had been reduced to third place in the House of Commons for the first time.

If he does resign, it would likely spur fresh calls for a quick election to put in place a stable government able to deal with Donald Trump's administration for the next four years.

The prime minister has discussed with

Finance Minister Dominic LeBlanc whether he would be willing to step in as interim leader and

prime minister, one source told the newspaper, adding that this would be unworkable if

LeBlanc plans to run for the leadership.

Trudeau, 53, had been able to fend off Liberal legislators worried about the polls and the loss of safe seats in two special elections.

But calls for him to step aside have grown since December, when Trudeau tried to demote Finance Minister Chrystia Freeland, one of his closest Cabinet allies, after she pushed back against his proposals for more spending.

Freeland quit instead and penned a letter accusing Trudeau of "political gimmicks" rather

than focusing on what was best for the country.

Trudeau propelled the Liberals to power in
2015 promising "sunny ways" and a progressive
agenda that promoted the rights of women.

But the everyday realities of governing gradually wore him down.

Although Ottawa spent heavily to protect consumers and businesses, racking up record budget deficits, this provided little protection

from public anger as prices soared.

Taiwan reports 2.4m cyberattacks daily on govt offices

TAIPEI: Cyberattacks on Taiwan government departments doubled last year from the previous year to an average of 2.4 million attacks a day, the island's National Security Bureau said, adding most

were launched by Chinese cyber forces.

Taiwan's Government Service Network or GSN, received a daily average of 2.4 million attacks last year, double the daily average of 1.2 million in 2023, according to a report by the National Security Bureau. The bureau offered rare details of the

attacks, attributing most to China's cyber forces, with telecommunications, transport and defence among the top targets.
"Although many of those attacks have

been effectively detected and blocked, the growing numbers of attacks pinpoint the increasingly severe nature of China's hacking activities," the report said.

China routinely denies being involved in hacking attacks but is frequently accused by foreign governments, especially the United States which last tracking actions to the control of the week said Chinese hackers stole documents from the US Treasury Department.

The Taiwanese report said China launched some of the attacks to coincide with Chinese military drills around the island, including distributed denial-ofservice attacks designed to disrupt access to web pages of Taiwan's transport and financial institutions.

The move, the report said, was meant to "intensify the harassment effect and military intimidation". – Reuters

Investigators ask police to arrest Yoon

SEOUL: Anti-graft investigators asked police yesterday to arrest impeached President Yoon Suk Yeol, after he fended off their week-long efforts to bring him into custody over his failed martial law bid.

The former star prosecutor has refused questioning and defiantly holed up in his residence, with a failed arrest attempt last

week leaving investigators trying to extend the warrant's deadline and asking for help. Investigation office (ClO) said they had asked for the police to take over because of the difficulties they had faced. Yoon's legal team has refuted the CIO's authority to arrest him.

The validity of the warrant expired

"We plan to request an extension from the court," said CIO deputy director Lee Jaeseung.

He said they would consult police on the timing of the warrant extension. Police have yet to accept the request.

Last week investigators made a U-turn

over safety fears following a tense, hours-long standoff with hundreds of security forces.

Yoon faces prison or, at worst, the death penalty if convicted for insurrection over briefly suspending civilian rule and plunging South Korea into its worst political crisis in decades, but both he and his supporters have remained defiant.

"The presidential security service will protect the president, and we will protect the presidential security service," said Kim Sooyong, 62, one of the protest organisers.

The initial warrant was issued on the

grounds that Yoon has refused to emerge for questioning over his martial law decree.

His lawyers have repeatedly said the warrant is "unlawful" and "illegal".

The head of Yoon's presidential security service said on Sunday he would not allow investigators to arrest the suspended president. - AFP

Flight EY461 to Abu Dhabi was travelling down the runway when two tyres burst, forcing pilots to slam on the emergency brakes. "Due to damage to the tyres, we have been unable to tow the aircraft off the runway. Repairs will be done on location," Melbourne Airport said. All passengers on board the Boeing 787-9 Dreamliner were safe. – Bernama

CAIRO: Israel and Hamas wrangled on Sunday over the details of a deal to halt fighting in the Gaza Strip and return hostages home, as Palestinian officials said intensified Israeli bombardments had killed more than 100 people over the weekend. A Hamas official said the group

had approved a list of 34 Israeli hostages to be returned as part of a deal that could eventually lead to a ceasefire. But Prime Minister Benjamin Netanyahu's office swiftly issued a statement saying Hamas had not provided a hostage list.

Later on Sunday, the Hamas official provided Reuters a copy of the list showing the names of 34 hostages it agreed to set free in any possible ceasefire deal with Israel.

A renewed push is under way to reach a ceasefire in the 15-month war between Israel and Hamas, and return Israeli hostages who were taken to Gaza, before US presidentelect Donald Trump takes office on

Jan 20.

The effort comes amid a surge in Israeli military action in the enclave. Israeli airstrikes last weekend killed 105 Palestinians in Gaza, medics said. The Israeli military said it had killed dozens of gunmen. The US State Department said

Israel must comply with international law and do "significantly more to ensure the protection of civilians". It said, however, that it supports Israel's right to defend itself.

Israeli negotiators were dispatched on Friday to resume talks in Doha brokered by Qatari and Egyptian mediators, and US President Joe Biden's President Joe Biden's administration, which is helping to mediate, has urged Hamas to agree to a deal.

Hamas said on Friday it was committed to reaching an agreement as soon as possible, but it was unclear how close the two sides

A Hamas official told Reuters any agreement to return Israeli hostages would hinge on a deal for Israel to withdraw from Gaza and a permanent ceasefire or end to the

war.

US plans more sanctions on tankers carrying Russian oil

WASHINGTON: The United States plans to impose more sanctions on Russia over its war on Ukraine, taking aim at its oil revenues with action against tankers carrying Russian crude, two sources with knowledge of the matter said. President

administration has sought to shore up support for Ukraine before Donald Trump takes office on Jan 20 given the Republican leader's complaints about the cost of US given support for Ukraine.

It is unclear what Trump's

approach to sanctions will be.

The Biden administration is planning sanctions targeting tankers that carry Russian oil sold above the West's US\$60 (RM270) a barrel price cap, the sources said. Russia has used this fleet of aging ships to evade the

Since Russia's February 2022 invasion of Ukraine, the US has sanctioned dozens of these vessels, out of a fleet estimated to be in the hundreds, to reduce its ability to fund the invasion.

The cap has led Russia to redirect

its oil sales to China and India, who have been willing to buy Russian crude, which is typically sold at a discount to the overall market even if sold above the price cap.

"It is going to be a big package,"

one of the sources said. The other source said the sanctions would also likely include measures against people involved in some networks

US Treasury Secretary Janet Yellen said last month that the US is looking and would not rule out sanctions on Chinese banks as it seeks to reduce Russia's oil revenue.

The Treasury's Office of Foreign Assets Control did not respond to a

request for comment on Sunday.
The G7, the EU and Australia imposed the US\$60 cap on Russian oil in late 2022, banning the use of Western maritime services such as transport, insurance and financing for shipments of oil priced at or above the cap.

Norway PM worried by Musk involvement in foreign politics

OSLO: Norway's Prime Minister Jonas Gahr Stoere said yesterday that he found it worrying that billionaire Elon Musk was involving himself in the political issues of countries outside of the United States.

Musk, a close ally of US Presidentelect Donald Trump, last month endorsed a German anti-immigration, anti-Islamic political party ahead of that country's national elections next month, and recently

made remarks on British politics.
"I find it worrying that a man with enormous access to social media and huge economic resources involves himself so directly in the internal affairs of other countries," Stoere told Norwegian public broadcaster NRK.

"This is not the way things should be between democracies and allies.

If Musk were to involve himself in

Norwegian politics, the country's politicians should collectively distance themselves from such

Ecuador ex-VP Glas back in prison

GUAYAQUIL: Ecuador's former Vice-President Jorge Glas was returned to prison hours after he was evacuated for security reasons amid chaotic scenes inside the jail, the prison authority said.

Glas' lawyer, Sonia Gabriela
Vera, said on Sunday the former
vice-president had been
evacuated from La Roca prison after an attempt on his life by mutinying inmates. She said the government was responsible for the situation.

Prisoners caused incidents "in a elear strategy to destabilise order and peace in the country", the Ecuadorian prison agency SNAI said in a statement. It said that Glas was taken back to prison after the armed forces carried out weapons

and explosives control operations. Vera urged the United Nations and other organisations to intervene after what she called an "attempted assassination" of Glas.

The attack "is the result of a state that has condemned him to danger, torture and slow death," Vera said.

Glas was arrested in April after Ecuadorean security forces stormed Mexico's embassy in Quito, where he was holed up

after seeking asylum.
Glas' supporters say the arrest is politically motivated. – Reuters

S development director of Sime Darby Plantations, my main job was handling consultancies for third-party clients. But sometimes the group would also give me assignments.

Unlike working for clients, these did not bring in any fees, but one assignment nearly got me a different kind of work.

It was a time in the early 1990s when interest in planting fast-growing trees was on the rise, and the company wanted a feasibility study. As Sarawak still had a lot of jungle, it was agreed that this was the place for me to go.

I had taken Leow Kok Yuan on the flight to Sibu, where we were going to start work. Leow was adept with figures, and his computer could work out any project as long as I gave him the numbers. He would key them in, but not before asking me a lot of questions.

He was cautious and often tested and tempered my assumptions. I liked the way he could defend his figures when

we faced the people at the top.
Of course, coming from the top, the idea was quickly adopted by all whom we went to see, including the head of logging for Sime Darby. He was managing a concession upriver at Batang Baleh, up Rajang River, and I had heard about him. He was Ross Ibbotson, a man with

many years of experience in the logging industry. He had also planted softwoods in Sabah

I did not meet Ibbotson until a few days later. However, Leow and I were warmly welcomed by his staff – all young and alert Foochow girls. They offered us coffee and cakes, and from the high floor, I had a chance to take in the wonderful scenery of the Rajang River, with longboats coming in and sawmills across the river working hard.

Leow asked for the files on planting

softwood trees. Softwoods grew fast, and I had earlier seen the forests of acacia and albizia in Sabah. They grew well, as did the gmelina. All these trees had long fibre and were suited for making

It took about three days for Ibbotson to come back from Batang Baleh, a tributary of the Rajang River. He was a stout, short figure, packed with energy, and he did not waste any time.

Dream role just wishful thinking

"I would recommend that you use acacia mangium. Even on poor soils, you can get a decent girth increment each year. You can harvest at year 10, and you don't have to replant. The stumps grow new shoots that can be harvested again 10 years later. The woodchips from the logs go to

Japan to produce paper."

Leow waited at his keyboard for some figures to be mentioned. Ibbotson went on: "You may need about 100,000ha, planted over 10 years. Your problem is finding a location with that kind of size."

He stopped to look at Leow and me and turned to the map of Sarawak on the wall.

"It would be here at Tatau or a bit further inside at Tubau, not too hilly for the work we would want to do."

That evening, he invited us to dinner at a restaurant in a private room, but he had to answer questions from Leow.

Ibbotson was happy to give his attention to Leow although his wife had arrived only that afternoon from London. In any case, he did not seem to

have much to say to her. He had only one day left with us in his office before he said he had problems upriver and rushed back up the Rajang River. He said he had to carry out some logging by helicopter where the slope was too steep.

Leow and I stayed back another day with help from the girls, and Leow invited them to lunch. Somewhere along the way, I heard that Mrs Ibbotson had caught a flight back to

On the flight back, I looked down to ee where the plantation was likely to be. Sarawak was fast catching up on planting but with oil palm. It would be a change if I was to run a forest plantation.

I imagined myself on a horse, riding

through the trees each day to check which trees would need thinning and which could be left until harvest time The scene ran in my head, and I wished it would come true.

It was therefore more reason for me to work carefully to the last detail. To be sure, I went to Mount Gambier in Australia and Rotorua in New Zealand to see if the radiata pine would be suitable, and then to Seattle to see the logging operations of Douglas fir by Weyerhaeuser at White River.

I left again to visit the plantations of Eucalyptus in Belo Horizonte, Brazil. Leow stayed back to work at his desk. At the presentation, the bosses approved his numbers without demur

Eventually, a meeting was set with the head of government in Kuching, and I accompanied Tunku Tan Sri Ahmad Tunku Yahya, the head of Sime Darby, and finance director Martin Berry. Tunku Ahmad did all the talking and placed a proposal on the table, and even when it was time to leave, Berry

even, when it was time to leave, Berry and I did not have to say a word.

In the end, we did not get the project. Perhaps the land available was not big enough.

I was disappointed as I could still see myself at the centre of the action, on a horse or driving a Range Rover. In the office, Leow would be in charge of his staff, whom I would help to select. Who would not want to head a business like that and in the middle of a land of legendary beauty like Sarawak? However, later on, rumour had it that

Ibbotson was also aiming for the role. If that were true, he certainly would have been a formidable rival, adding yet another adventure to his life

I smiled when I heard this. Who could blame him?

WHEN children under 15 roam the streets at night without parental knowledge, it is a serious concern that demands attention.

Our youths are becoming rebellious, engaging in dangerous activities like illegal cycling (basikal lajak), late-night races and exhibiting violent behaviour. Some are involved in petty crimes.

We cannot ignore such behaviour, hoping it will resolve on its own. It is crucial that we address these issues before they

escalate further.

Recently, a 14-year-old girl in Seberang Perai was reported to have stabbed

her aunt during a quarrel. In 2022, there were 3,013 cases of minors involved in criminal activities, with the majority of arrests made among those aged 16 to 18. Additionally, many teenagers have been found

living on the streets in Kuala Lumpur. Youths as young as 15 are found living in abandoned, dilapidated buildings, alongside the homeless, drug dealers and pimps.

Instead of being at home and attending school, these young people are surviving in the streets, engaging in petty crimes, drugs and prostitution. Many of them come from broken homes and have fled abusive

parents or step-parents.
Some children are abandoned by parents who feel helpless and are unable to manage their children's disruptive behaviour.

Thankfully, institutions

like the Henry Gurney School in Malacca, which functions similarly to a prison, focus on reforming juvenile delinquents, giving them a chance to turn their lives around.

In addition to being a correctional facility, it also serves as an educational institution where inmates can continue their studies.

Thanks to dedicated teachers, many students from the school have gone on to pursue higher education.

Once students leave the school, it is up to their families and society to embrace them and offer them a second chance at life

Families play a crucial role in a child's physical, mental, spiritual and social development. Many of these troubled children come from broken homes, where parents are divorced or

separated.

While not every child

broken family becomes dysfunctional, most dysfunctional children come from backgrounds.

Violence starts and ends at home as children learn by observing their surroundings. Violence often leads to violence. more

Parents and schools must take greater responsibility in guiding the social and intellectual growth of children.

They need to monitor their activities and foster a culture of care and concern.

ALAYSIA'S Asean chairmanship in 2025 marks a pivotal moment for the region. By championing inclusivity, sustainability, economic diversification and balanced leadership, Malaysia can guide Asean towards stability, resilience and meaningful cooperation.

Tackling issues such as the Myanmar crisis,

integrating Timor-Leste and revitalising the region's digital economy, Malaysia's proactive and transparent approach has the potential to shape Southeast Asia's future while benefiting its citizens and the global community.

Key priorities

As Asean chair, Malaysia's foremost priority must be fostering unity while respecting the sovereignty and diverse interests of member nations – an approach aligned with its Madani vision of inclusivity, integrity and equitable participation. This resonates with Asean's foundational principle of "Unity in Diversity".

Malaysia should continue to foster balanced relationships with all major and middle powers, reflecting Asean's principle of neutrality. By doing so, Malaysia can help mitigate geopolitical rivalries and maintain Asean's centrality.

In line with Asean's 2040 goals, Malaysia

must champion initiatives to enhance regional resilience. Key focus areas should include:

advocating peaceful negotiations to minimise
external interference. This includes championing
dialogue-driven diplomacy through forums like the Asean Regional Forum and the East Asia Summit, which can help prevent confrontations in disputed waters.

In leading efforts to finalise the South China Sea Code of Conduct, Malaysia must ensure it is pragmatic and enforceable, featuring clear dispute resolution procedures, resource-sharing guidelines and protocols to de-escalate incidents.

By harnessing its balanced relations with major powers, Malaysia can mediate tensions through confidence-building measures, including joint naval exercises focused on humanitarian assistance and disaster relief.

These strategies will reinforce stability, uphold international law and help the region avoid becoming a battleground for great-power rivalry.

Advancing economic integration

Malaysia should spearhead Asean's integration through trade diversification by promoting engagement with emerging markets such as BRICS+ and regional blocks like AfCFTA (African Continental Free Trade Area) to reduce reliance on traditional partners.

Malaysia could propose an Asean-BRICS+ roundtable to explore new trade corridors and shared infrastructure investments in nonrenewable and renewable energy, logistics and digital connectivity. Concurrently, forging new educational partnerships in science, particularly in quantum and nuclear physics, would futureproof regional innovation.

Building on the Regional Comprehensive Economic Partnership, Malaysia can push for sector-specific free trade agreements that expand global markets for Asean small and medium

Another priority is strengthening supply chains through better cross-border infrastructure and robust digital systems. Rolling out a uniform digital platform for trade facilitation (for example, blockchain-based eROO) would reduce crossborder inefficiencies and enhance reliability.

To secure staple commodities, an "Asean Strategic Reserve Alliance" can be proposed to leverage real-time data in managing stocks, sourcing and logistics of staple food-chain commodities and other industrial inputs to boost regional resilience against global shocks. Finally, a unified Asean digital framework can

be initiated to harness AI, IoT and blockchain, For example, harmonising e-commerce regulations and digital taxation can foster fair competition and protect consumers.

Creating an Asean-wide digital sandbox would test cross-border applications in fintech, e-health and agritech, thereby accelerating research and development and skills transfer. Through these efforts, Asean can solidify its standing as a global leader in the digital economy.

Timor-Leste's membership

To ensure a smooth transition for Timor-Leste's membership in Asean, Malaysia can lead capacity-building efforts by helping align Timor-Leste's policies with existing frameworks while supporting socioeconomic development. This includes fostering technical and policy integration through specialised training programmes and encouraging Malaysian industries to invest in key sectors, such as agriculture and energy.

Jimmy Carter – an honest president

THE late Jimmy Carter was an exemplary man. His honesty, modesty and good work set the mark for what American presidents should be like. He was the quintessential Christian gentleman and a fine naval officer.
Unfortunately, this good man got embroiled

in America's colonial misadventures more often than the social welfare projects and peace plans that he sought to pursue. Chief among these thorny problems was the Mideast – no place for a decent, honest man - and the ugly imbroglio

Carter directed and took credit for his administration's flagship foreign policy effort, the much-ballyhooed Camp David Accords, a series of agreements that were supposed to end Arab-Israeli hostility, bring peace to the Mideast and address the festering problem of millions of homeless Palestinians who had been driven from their ancestral homes by the US-backed creation of the state of Israel.

Long, torturous negotiations ensued in September 1978 at Camp David, Maryland that finally brought together Palestine Liberation chief Yasser Arafat and Israeli prime minister Menachem Begin. With great fanfare, an agreement was proclaimed for Israel, PLO (Palestine Liberation Organisation) and Egypt to recognise one another.

The Palestinians of the Israeli-occupied West Bank and Gaza were promised autonomy. Egypt was given US\$1.3 billion (RM5.85 billion) by the US; Israel was given US\$3 billion annually. All sorts of diplomatic and military goodies were offered. Peace was about to

However, the dawn never came. Egypt's then ruler. Anwar Sadat, took the American cash and supported Israel's plan to pack Palestinian refugees into the open-air Gaza prison. Sadat and Begin were awarded the Nobel Prize.

It was claimed that Sadat had been on the CIA payroll since the early 1950s. My journalist mother, Nexhmie Zaimi, interviewed Sadat and described him as "a clown". But a clever clown. Most Egyptians viewed Sadat as a traitor.

of Palestinians, Carter wrote a book, *Peace not Apartheid* that accused Israel of South African apartheid behaviour towards Palestinians

Predictably, he was blasted by a tsunami of vitriol by pro-Israel groups and accused of "antisemitism". In the media, the loveable, avuncular Carter quickly became a hate figure.

In 2020, the then (Donald) Trump administration cobbled together a "deal" known as the Abraham Accords, that paid off despotic Arab regimes like the United Arab Emirates, Bahrain, Morocco and basket case Sudan to make nice to Israel.

It was a sleazy compact deal worthy of New York real estate promoters or gang chiefs. All the members, Sudan excepted, were scared to death of Iran. Morocco's king was given a US imprimatur for his illegal annexation of

Syria would not join this sell-out and was marked for regime change. Israel said all was ok until the mass eruption in Gaza began. Of all the Arab states, only dirt-poor Yemen acted to show support for the besieged Palestinians in Gaza.

In Washington, an addlepated President Joe Biden let Israel and its American neocon fifth column take over his government and lay waste to Gaza. Many longed for the days of honest Jimmy Carter.

done to improve the education of persons with disabilities (PWDs), with increased allocations in Budget 2025, more needs to be done in terms of specialist teachers, upgraded infrastructure, quality of teaching and curriculum, and focus individualised education plan (IEP) for each child. M importantly there is a need to ATION MAN IN

engage with parents and the community for the overall betterment of the special needs child or adult.

As the mother of a

special needs adult daughter, who is now 34 years of age, and working as an assistant teacher, it continues to be a cause of that continues to lag behind other neighbouring countries in its ability to provide the level of education and training required for special needs.

Based on current information, as

of September 2019 there are 85,574 special education needs (SEN) students registered in Malaysia, of whom 68,874 students are in the Special Education Integrated Programme (SEIP), which covers mainstream schools with special needs classes. The breakdown also revealed 967 in preschool, 38,710 in primary schools and 29,197 students in secondary schools.

These numbers refer to parents who have registered their children in government special education classes, but there is a growing

number of parents, whose numbers remain
unknown, who have
chosen to enrol their
special needs children, diagnosed as autistic, slow learners, dyspraxic, dyslexic, ADHD, Down syndrome and a variety of other known learning

disabilities in private special needs centres or non-governmental organisations (NGOs).

Due to the government's inability to provide for the education of PWDs the same standard as normal children, many parents of PWDs seek private special schools or NGO centres to provide for the educational needs of their children and adults.

The cost is high and many parents feel not enough has been done to

lessen their financial burden.

There is also the problem of overcrowded classrooms, due to lack of teachers and many parents have described the classes as more of baby sitting as teachers are unable to cope with the more difficult behaviours.

accepted that learning disabilities have an impact on 4-6%

of the population and Malaysia with a current population of 35 million reveals a figure of 2,100,000 PWDs. Only a fraction are registered at government schools, an unknown number in private schools, while many, possibly in rural and nonurban areas remain at home.

Lack of specialist trained teachers

Raaginee Shalesh, who founded a special needs private learning centre in 2004, Pusat Jagaan and Latihan Insan Istimewa, located in Subang which today has 12 teachers and 150 students ranging in age from 9 to 38 years, feels parent dissatisfaction with government funded special education schools can be tacked with structural

changes.
"There is a lack of trained professionals, whether speech ecialist teachers, therapists and therapists, specialist occupation psychologists trained in behaviour management.

"While there are many high functioning special needs, there is an equal number of low functioning PWDs who need early intervention and an IEP while they are in primary school but the teachers in government schools are not trained to provide that kind of specialist training, and by the time they reach a certain age, they will not respond to any form of intervention," said Raaginee who also runs community programmes in sports such as futsal for PWDs."

Raaginee revealed that many parents are disappointed with the lack of updated resources needed for teaching and learning such as computers and gadgets that can aphance learning at a faster needed. enhance learning at a faster pace.

"Most of the special needs children are also lumped into one classroom and parents feel there is not only insufficient teachers but each of their children have different learning disabilities and cannot be taught in the same way-again the lack of an IEP," she shared.

Outdated ineffective and curriculum

The current curriculum is outdated and not tailored to address the diverse spectrum of curriculum needed for special needs and their

developmental changes. There is a lack of teaching resources in terms of learning tools needed to match an advanced curriculum for those who need it.

Parents' involvement and input

For the child to progress in special education classes, the teachers need to involve parents and provide reports on how to work with the child or adult at home but this is lacking due to insufficient teachers.

The biggest challenge is lack of a comprehensive, individualised approach to education for children and adults with special needs. The one-size-fits-all approach fails to address the diverse needs of special needs education.

Not many parents have the money or resources to provide private special needs therapy or even enrol in private centres.

It is time for the government to

take cognisance of the need to not only provide classes but also ensure that the PWDs are provided the tools that will allow them to transition to working adults and be an asset in society.

The shares are allocated for the Malaysian public via balloting (60 million), eligible directors, employees, and contributors to the group's

(20 million), placement to selected investors (88.1 million) and private placement to Bumiputera investors approved by the Investment, Trade, and

Industry Ministry (250 million). Based on the IPO price of 44 sen per share. Oriental Kopi's market capitalisation is estimated at RM880 million upon listing. Applications for the public issue opened yesterday and will close on Jan 10, with the listing scheduled for Jan 23.

Oriental Kopi executive director

Sean Koay Song Leng disclosed that the company is constructing a 108,448 square foot facility in Puchong, Selangor which will house the new head office, central kitchen and warehouse.

"This centralised facility will streamline our management functions, optimise F&B operations and enhance storage and distribution efficiency. It will also help alleviate the kitchen workload at our outlets, especially those with limited kitchen space," he said in a press conference following the prospectus launch.

Koay said the central kitchen will handle food production, while final preparation will still occur at the outlet kitchens.

Foreign investors also maintained their selling momentum, recording a net outflow of RM427.1 million last week. This extended their selling streak to 11 consecutive weeks, the longest of last year.

The net selling occurred during three of the four trading days in the shortened week, as the market was closed on Wednesday for the New Year's holiday.

The heaviest outflows were seen on Friday (RM423.8 million), followed by Thursday (RM55.8 million). Inflows were recorded on Monday (RM570,000) and Tuesday (RM11.2

"The sectors that saw the highest net foreign inflows were property (RM115.7 million), utilities (RM36.8 million), and consumer products and services (RM29 million).
"Meanwhile, the top sectors with the highest net foreign outflows were construction

(RM89.3 million), financial services (RM45.8 million), and plantation (RM45.5 million)," MIDF added. - Bernama

Foxconn posts record Q4 revenue on AI demand

TAIPEI: Taiwan's Foxconn, the world's largest contract electronics maker, beat expectations to post its highest-ever revenue for the fourth

quarter on continued strong demand for artificial intelligence (AI) servers. Revenue for Apple's biggest iPhone assembler jumped 15.2% to T\$2.13 trillion (RM292 billion), Foxconn said in a statement on Sunday.
It was also ahead of a T\$2.1 trillion

LSEG SmartEstimate, which gives greater weight to forecasts from analysts who are more consistently

Robust AI server demand led to Robust Al server demand led to strong revenue growth for its cloud and networking products division, said Foxconn, whose customers include Al chip firm Nvidia.

For smart consumer electronics, which includes iPhones, there was

"roughly flattish" year-on-year growth, it said.

Total revenue in December alone reached T\$654.8 billion, up 42.3% year on year and the second-highest ever level for the month.

"In the first quarter of 2025, overall operations have gradually entered the traditional off-season," Foxconn said of

its outlook for the current quarter.
"Even with record high revenue

HANOI: Vietnam's economy expanded 7.09% last year to US\$476.3 billion (RM2.1 trillion). faster than the 5.05% expansion in 2023, driven by strong exports and robust foreign investment inflows, government data showed yesterday.

Gross domestic product grew 7.55% in the

fourth quarter, the fastest quarterly growth in more than two years, the General Statistics Office (GSO) said in a report.

The Southeast Asian country, a regional manufacturing hub, has benefited from a recovery in global consumption despite being

badly affected by Asia's strongest typhoon last

"This is a positive result amid difficulties including natural disasters and is a good foundation for 2025 growth," Nguyen Thi Huong, head of the GSO, said at a press

Exports in 2024 grew 14.3% from a year earlier to US\$405.53 billion, led by shipments of electronics, smartphones, clothing and farm produce, the report said.

Imports grew 16.7% to US\$380.76 billion in

2024, resulting in a trade surplus of US\$24.77

The strong rebound in growth was also helped by the government increasing coal imports for power generation to avoid a repeat of the electricity shortages of previous years.
Coal imports in 2024 rose 24.8% from a year

earlier to 63.8 million metric tonnes, while electricity output in the year rose 9.6% to 293.3 billion kilowatt hours.

Foreign investment inflows into Vietnam

rose 9.4% last year to U\$\$25.35 billion.

Average consumer prices in 2024 were up 3.63% while industrial production output rose

Indonesia's Bulog aims to procure 3 million tonnes of domestic rice

JAKARTA: Indonesia's state food procurement company Bulog has more than doubled its domestic rice procurement target for this year to three million tonnes from 1.27 million tonnes in 2024, Bulog data showed yesterday.

The senior minister overseeing food affairs, Zulkifli Hasan, has said that Indonesia will not

import rice this year after buying in more than 3.7 million tonnes in 2024.

"We will optimise domestic procurement during the peak harvest in March to May so that the procurement target ... can be achieved," Bulog official Yayat Hidayat told a weekly inflation Zulkifli said the government will raise its purchase price for unhusked rice by 500 rupiah to 6,500 rupiah (RM1.80) a kilogramme from Jan

Indonesia's 2025 rice output is estimated to rise to 32.8 million tonnes from an estimated 30.34 million tonnes last year. - Reuters

China's central bank outlines 'moderately loose' monetary policy

BEIJING: China's central bank has outlined a "moderately loose" monetary plan aimed at boosting domestic demand to spur growth, days after President XI Jinping called for more proactive macroeconomic

Beijing last year struggled to lift the economy out of a slump fuelled by a property market crisis, weak consumption and soaring government debt.

Officials have unveiled measures aimed at bolstering growth, including cutting interest rates and easing homebuying restrictions, but economists have warned more direct stimulus may still be needed.

The People's Bank of China (PBoC) said in a statement it will "implement a moderately loose monetary policy ... to create a good monetary and financial environment for promoting sustained economic recovery".

The statement reiterated plans to cut interest rates and the reserve requirement ratio which dictates how much banks must hold in their coffers, rather than lending investina

It said the changes would be made "at an appropriate time" depending on conditions at home and abroad.

The PBoC emphasised the need to weed out corruption – signalling the continuation of a long-running crackdown in China's finance industry.

The central bank also said it would continue to help local governments resolve debt burdens with "financial support".

The measures are to "prevent and resolve financial risks in key areas, further deepen financial reform and high-level opening up, focus on expanding domestic demand stabilising expectations, and stimulating vitality", the statement

said.
The central bank's announcement came after officials convened for a two-day conference in the capital.

Beijing was aiming for growth of around 5% in 2024, a goal Xi has expressed confidence in achieving but which many economists believe will be narrowly missed.

The International Monetary Fund expects China's economy to have grown by 4.8% in 2024 and to grow 4.5% in 2025. – AFP

New car sales rise to five-year high in America

GM maintains crown with 2.7 million vehicles sold, Stellantis and Tesla face challenges

DETROIT: US new-car sales in 2024 continued to rise from their pandemic lows, bolstered by replenished inventories, higher incentives and surging demand for hybrid vehicles, automakers

reported.
Sales of new vehicles finished at 15.9 million last year, according to Wards Intelligence, up 2.2% from the prior year, and the highest since 2019.

Automakers are projecting strong sales will continue into 2025, although President-elect Donald Trump's proposed automotive policies, such as removing tax credits for EVs, present a wild card.

wild card.
"We're carrying significant momentum into 2025," Rory Harvey, GM's head of global markets, said in a release.

The Detroit automaker defended its 2023

crown as the biggest US carmaker by sales, selling 2.7 million vehicles last year, the company said, up 4.3% from 2023.

Most automakers recorded solid sales results last year, as they adjusted to slowing demand for EVs and relied on their core business of gasoline-powered trucks and SUVs, while some capitalized on soaring consumer interest in hybrid vehicles.

Sales of traditional hybrids increased 36.7% in 2024 compared with the previous year, Wards

reported.

Toyota notched a 3.7% sales gain year-over-year in the US, boosted by steady increases of reliable smaller vehicles such as the Camry and RAV4 SUV, as well as significant gains for hybrid vehicles.

Reuters reported last year that the automaker

is potentially converting all of its lineup into hybrid-only models.

"For hybrids, we're sold out - customers want them, we can't get enough of them," said David Christ, head of sales and marketing for Toyota in

"Battery electric vehicles, even with the huge incentives we're spending and the federal government's incentives, are just not as in

Ford Motor also benefited from an increase in hybrid sales, which helped the automaker's total vehicle sales rise 4.2% in 2024.

The Dearborn, Michigan, company sold roughly double the number of hybrids compared with its EVs, with 187,426 hybrids sold and 97,865 EVs.

Automakers have axed or changed lofty EV plans laid out when demand seemed much stronger than it turned out to be, but they are still aiming to attract new EV buyers.

Ford said in an effort to support EV sales, which were up 34.8% for the automaker in 2024, it would extend a programme where EV buyers receive free chargers and installation at home through the end of March.

US sales of electric vehicles are expected to approach 1.3 million, or about 8% of all new

whicles purchased, Cox Automotive said.

Buyers' willingness to go electric crept up slightly from 2023, when US drivers bought 1.2 million EVs, comprising 7.6% of all sales, Cox

The Trump administration's plans would likely affect auto sales in 2025 and beyond, if the incoming president makes good on plans to roll a US\$7,500 consumer tax credit on some EVs. as well as increase tariffs on imports from Mexico and Canada.

"If you take true demand for the car and you eliminate the US\$7,500 benefit ... it's really going to change who wants them and how they buy them. So we're preparing for that," Christ said.

Jeep maker Stellantis and electric vehicle giant Tesla were the outliers last year, recording

slipping sales compared with 2023.
Stellantis had a particularly rocky 2024, selling 15% fewer vehicles in the US compared with 2023, and recording decreases across its popular Ram, Jeep and Dodge brands.

The French-Italian automaker grappled with fallout from an aggressive pricing strategy that ultimately led to the abrupt departure of former CEO Carlos Tavares.

Tesla has faced slowing sales as its lineup grows stale and competition in China intensifies, eating in to an important market for the company run by Elon Musk.

The EV giant reported a rare decrease in yearly deliveries last Thursday. – Reuters

Japan PM calls for clarity on steel deal security concerns

TOKYO: Japan's prime minister called for clarity yesterday on why US President Joe Biden blocked a US\$14.9 billion (RM67 billion) deal for Nippon Steel to buy US Steel, warning the decision could hit investments

Biden's announcement last week cited a strategic need to protect domestic industry, a move that drew sharp criticism from both companies and Tokyo.

"They need to be able to explain clearly why there is a national security concern, or else further discussions on the matter will not work," Prime Minister Shigeru Ishiba told reporters.

A US government panel failed to reach consensus last month on whether the acquisition threatened national security – shifting the decision to Biden in the waning days

of his presidency.
Ishiba said that the veteran Democrat's decision had sparked concerns over future Japanese investments in the world's largest

"It is unfortunately true that there are

concerns being raised within Japan's industrial world over future Japan-US investment," he said.

"It's something we have to take seriously," he said

Japan and the United States are each other's top foreign investors.

"It would be inappropriate for the Japanese

government to comment on the management of an individual company that was under review as per US domestic law, so we will refrain from commenting, but we will strongly call on the US government to take steps to dispel

these concerns," said Ishiba.

Biden's decision, less than three weeks before he leaves office, followed extended wrangling over competing domestic political,

reconomic and trade demands.

The outgoing president – who made the rebuilding of the US manufacturing base a major goal of his administration – had criticised the deal for months, while holding off on a move that could hurt ties with Tokyo

"This acquisition would place one of America's largest steel producers under foreign control and create risk for our national security and our critical supply chains," Biden said in a statement on Friday

"That is why I am taking action to block this

The United Steelworkers union quickly welcomed the announcement, describing it as "bold action to maintain a strong domestic

But Nippon Steel and US Steel said the outcome reflected "a clear violation of due process and the law".

Nippon Steel had touted the takeover as a

lifeline for a US company that is long past its heyday, but opponents warned that the Japanese owners would slash jobs.

The decision to block the deal enjoyed rare bipartisan agreement in Washington.

Republican President-elect Donald Trump and incoming vice-president JD Vance have also campaigned against the sale. - AFP

Fed policymakers say job not done on inflation

WASHINGTON: Two Federal Reserve washington: two Federal Reserve policymakers said they feel the US central bank's job on taming inflation is not yet done, but also signalled they do not want to risk damaging the labour market as they

try to finish that job.

The remarks, from governor Adriana
Kugler and San Francisco Fed president Mary Daly, highlight the delicate balancing act facing US central bankers this year as

they look to slow their pace of rate-cutting. The Fed lowered short-term rates by a full percentage point last year, to a current range of 4.25%-4.50%. Inflation by the Fed's preferred measure

is well down from its mid-2022 peak of around 7%, registering 2.4% in November. Still that is above the Fed's 2% goal, and

in December policymakers projected slower progress toward that goal than they had earlier anticipated.

"We are fully aware that we are not there yet — no one is popping champagne anywhere," Kugler said at the annual American Economic Association conference in San Francisco

"And at the same time ... we want the unemployment rate to stay where it is" and not increase rapidly, she said. In November, unemployment was 4.2%,

Investment in Al has surged since OpenAl launched ChatGPT in 2022, as companies across sectors seek to integrate artificial intelligence into their products and services

Al requires enormous computing power, pushing demand for specialised data centres that enable tech companies to link thousands of chips together in clusters.

Microsoft has been investing billions to enhance its Al infrastructure and broaden its data-centre network.

Analysts expect Microsoft's fiscal 2025

capital expenditure including capital leases to be US\$84.24 billion, according to Visible

Alpha.

The company's capital expenditure in the first quarter of fiscal 2025 rose 5.3% to US\$20 billion.

As OpenAl's primary backer, the tech giant is considered a leading contender among Big Tech companies in the Al race due to its explicit on a partnership with the All. due to its exclusive partnership with the Al chatbot maker.

EV sales hit record in UK but still behind target

LONDON: The UK car industry sold a record number of all-electric vehicles in 2024 but still fell short of the government's mandated targets, an industry trade body

Battery electric vehicles made up 19.6% of new cars sold last year, the Society of Motor Manufacturers and Traders, which was below the government's 22%

target for carmakers.

The SMMT reported a "record annual volume" of 382,000 battery electric vehicles sold in the UK last

The automobile trade body had already warned in October that carmakers were at risk of missing government targets, with manufacturers facing government penalties of £15,000 (RM84,000) polluting vehicle sold above the limits.

However, the government has since assured that it expects all manufacturers to avoid the penalties in 2024 by taking advantage of flexibility mechanisms that will take into account, among

other things, emissions reductions across the whole fleet. The group's CEO Mike Hawes said that while the market share of electric vehicles grew, this came at a "huge cost" to the industry.

The chief executive referred to the "billions invested in new models" supplemented by "unsustainable" incentives provided by the industry.

Hawes urged the government to review the mandate and to do more to stimulate private demand. including improving charging

infrastructure.

The SMMT also warned that reaching the thresholds in 2025 will be "even more intense" with the mandates pushed up to 28 percent of cars sold.

There are also concerns over the Labour government's pledge to bring forward the ban on the sale of new petrol and diesel vehicles to 2030, after the previous Conservative government pushed it back to 2035. – AFP

New York-based Shutterstock is a global platform for licensing a diverse collection of 3D models, videos, music, photographs, vectors, and illustrations.

It includes brands such as Giphy, which it acquired in 2023.

Number of employed Germans reaches new high

BERLIN: There were roughly 46.1 million people employed in Germany in 2024 on an annual average, the highest number since Germar reunification, the statistics office said.

The average number of people in employment in 2024 rose by 72,000 on the previous year, the statistics office

With the exception of the pandemic year of 2020, the number of employed

has risen consistently since 2006. However, the pace of employment growth has slowed considerably since mid-2022, the office said.

The increase of 72,000 people nployed in 2024 follows larger rises of 622,000 in 2022 and 336,000 in 2023, data from the statistics office showed.

As in previous years, employment growth in 2024 was due to the immigration of foreign workers and the higher labour force participation of the domestic population.

According to the statistics office, these two contributions offset the dampening effects of demographic

The service sector was the only contributor to the increase in the total number of people in employment in 2024, with 75.5% of all employed working in this sector.

In industry, the number of employed fell by 50,000 and the

number of workers in construction industry fell by 28,000, data from the statistics office showed. - Reuters

He said across Asia, caution prevailed, driven by fears that President-elect Donald Trump's proposed policies, including significant increases in tariffs on imports from China and other countries, could hinder growth in a region heavily reliant on trade. "Locally, these concerns were exacerbated by mixed

"Locally, these concerns were exacerbated by mixed performances in regional markets," he told Bernama.

Strong demand lowers Malaysian govt bond yields

KUALA LUMPUR: Malaysian Government Securities (MGS) and Government Investment Issues (GII) yields trended lower last week, ranging from -3.7 to -0.2 basis points (hps)

The 10-year MGS edged down by 0.2 bps to 3.82%, while the 10-year GII dropped by 0.9 bps to 3.831%.

year Gll dropped by 0.9 bps to 3.831%. Kenanga Investment Bank Bhd said the key driver was the slight decline in the 10-year MGS yield, which reflected steady domestic demand amid optimism around Malaysia's economic outlook.

"Also, some foreign investors turned to Malaysia's shorter-dated bonds, drawn by attractive yields amid year-end saturation in the US bond market.

"However, RM1.2 billion in foreign outflows was recorded due to strong US labour market data and renewed uncertainty tied to Trump's return to power. Locally, weak PMI data added pressure, dampening sentiment in the bond market," Kenanga said in a report.

On the flows and yields outlook, Kenanga said the domestic yields will likely rise next week as markets react to the upcoming US in his report

"This could further see outflows of bond portfolio funds. Based on preliminary data, combined outflows from bond and equities in December totalled RM4.3 billion, reflecting persistent risk aversion from foreign funds.

"Nevertheless, stable domestic indicators including labour market data, industrial production, and retail sales, could temper the increase in yields if they meet or exceed anticipated," Kenanga said.

Despite the cautious outlook, Malaysia's bond market remains supported by resilient domestic fundamentals and favourable economic indicators

Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid noted that the ringgit has continued to depreciate against the greenback as the US economy continues to show improvement, cementing a hawkish US interest rate outlook this year.

"The latest print of the US ISM Index for the manufacturing sector rose to 49.3 points in December, marking its second consecutive month of improvement. A strong US economy would mean the Fed would have little incentive to ease its monetary policy further, especially when there is a risk of higher inflation due to policy adjustments by the incoming US administration," he told Remana.

The ringgit closed mostly lower against other major currencies. It strengthened versus the Japanese yen to 2.8583/8614 from Friday's close of 2.8606/8643 but weakened against the British pound to 5.6250/6306 from 5.5800/5869 and fell vis-a-vis the euro to 4.6695/6742 from 4.6288/6345.




DEMAND growth to remain strong in 2025. Electricity demand growth for 2025 has yet to be disclosed. However, TENAGA has raised its guidance for 2024 demand growth to 5.8–6.3%, compared to the 1.7% embedded in the IBR mechanism for RP3. This projection, exceeding the country's GDP growth forecast of 4.8-5–3% (as revealed in Budget 2025), is notable, as electricity demand growth has historically lagged behind GDP growth since the 2000s. 

THE uptrend in the construction sector is expected to persist through 2025, driven by a robust pipeline of infrastructure and data centre projects. Several delayed public infrastructure projects are anticipated to commence soon, while data centre projects remain strong in the near term, with 7,200MW of data centre opportunities projected by 2035. This growth is supported by major tech giants and data centre operators making Malaysia as a key hub for their operations.

According to the Construction Industry Development Board (CIDB), a total of RM185.1 billion in main contractor construction contracts were awarded YTD as of end-November 2024, surpassing the total contract awards of RM152.8 billion in 2023. However, this was still 23% below the previous upcycle record of RM241 billion in 2016 which included the lumpy East Coast Rail Link).

2024 has been a relatively slow year for public project rollouts. The MRT3 underwent a three-month public inspection from October to December, and construction is expected to begin in 2026, with the entire line anticipated to be fully operational by 2032. If this timeline materializes, we believe 2025 could surpass the 2016 peak for contract awards. The Penang LRT Mutiara Line is still pending final negotiations between the SRS Consortium and MRT Corp. Other major projects in the pipeline include the Penang Airport expansion, the second phases of the Pan Borneo Highway and Sabah-Sarawak Link Road, and the Subang Airport redevelopment plan. We view the high-profile KL-Singapore High-Speed Rail as a medium-term prospect. Additionally, the Johor-Singapore Special Economic Zone presents significant opportunities for the sector. – Kenanga Research, Jan 6

Technology Overweight



DESPITE various trade concerns over the heightening trade tension, the year of 2025 is touted to be a time of technology breakthrough, which will see many opportunities to invest, innovate and develop. We believe Artificial Intelligence (AI) remains at the forefront of key topics as did cybersecurity, cloud computing, and robotics. We also gather that some local ATE makers have started receiving more inquiries in the last 2 months, although the outlook visibility remains short.

Electric vehicle sales in China are set to eclipse the sale of traditional vehicles for the first time this year as domestic EV sales are projected to grow 20% YoY to more than 12m. The projections, which include sales for both pure EVs and plug-in hybrids, offer a stark contrast to the outlook for internal combustion engine vehicle sales, which are expected to fall by over 10% to less than 11 million cars in the coming year.

According to Techinsights, China will continue to assert its

According to Techinsights, China will continue to assert its dominance in shaping global automotive trends. As the epicenter of innovation in vehicle architecture, the country's influence is reshaping how cars are designed and built worldwide. Secondly, the transition to sustainable mobility is gaining momentum. Battery electric vehicles are poised for significant growth, driven by stricter environmental regulations and consumer demand for greener alternatives. Thirdly, the adoption of Level 2 automated driving systems, offering features like lane centering and adaptive cruise control, is reaching a tipping point. Fourth, Al technologies are transforming in-vehicle experiences from voice assistants to advanced driver monitoring systems, Al making the cockpit smarter, safer, and more personalised. Lastly, the supply chain disruptions that defined the past few years are easing, as inventory levels stabilise, manufacturers and suppliers can refocus on innovation and strategic planning. – PublicInvest Research, Jan 6







Tourists return to post-Olympic Paris for holiday magic

HOLIDAYMAKERS are returning to Paris for the winter holiday magic as the tourism industry rebounds, inspired by the Paris Olympic Games and re-opening of Notre

"This year, there is much more tourism than last time I came here," said Noemi Rizzato, a tourist from Milan who braved the cold to visit the Place du Trocadero on the Right Bank of Paris, bundled up in her down jacket. Georges Bardot, a 78-year-old

pensioner from eastern France, also pointed to large numbers of foreign tourists amid the holiday hustle and bustle in the City of

Light.

"We heard every language except French spoken on the metro," Bardot laughed.

This winter, Parisian hotels are experiencing a surge in demand. The booking rate for two-week Christmas vacations neared 70% in mid-December, nine percentage points higher than a year ago, according to data from MKG Consulting.

Top establishments are doing

particularly well, with an increase of nearly 14 percentage points

over one year.

According to the UMIH hotel and restaurant union, well-heeled international customers are making a comeback. UMIH president (Paris) Frank

Delvau pointed to an "Olympic

The Games have made tourists want to come back, or to visit, he

Tourism professionals said the world's largest sporting event led to a lacklustre summer in Paris.

Wealthy Parisians fled the capital for the summer and many foreign holidaymakers chose to stay away due to transport aridlock crackdown. Hotels and airlines such as Air France saw a drop in bookings while taxi drivers and restaurant owners said their businesses had been badly affected.

With five billion viewers, the Paris Games were the most followed Games in television and social media history, according to International Olympic Committee.

"We needed this catch-up "We needed this catch-up effect because the situation was very difficult in the third quarter. "There was a sharp fall in visitor numbers. The restaurant

business was down 40%, 50% at times," Delvau said.

From Nov 1 to Dec 8 last year, international air arrivals to Paris rose by 15.4% compared with 2023, reaching 1.3 million, according to the Paris Tourist Office

On the Ile de la Cite, the island site of the cathedral, shopkeepers eagerly await the return of visitors after five years of reconstruction work as well as the coronavirus lockdowns that saw a drop in tourist numbers.

"Notre Dame opening this year was the biggest item on our list. "And we did visit Notre Dame,

Medici secret passageway in Florence reopens

A SECRET passageway built 500 years ago to allow the Medici family to pass through Florence, Italy unhindered reopened to the public last month after a 10 million euro (RM46 million) restoration.

The Vasari Corridor, which is more than 700m and runs above the famous Ponte Vecchio, has been closed for eight years.

Designed in 1565 by Giorgio Vasari, a commission by Duke Cosimo I to mark his son's wedding, the corridor begins at what is now the Uffizi Galleries and ends up in the Pitti Palace across the Arno river. Its 73 windows offer unrivalled views

over the city centre, a Unesco World Heritage site, and will now be accessible to the masses.

Since the 1970s, it has held a large collection of the Uffizi's self-portraits but was closed in 2016 to allow for upgrades

"Now restored to its original simplicity, the corridor presents itself to visitors as a plain 'aerial tunnel," the Uffizi

said in a statement.

It passes above the heart of the city, just as it appeared when the Florentine rulers used it for quick, safe and uninterrupted passage between their residence and the seat of government,

"They're an incredibly tough team and the margins were very small. I feel that it could have gone either way. "I want to thank my team, unbelievable support. The vibes all week were amazing. "That's one of the things that makes our team so great and one of the reasons why we've been able to do so well. We've just really come together. It's amazing."

Injured Osaka 'very optimistic'

NAOMI OSAKA will undergo a scan on the injury that forced her to pull out of the Auckland Classic final but remains optimistic about playing at the Australian Open, the former world No. 1 said yesterday. Osaka, the 2019 and 2021 champion at Melbourne Park, was reduced to tears on Sunday when an abdominal injury forced her to quit while leading Clara Tauson 6-4 in her first WTA final in almost three years. "I'm having an MRI today to assess," the 27-year-old said in a brief statement. "I don't feel that it's too serious and I still feel very optimistic about AO." Osaka, who returned to the tour a year ago after a long maternity break, had shown glimpses of the form that won her four major titles on her run to the final in Auckland She broke back into the top 50 in the world rankings on Monday. The Australian Open begins on Sunday.

Melbourne airport still gives Djokovic the jitters

NOVAK DJOKOVIC has admitted to still getting stressed when he gets off a plane at Melbourne airport after he was deported from Australia three years ago. The 24-times Grand Slam champion had his visa cancelled ahead of the 2022 Australian Open following days of drama over Australia's Covid entry rules and his unvaccinated status."I have to be quite frank," Djokovic said in an interview with Melbourne's Herald Sun newspaper. "The last couple of times I landed in Australia, to go through passport control and immigration – I had a bit of trauma from three years ago. And some traces still stay there when I'm passing passport control, just checking out if someone from immigration zone is approaching. The person checking my passport – are they going to take me, detain me again or let me go? I must admit I have that feeling."

*IDEKI MATSUYAMA broke the 72-hole PGA Tour tournament scoring record yesterday, firing an 8-under 65 to finish on 35-under 257 and win

the Sentry tournament.
The 32-year-old Japanese star outdueled American Collin Morikawa to capture his 20th worldwide title and 11th PGA Tour victory in the 2025 season opener.

Matsuyama sank an eight-foot birdie putt on the par-5 18th hole at the Plantation Course in Kapalua, Hawaii, to take the low-par mark for four rounds.

Australian Cameron Smith had owned the PGA Tour all-time low tournament record with a 34-under 258 on the same layout in

Needing a birdie at the last for the record, and with a secure lead over Morikawa, Matsuyama chipped his third from just off the green, then rolled his final putt straight into the hole, allowing himself a right fist pump of celebration.
"That last putt, it felt like if I

make it, it's going to be the record, so I'm so happy that it went in," Matsuyama said through a translator. Matsuyama, who took a bronze medal at the

Paris Olympics, won for the third time in 12 months after titles at Riviera d n Memphis last year. "I was

Australia set sights on world domination after taming India

CRICKET'S World Test Championship final is still five months away but it is already playing on the mind of Australia skipper Pat Cummins, saying the defence of their title is "a huge goal" after conquering India.

Australia surged into a June showdown against South Africa at Lord's with a six-wicket victory in the fifth Test against India in Sydney

on Sunday.

The thrilling win sealed a first series triumph against their South Asian rivals in a decade.

It also confirmed their place in a clash against South Africa that will determine the world's most consistent red-ball side over the last two years from the nine teams contesting

"To hold the Border-Gavaskar Trophy is an amazing feeling, and the extra layer is now securing a spot again in the World Test Championship final, which was always a huge goal for us in this cycle," Cummins said.

"We talk about the World Test Championship a lot. It's a trophy we're really proud to hold so we want to go back and

"I think it's a great tournament in that you've got to play well consistently and across all different conditions against different

teams. We can't wait to get over there."

South Africa booked their spot under the WTC's average points system when they beat Pakistan in a dramatic two-wicket win at Centurion late last month

Australia play two Tests in Sri Lanka starting later this month before a lengthy redball break heading into the WTC final.

Cummins appears likely to miss the Sri Lanka tour for the birth of his second child, with Steve Smith in pole position to take over

as captain.
But the Australian skipper is adamant that after four year in the role, he has no plans to hand over the armband permanently anytime soon

"First of all, I absolutely love what I do That's the biggest driver in wanting to play Test cricket and work with this team and support staff," Cummins said.

Difficult' to be Vinicius: Ancelotti

REAL MADRID coach Carlo Ancelotti said yesterday it would be "difficult" to be Vinicius Junior after the player was sent off against Valencia.

Late Dembele strike earns PSG French Champions Trophy in Doha

USMANE DEMBELE'S stoppage-time goal settled the French Champions Trophy yesterday, giving Paris Saint-Germain a 1-0 win over Monaco in a fixture played in Doha.

PSG's troubles in front of goal this season

have often cost them in the Champions League, and they were thwarted throughout this game by a combination of poor finishing and some fine saves by Monaco goalkeeper Philipp Koehn.

However, it was ultimately a deserved victory for Luis Enrique's team in Qatar, as PSG won the trophy - the French equivalent of a Super Cup or England's Community Shield - for the 11th time in the last 12 seasons.

"It was a great game between two teams who play good football," said Luis Enrique. "The result is well deserved and reflects our

domination... against one of the best teams in France and in Europe."

This fixture was supposed to be staged in Beijing on Aug 8 as the curtain-raiser to the French campaign.

However, it ended up being called off by the

Chinese authorities, and Qatar - which owns PSG via Qatar Sports Investments - stepped in to stage the game.

It took place at Doha's Stadium 974, which hosted matches at the 2022 World Cup held in Qatar and which was not full for this match.

PSG won a clean sweep of the domestic honours in France last season and were looking to claim the first leg of another treble in this campaign.

A 4-2 win away in Monaco last month, when Dembele scored a double, allowed them to finish 2024 with a 10-point lead at the top of Ligue 1 from both Marseille and the principality

Sze Fei-Nur Izzuddin deserve to be country's top men's doubles pair: Chia

ATIONAL men's doubles shuttler Aaron Chia admits that Goh Sze Fei-Nur Izzuddin Rumsani deserve to be the country's current top combination.

Chia, who partners Soh Wooi Yik, acknowledged that Sze Fei-Nur Izzuddin proved far superior than them following a

stellar 2024 season.
"Whether we are No. 1 or No. 2, we all represent Malaysia. They (Sze Fei-Nur Izzuddin) have performed well recently and it is well-deserved for them (to be ranked as the country's top men's doubles pair)," he told reporters during the 2025 Malaysia Open court testing session yesterday.

Last month, Sze Fei-Nur Izzuddin emerged

as the country's top pair when they surged to third spot from seventh position in the world

rankings while Aaron-Wooi Yik dropped one

spot to sixth place.

This is the first time Aaron-Wooi Yik have been ranked second best in Malaysia since the two-time Olympic Games bronze medallists topped the country's men's doubles ranking

Sze Fei-Nur Izzuddin have risen to become the country's top men's doubles pair following a remarkable run in the Badminton World Federation (BWF) World Tour Finals 2024, where they became the first Malaysian men's doubles pair to reach the final of the seasonfinale before going down 17-21, 21-17, 11-21 to Danes Kim Astrup-Anders Skaarup Rasmussen in Hangzhou, China, last month.

Sze Fei-Nur Izzuddin also bagged three World Tour titles last season, namely the Japan Open (Super 750), China Open (Super 1000)

and Arctic Open (Super 500). As for the 2025 Malaysia Open, which will be held at the Axiata Arena from today until Sunday (Jan 12), Chia said he and Wooi Yik will not underestimate the threat posed by their first-round opponents, Chen Zhi Yi-Presley Smith of the United States.

Top national mixed doubles pair Toh Ee

Wei-Cheng Tang Jie do not plan to put additional pressure on themselves even as

they seek to put a smile on the faces of home fans in the Super 1000 tournament.

Ee Wei-Tang Jie, who described themselves as being "a work in progress", are currently ranked fifth in the world.

The third-seeded Ee Wei-Tang Jie will open their Malaysia Open campaign against the unseeded Hsuan-Yi Wu-Chu Yun Yang of

Xin Yee also named Pearly-Thinaah as her badminton idols, saying she admires the world No. 6 pair's never-say-die attitude. – pair's n Bernama

Man United manager 'really mad' at players after Liverpool draw

UBEN AMORIM wasn't in a joyous mood at fulltime and aimed fire at his players despite Manchester United earning a surprise point against Liverpool

United produced a spirited performance in the 2-2 draw at Anfield, ending a four-match losing streak, and could've stolen three points at the

The Red Devils silenced the Merseyside crowd in the first half and had the better of the chances, with Amad Diallo squandering a header from close range and Rasmus Hojlund fluffing a oneon-one opportunity.

Lisandro Martinez lashed the visitors into a shock lead after the break before Cody Gakpo's curling effort and Mohamed Salah's penalty flipped the game on its head.

But Amad ensured United didn't return to

Manchester empty-handed by producing his latest big-game moment and equalising late in

front of the away fans.

Amorim's side defied the odds by halting Liverpool's relentless charge towards a record-levelling 20th League title after a build-up dominated by the expectation of a definitive

However, the 39-year-old wasn't in a celebratory mood after the final whistle and displayed his elite mentality by admitting he was infuriated by United's failure to replicate yesterday's performance in their recent defeats.

"That should be a big issue for our players that even one person thinks you have the ability but not the character, we have to fight that and change that," Amorim told Sky Sports.

"I think it is really clear. When we are focused, when we fight for every ball, when we suffer, and we are tired when the game is finished, we are a good team.
"If we don't do that all the time, then we are

going to lose games. That is clear to everybody. We controlled the tempo of the game very well.

"Every time Liverpool had a chance, we controlled and had the ball for a moment. That

makes a difference.

makes a difference.

"You could see in the game that it was not like we were not suffering all the time because we controlled the ball, sometimes winning some fouls and controlling the transitions.

"It was a good game. I'm happy for the performance, but I'm not happy for the result. But I'm really, really mad because of the other games."

After going into the game by saying that his players were "afraid" to have the ball, Amorim said his shock theraw, annyage, is designed to

said his shock therapy approach is designed to shake the club out of its malaise.

"I'm trying that (motivation) every day," Amorim said as per *espn.com*. "I'm trying to push this team every day, sometimes it's maybe not the best way.

"I am always challenging these players in everything I do because I feel we are, not just the players, but everybody at Manchester United is too comfortable.

"So I think sometimes we need a shock, and you can see today we were a different team. It was not about the system, it was about the way we faced the competition.
"I think it's a very good sign. It's really clear, we

lost three games in a row at home, some of the

games we suffer two goals without doing nothing."
United had lost five of their past six League games going into the Liverpool clash and now face an FA Cup third-round tie at Arsenal on Sunday (11pm Malaysian time) before returning to Premier League action with a home game

against bottom club Southampton next Friday (4am).

But after being undone by inconsistency

during Amorim's brief time at the club, the former Sporting CP coach is now aiming to avoid another

slump after a big result.

"Of course, not just to the end of the season, is so long, but we had some good games during this last month but then we drop again," Amorim said.

"It's something that we need to be really consistent. We had this talk after against (Manchester) City and it was the same.

"We can talk, but we need to show and do it, and the best thing is tomorrow we have training and we have to maintain the same level of mentality." - Express Newspapers/Agencies
