Judiciary made correct decisions, says chief justice

→ 'Actions guided by no considerations other than law and facts of case within bounds of judicially established principles'

PUTRAJAVA: Chief Justice Tun Tengku Maimun Tuan Mat said she firmly believes that the judiciary under her leadership has made the correct decisions based on the law and facts, regardless of the heated political overtones and undertones that clothed some of the cases before the court.

"This alone should dispel any baseless notion that I have ever been partial to any particular prime minister or any political party," she said in her final speech as chief justice at the Opening of the Legal Year 2025 event yesterday. Tengku Maimun said her six-year tenure saw

Tengku Maimun said her six-year tenure saw four different prime ministers from different political affiliations - Tun Dr Mahathir Mohamad, Tan Sri Muhyiddin Yassin, Datuk Seri Ismail Sabri Yaakob and Datuk Seri Anwar Ibrahim.

She said she had carried the burden, image and overall responsibilities of the judiciary for almost six years, adding that she does not envy the next person who would take over from her.

Tengku Maimun will go on mandatory retirement upon turning 66 in July this year. However, she can remain in office for another six months if the Yang-di-Pertuan Agong grants an extension of her tenure. Bernama reported.

She said following her appointment as the first female chief justice of Malaysia, she was determined to fulfil her oath of office in ensuring

the Federal Constitution reigns supreme.

Tengku Maimun said she was guided by no considerations other than the law and the facts of the case within the bounds of judicially established principles.

"I am here to do my job. I never coveted it,

"I am here to do my job. I never coveted it, but by the Grace of Allah SWT, I was entrusted to lead the judiciary. It is an extremely intimidating position to hold, but upon accepting the appointment, I am fully committed to doing it properly.

"I will not bend or bow to any person no matter low high and mighty to do what he or

"I will not bend or bow to any person no matter how high and mighty, to do what he or she demands of me." Tengku Maimun said she is looking forward

Tengku Maimun said she is looking forward to retirement, believing that she would get to leave the judiciary in a better place than when she and her colleagues had led it

she and her colleagues had led it.
She said she would also relish the chance to spend more time with her grandchildren and deepen her connection to her faith.

New cybercrime Bill to be tabled in October

KUALA LUMPUR: The National Cyber Security Agency (Nacsa) is in the process of drafting a new cybercrime Bill, that is expected to be tabled during the Third Meeting of the Fourth Session of the 15th Parliament in October, said its CEO Dr Megat Zuhairy Megat Tajuddin.

He said the proposed Bill aims to replace the Computer Crimes Act 1997, which is now considerated outdated and less relevant in addressing modern cyber threats.

"A few weeks ago, Prime Minister Datuk Seri

"A few weeks ago, Prime Minister Datuk Seri Anwar Ibrahim expressed support for the drafting of the new Bill in a post on his Facebook page after chairing the second National Cyber Security Committee meeting for 2024.

"We actually wanted to revise the Computer Crimes Act 1997 but I think it is more relevant if we have a new Act," he told Bernama after participating in a dialogue session titled "Regulating for Resillence: Cybersecurity and Critical Infrastructure Protection" at the

International Regulatory Conference 2025 on Tuesday.

Megat Zuhairy said the new Bill is a key requirement for Malaysia to join the Budapest Convention and the United Nations Convention Against Cybercrime in June, both of which are essential to demonstrate the country's commitment to combating cybercrime domestically and internationally.

In a separate dialogue session at the conference, Megat Zuhairy called for urgent action to address the critical shortage of cyber security professionals, highlighting Anwar's target of achieving 25,000 cybersecurity experts by the end of the year.

He stressed the importance of retaining local talent to meet this ambitious goal.

"The industry should offer higher salaries to

"The industry should offer higher salaries to Malaysians and not let them go to Singapore or Dubai

"With a shortage of talent, we are

jeopardising national security in a broader perspective. We need 10,000 talents this year and if the universities manage to produce 3,000 now, half of them would go to other countries like Singapore, Catar and Dubai, that offer a lot more (salary). We have to take a very drastic approach to get more talents."

He also advocated workplace flexibility to encourage more women to enter and remain in the cybersecurity workforce. The dialogue session was moderated by

The dialogue session was moderated by Malaysian Communications and Multimedia Commission (MCMC) chief technical and monitoring officer Che Juhan Che Mat.

"Our thoughts are with the victims, their families and the communities grappling with loss and destruction.

"May they find the strength, courage and support needed to endure and recover during this difficult time."

He also extended Malaysia's support to Nepal, where tremors were also strongly felt, as both nations face the challenges of rebuilding and healing in the aftermath of the calamity.

According to media reports, at least 126 people were killed after the earthquake, with magnitude 7.1, hit Tibet in southern China, near the Nepalese border on Tuesday.

The tremors were also felt in several parts of India, including Bihar, Assam and West Bengal.

Review of strategies to tackle online scams

KUALA LUMPUR: The government will review strategies to deal with the issue of online fraud and implement more effective measures, said Communications Deputy Minister Teo Nie Ching.

She said through the national anti-fraud

She said through the national anti-fraud portal and the cooperation of all stakeholders, the government would continue to take decisive action to combat scams.

"Measures such as the shift from SMS (short message service)-based OTP (one-time password), tightening of authentication rules and the establishment of a special line to report financial fraud have yielded positive results.

"However, there is still much more to be done," she said in a post on her Facebook page.

Teo said the issue of online fraud, which is becoming more prevalent, was discussed during her meeting with Finance Deputy Minister Lim Hui Ying on Tuesday. The meeting was also attended by representatives from the Malaysian Communications and Multimedia Commission and Bank Negara Malaysia.

New monthly tax deduction system

PUTRAJAYA: A new monthly tax deduction system, the e-PCB Plus, will be introduced under one platform through the MyTax portal to replace the existing systems, namely e-PCB, e-Data PCB and eCP39.

The Inland Revenue Board (IRB) said in a statement that this is in line with the implementation of the transition plan towards the e-PCB Plus Phase 1 system on Sept 24 latters.

"Employers are requested to complete the submission of all data and PCB payments for the current month deductions or past year deductions on or before Jan 15."

It said the existing system would only be opened for display purposes to enable employers to review previous information or records.

"Other functions such as charging, calculation and payment will be completely closed. The full implementation of the e-PCB Plus system will be announced before it is officially opened for use by all employers and users."

IRB urged employers who are currently using the e-PCB, e-Data PCB and e-CP39 systems and have not yet registered under the e-PCB Plus system to do so immediately to ensure a smooth transition process. – Bernama

Call to lower allowed alcohol limit for motorists

Expert advocates aligning law with WHO standards to reduce road crashes and fatalities

PETALING JAYA: Universiti Tun Hussein Onn Malaysia Faculty of Engineering Technology senior lecturer Dr Nurrul Hafeezah Sahak has urged authorities to lower Malaysia's legal blood alcohol concentration (BAC) limit from 0.08% to align with the World Health Organisation's (WHO) recommended standard of 0.05%. recommended standard of 0.05%

She explained that the current limit can still impair a motorist's concentration, perception, speed control and short-term memory, contributing to road crashes.

"This figure exceeds WHO's recommendation, which has been shown to reduce road crashes causing death or injury by 18%, demonstrating the potential for significant improvement in drink driving incidents," she said, adding that an intoxicated driver is 13 times more likely to

intoxicated chiver is 13 times more likely to cause a crash than a sober one.

A National Health and Morbidity Survey revealed a decline in alcohol consumption among Malaysians aged 18 and above, dropping from 12.8% in 2011 to 7% in 2022.

However, Kuala Lumpur recorded a significantly higher rate of 12.1%.
"What is alarming is the survey's findings

that over half of the drinkers obtained alcohol

from family members, 65% had their first drink before the age of 14 and 86% have peers who consume alcohol," Nurrul Hafeezah

She highlighted the financial and human costs of road traffic fatalities, estimating an average cost of RM1.2 million per fatality, RM120,000 for severe injuries and RM12,000 for minor ones, factoring in lost productivity

and victim compensation.

"Beyond the financial toll, the human cost is immeasurable, with lives lost and families

Is himmeasurable, with rives lost and failines devastated," she said.

Home Minister Datuk Seri Saifuddin Nasution Ismail reported that between January 2021 and September 2024, 149 drinkdriving cases involving road crashes were prosecuted under Section 44 of the Road

Transport Act 1987.

Convictions for fatal drink-driving incidents carry severe penalties, including 10 to 15 years imprisonment and fines of RM50,000 to RM100,000.

For cases involving injury, offenders face seven to 10 years imprisonment and fines of between RM30,000 and RM50,000.

Nurrul Hafeezah recommended adopting

effective models such as South Korea's chauffeur services, which have significantly reduced traffic fatalities by providing safe transport for intoxicated motorists.

She also advocated the installation of driver-monitoring technologies such as alcohol ignition interlocks, which measure alcohol levels in the driver's breath and prevent the vehicle from starting if

nintoxication is detected.

Nurrul Hafeezah proposed adopting stricter penalties akin to those in Canada, where life imprisonment is enforced, or those adopted in the UK, which imposes up to 14

years' imprisonment with an unlimited fine and penalties in Taiwan, where the death penalty is permitted for fatal drink-driving

She pointed out that while e-hailing services provide alternatives for drinkers, designated driver programmes remain limited, with challenges such as cultural norms, high costs and availability in rural

areas hindering broader adoption.

"Public awareness campaigns play a critical role in reducing drink-driving incidents. In Western countries, large-scale 'Don't Drink and Drive' campaigns are conducted via radio, television, billboards and school programmes, but such initiatives are rare in Malaysia," initiatives

Malaysian Institute of Road Safety Research chairman Prof Dr Wong Shaw Voon stressed that drink driving remains a leading cause of preventable road crashes, with often tragic consequences for drivers, passengers and bystanders.

He highlighted the importance of

addressing drink driving to achieve the United Nations Sustainable Development Goals (SDG), particularly SDG 3.6, which aims to halve road crash fatalities, and SDG 11.2, which promotes safe transport systems

11.2, which promotes safe transport systems by 2030.

"Drinking is a personal choice, but it comes with responsibility. Choosing never to drink and drive is a simple decision that can save countless lives," Wong said.

He also colled for strictory peopletics 24/7.

He also called for stricter penalties, 24/7 road surveillance to deter offenders and collaboration between the beverage industry, local authorities and establishments serving alcohol to encourage responsible drinking practices.

Online systems to streamline criminal case management

PUTRAJAYA: The Attorney-General's Chambers (AGC) has introduced two innovative online systems, Modul Daftar Kertas Siasatan (e-Daftar) and Modul e-Representasi (e-Rep) as part of the government's digital transformation initiative.

Attorney-General Datuk Mohd Dusuki Mokhtar explained that the paperless systems aim to improve efficiency in managing criminal cases by enabling seamless tracking from investigation to verdict.

The systems are equipped with automated alerts to prevent procedural delays.

"These systems include alert features that

notify us via email when the time allocated for specific actions is about to lapse or expire.

"They significantly reduce the time and resources required to manage large volumes of criminal cases, allowing prosecutors to focus on substantive aspects of their work," Mohd Dusuki said in his first speech as attorney-general at the opening of the Legal Year 2025 event held at the Putrajaya International Convention Centre yesterday.

Regarding e-Daftar, Mohd Dusuki said as of early December 2024, the system had recorded 455,170 investigation papers and was being used by 10 states, 161 agencies and 391 deputy public prosecutors.

Plans are underway to expand its use ationwide by the end of the year.
"Meanwhile, e-Rep will replace the manual

for handling representations submitted by lawyers.

"They will receive automatic email notifications and the status of representations can be checked online," he said.

can be checked online; he said.
Additionally, the AGC has initiated the
Case Decision Reporting system, which allows
reports of lower court decisions to be
accessed from any device or location.

Economic zone shows dedication to regional ties

KUALA LUMPUR: The Johor-Singapore Special Economic Zone (JS-SEZ) serves as a testament to Malaysia's dedication to regional integration, especially as the country assumes the Asean chairmanship this year, said Transport Minister Anthony Loke.

Speaking at the CGS International Securities Malaysia Sdn Bhd 17th Annual Malaysia Corporate Day on Tuesday, Loke highlighted that Malaysia's 2025 Asean chairmanship theme "Inclusivity and Sustainability" underscores the nation's commitment to strengthening regional ties.

"Asean's collective gross domestic product is projected to surpass US\$6 trillion (RM26.9 trillion) by 2030, and Malaysia is determined to play a leading role in this growth story," he said.

"Projects such as the JS-SEZ exemplify our commitment to regional integration. By fostering inventions of the SEZ is

innovation and attracting investment, JS-SEZ is set to become a beacon of economic collaboration."

Loke also pointed to initiatives such as the Asean Highway Network and Trans-Asean Gas Pipeline as further evidence of Malaysia's dedication to enhancing regional connectivity and energy security.

"I think one advantage we have in this region is

that we have good neighbours around us," he added.

"There are not many parts of the world where people can live harmoniously and peacefully. Although we may be competing, we are always looking for ways to collaborate and work

Quoting Prime Minister Datuk Seri Anwar Ibrahim and Singapore Prime Minister Lawrence Wong from their joint press conference earlier that day, Loke added that competition is no longer between Asean countries but with the rest of the world.

"We must strengthen ourselves regionally and bolster our position within Asean while increasing business within the region. This is a major growth area and Malaysia is well-positioned to lead this effort, especially as we have just assumed the Asean chairmanship this year," he said.

Loke expressed confidence government's ability to elevate the nation's profile

and play a leadership role in enhancing regional cooperation and collaboration.

During a fireside chat session at the same event, Loke emphasised that logistics is a key pillar of JS-SEZ, aimed at attracting investment and encouraging the relocation of logistics operations from Singapore to Johor.

"Singapore still holds certain advantages with its airports, ports and trading infrastructure. However, I believe many back-end operations can be relocated to Johor. It makes more sense to have bigger warehouses in Johor," he said.

Special tariff for public transport operators

KUALA LUMPUR: The Transport Ministry is proposing a special electricity tariff for the public transport sector to help ease the financial burden on operators.

Transport Minister Anthony Loke explained that current electricity charges for public transport operators are the same as those for businesses, making it financially challenging for the sector to operate sustainably.

"One of the key issues we are addressing at the ministry is advocating a special electricity

"We are considering a special tariff for operators, both public and private, to encourage the growth of public transport," Loke said.

He emphasised that the current charges are prohibitive and that the proposed special tariff could significantly reduce the financial strain on operators. – Bernama



'Open public parks until late to promote healthy lifestyle'

▶ Move would allow those with demanding work schedules to exercise and engage in stress-reducing activities, says specialist

PETALING JAYA: According to a research paper titled "The Growing Threat of Non-Communicable Diseases in Malaysia," the probability of dying from non-communicable diseases is expected to rise to 19.4% this year and 20% by 2030.

The paper, co-authored by Shubash Shander Ganapathy, Chan Yee Mang, Nur Hamizah Nasaruddin, Nazirah Alias, Khaw Wan Fei, Lee Ann Tan and Tham Sin Wan, said the rise is driven by increases in cancer and diabetes deaths, and the high and sustained figures expected in cardiovascular deaths.

Considering this, Universiti Kebangsaan Malaysia public health medicine specialist Prof Dr Sharifa Ezat Wan Puteh has called for public parks to remain open until late at night to cater to the needs of working Malaysians, and address rising health issues caused by lack of exercise.

"Access to public parks for activities such as exercise can reduce stress and lower the risk of heart disease by 33%. It can also decrease the risk of dementia by 30% to 40%.

"For those with demanding work

"For those with demanding work schedules, extending the hours for public parks would provide much-needed opportunities for exercise and relaxation, contributing to better mental and physical health."

Sharifa Ezat said given the high prevalence of non-communicable

diseases in Malaysia, public parks should be open until at least midnight, and equipped with clean and safe amenities such as toilets

and lighting to encourage use.
"While higher-income groups can afford gym memberships or private recreational facilities, those in middle and lower-income brackets, and others with health conditions often rely on public parks as an accessible and free option for carreiros.

"Unfortunately, urban development has led to fewer public parks, forcing many Malaysians to travel long distances for recreational spaces"

spaces."

She said to maintain cleanliness and safety, it is reasonable to introduce nominal fees for park usage or seek corporate sponsorship, with many developed countries having successfully implemented similar models.

Sharifa Ezat also called for improved safety measures such as

CCTV surveillance, adequate lighting, and enforcement to prevent the misuse of parks for illicit activities.

She emphasised that parks in urban and semi-urban areas are particularly suited for extended hours as such spaces are essential for public health, but they must be kept safe and well-maintained.

kept safe and well-maintained.

"It may be costly for the government to manage public parks, but investing in them is akin to investing in people's health.

"Public parks are more than just green spaces. They are vital to our collective health, and by extending their hours, we can foster healthier, happier communities."

Nurse Nor Hidayah Abdul Shamsul, 28, who works shifts, said she only has time to relax or exercise at night.

"Parks are perfect for me because they're free and offer fresh air, but most are already closed by the time I get there. "Stress management is crucial for nurses, and a simple walk or jog in the park helps clear the mind after a long shift. But with the limited hours, I miss out on this simple method to unwind and stay healthy."

Factory supervisor Farhan Malik,
42, said he works long hours and
does not have the energy to work out
early in the morning.
"Late-night walks in the park are

my only way to stay active.

"I'm at an age when staying physically active is crucial. But between work and family commitments, I can only spare time for exercise late in the evening, but the parks are closed by then."

He added that public parks could play a vital role in encouraging fitness for those in his situation as not everyone can afford gym memberships or private facilities.

"If parks were open longer and equipped with good facilities, many working Malaysians, including myself, would benefit greatly."

RM11m allocated for entrepreneur training initiative

PUTRAJAYA: An allocation of RM11 million has been set aside for the implementation of the Urban Community Economic Empowerment Programme 2025, which is expected to benefit 1,060 participants from the B40 group in urban areas.

Housing and Local Government Deputy Minister Datuk Aiman Athirah Sabu said to ensure the success of the programme, a total of 29 NGOs have been entrusted with the responsibility of training the participants to ensure they receive high-quality entrepreneurship training, enabling them to run their own businesses.

"More than 90 NGOs applied, but only 29 were approved and allocated funding.

funding.

"The funded NGOs must ensure that within six months, the training provided to the participants will help increase their income to at least RM750, which is above the RM747 poverty line," she said after the presentation of approval letters for the implementation of the programme yesterday.

Previously known as the Azam

Previously known as the Azam Bandar Programme, it is an annual initiative by the Housing and Local Government Ministry that was introduced in 2013, in which participants undergo a week-long entrepreneurship skills and knowledge course, and are provided with necessary equipment and tools to start or expand their chosen business.

business.
To date, a total of RM174 million has been allocated for the programme to train 16,955 entrepreneurs nationwide.

entrepreneurs nationwide.

Aiman Athirah said each NGO will be monitored throughout the programme.

She also reminded NGOs not to violate the ministry's regulations and not to repeat mistakes made by other NGOs during the previous programme. – Bernama

Two universities get new vice-chancellors

PUTRAJAYA: The Higher Education Ministry has announced the appointment of Prof Dr Mohd Shafry Mohd Rahim and Prof Dr Yatimah Alias as the new vice-chancellor of Universiti Teknologi Malaysia and Universiti Malaysia Pahang Al-Sultan Abdullah respectively.

In a statement, the ministry said Mohd Shafry's appointment is for two years effective today, while Yatimah's appointment, also for two years, takes effect on Jan 13.

"The ministry is confident that their appointments will empower academic development and research based on the latest technology, and produce globally minded graduates who are industry-ready, competitive, creative and innovative and have a high sense of identity," read the statement.

They received their appointment letters from the Higher Education Minister Datuk Seri Dr Zambry Abd Kadir at his office on Tuesday. – Bernama

Call for import ban on gold-wrapped products

KUALA LUMPUR: The Malaysia Gold Association (MGA) has called for the immediate cessation and ban on the import, fabrication and sale of "gold-wrapped silver" and similar gold-wrapped products.

In a statement, MGA said the influx of such products into the country could have a significant impact on the integrity of the country's precious metals market, causing price confusion and affecting real gold demand and the overall dynamics of precious metals.

It added that the products

resemble genuine gold jewellery due to the thickness of the gold coating, making it difficult for purchasers to distinguish them from real gold without professional assessment.

"This misperception creates the risk of financial loss, as buyers may unknowingly purchase these deceptive products under the false belief they are acquiring authentic gold," the association said.

MGA president Datuk Louis Ng urged industry players, manufacturers, importers, retailers, distributors and particularly enforcement agencies, to formally categorise gold-wrapped silver and similar gold-wrapped products (with non-gold inner cores) as fake gold and prohibited items.

gold and prohibited items.

"We hope Malaysian enforcement authorities, including the Customs Department and the Domestic Trade and Cost of Living Ministry, will impose stricter regulations to prohibit the sale, trade and exchange of these deceptive products, including on e-commerce platforms," he said.

Ng emphasised that rigorous

Ng emphasised that rigorous monitoring and enforcement

are required to safeguard consumer rights.

MGA said after careful

MGA said after careful consideration and discussions with key industry players, including manufacturers, retailers, pawnbrokers and other stakeholders, it was unanimously decided to reject such products, and fully comply with measures to halt their production, import and sale.

their production, import and sale.
"This commitment ensures
manufacturers will not fabricate
these products, and retailers will not
sell them in Malaysia," it added.

'Rising macaque numbers require humane solution'

Use of poison to address issue causes animals harm and poses risks to non-targeted species: Academic

PETALING IAYA: A more humane approach than poisoning is needed to manage the growing macaque population in urban areas, said Universiti Malaysia Terengganu Faculty of Science and Marine Environment Assoc

or science and wanne Environment Assoc Prof Dr Chong Ju Lian.

Commenting on a widely spread video in which a man is seen throwing poisoned ice cream at a troop of macaques after calling them pests that invade homes, she said such action is inhumane, particularly when dealing with human animal conflicts

with human-animal conflicts.

The roughly one-minute video has raised questions online about how to control wildlife that encroach on urban areas.

Chong, who is also Malaysian Nature

Society honorary secretary, said poisoning macaques causes them harm and poses risks

Killing, poisoning or torturing wild animals is a criminal act under the Wildlife Conservation Act 2010, and violators could face a maximum fine of RM1 million and up to 15 years' jail upon conviction.

"Leaving out poisoned bait could harm the ecosystem. There have been cases in which people accidentally consumed food laced with rat poison that was meant for wild animals. Poison should never be the solution It is a painful way for animals to die and

anyone resorting to using it to control wildlife numbers shows a lack of compassion." Universiti Putra Malaysia Wildlife Management senior lecturer Dr Tengku Rinalfi Putra Tengku Azizan said the growing urban macaque population is caused by various factors, with habitat loss being a

significant contributor.

"Over the past 70 years, human encroachment has steadily reduced macaque habitats, forcing them to adapt to urban environments. The rise in the macaque population is a result of human activity and their adaptabilities to when catting." their adaptability to urban settings.

He said human behaviour, such as poor food waste disposal and an abundance of leftovers in public spaces, have attracted macaques and worsened the issue.

"As opportunistic feeders, macaques have adapted by relying on human food sources, allowing them to not only survive but thrive despite the challenges. This contributes to escalating conflicts between them and humans."

Chong said a multidisciplinary approach wildlife control is essential, with to wildlife control is essential, with stakeholders working together to address

the problem.
"Authorities and NGOs could raise awareness to reduce human-wildlife conflicts." and promote peaceful coexistence. This includes not feeding macaques and improving waste secure bins." management

She urged the public not to take matters their own hands when faced human-wildlife conflicts but to

"The public should report any cruelty towards animals to the Wildlife and National Parks Department, which manages human-wildlife issues through trapping, translocation and contraception."

Malaysian Animal Welfare Association (Mawa) president Mukunnan Sugumaran expressed shock and concern over the

expressed shock and concern over the poisoning of macaques.

"It was hard to watch the video. When the man threw the food at them, the macaques were excited but unaware that the food would eventually kill them. It is heartbreaking," he said, adding that the culprit, who is an online vendor, used the video to promote a pesticide product.

He said the biggest concern is that the incident could encourage others to misuse poisons to target macaques, other wildlife or even a neighbour's pet that one may not like.

Mawa has lodged a police report against e online vendor and an investigation

Two trailers, 35 tonnes of rice and 14 cattle seized

uncovered 35,290kg of rice worth RM141,160, suspected to have been smuggled from Thailand.

"A 32-year-old male driver, who failed to produce documents related to the cargo, was detained. Further investigation suggests that the rice was brought in from a neighbouring

country through unauthorised routes."

He said the suspect and seized items, comprising the rice and the trailer, valued at about RM560,000, have been handed to the Kelantan Agriculture and Food Security Ministry Padi and Rice Regulatory Division for

In a separate incident at 3.30pm on Tuesday, a team from the 9th Battalion detained a trailer carrying 14 cattle worth RM136,500 at a roadblock in Lalang Pepuyu.

A 26-year-old male driver presented documents for the cattle but the ear tags on the animals did not match the livestock

transfer permit provided.

"The seized items are valued at RM321,500 and have been taken to Taman Bakti Komtak for further action by the Veterinary Department," said Nik Ros Azhan. – Bernama



Rescuers race to find survivors

More than 400 pulled out of earthquake ruins in Tibet

BEIJING: More than 400 people in Tibet trapped by a deadly earthquake in the foothills of the Himalayas have been rescued, Chinese officials said yesterday, but an unknown number remained unaccounted for in severe cold weather.

The epicentre of Tuesday's magnitude 6.8 quake, one of the region's most powerful tremors in recent years, was located in Tingri in China's Tibet, about 80km north of Mount Everest. It also shook buildings in Nepal, Bhutan and India.

Twenty-four hours after the temblor struck, those trapped under rubble would have endured a night in sub-zero temperatures, adding to the pressure on rescuers looking for survivors in an area the size of Cambodia.

Temperatures in the high-altitude region dropped as low as -18°C overnight. People trapped or those without shelter are at risk of rapid hypothermia and may only be able to live for five to 10 hours even if uninjured, experts say

say.
At least 126 people were known to have been killed and 188 injured on the Tibetan side, state broadcaster CCTV reported. No deaths have been reported in Nepal or elsewhere.

Chinese authorities have yet to announce

how many people are still missing. In Nepal, an official said the quake destroyed an empty school building in a village near Mount Everest, which straddles the Nepali. Tibetan border

which straddles the Nepali-Tibetan border.
Jost Kobusch, a German climber, said he was just above the Everest base camp on the Nepali side when the quake struck. His tent shook violently and he said he saw several avalanches crash down, although he was unscathed.

His expedition organising company, Satori

Adventure, said Kobusch had left the base camp and was descending to Namche Bazaar yesterday.

An initial survey showed 3,609 homes had been destroyed in Tibet's Shigatse region, home to 800,000 people, state media reported late on Tuesday, citing local officials.

Over 1,800 emergency rescue personnel and 1,600 soldiers had been dispatched to the region.

Footage broadcast on CCTV showed families huddled in rows of blue and green tents quickly erected by soldiers and aid workers in settlements surrounding the epicentre, where hundreds of aftershocks have been recorded.

State media said over 30,000 people affected by the quake had been relocated. Home to some 60,000 people, Tingri is

Home to some 60,000 people, Tingri is Tibet's most populous county on China's border with Nepal and is administered from the city of Shigatse, the seat of the Panchen Lama, an important figure in Tibetan Buddhism

with Nepal and is administered from the city of Shigatse, the seat of the Panchen Lama, an important figure in Tibetan Buddhism. No damage has been reported to Shigatse's Tashilhunpo monastery, state media reported, which was founded in 1447 by the first Dalai Lama.

The 14th Dalai Lama, along with Japanese Prime Minister Shigeru Ishiba, Russian President Vladimir Putin and Taiwan President Lai Ching-te, have expressed condolences to the earthquake's victims.

Southwestern parts of China, Nepal and northern India are often hit by earthquakes caused by the collision of the Indian and Eurasian tectonic plates, which are pushing up an ancient sea that is now the Qinghai-Tibetan

More than 500 aftershocks with magnitudes of up to 4.4 had followed the quake, the China Earthquake Networks Centre said.

Tuesday's quake was the worst in China since a 6.2 magnitude earthquake in 2023 that killed at least 149 people in a remote northwestern region. – Reuters

Thai suspect sought over murder of Cambodian politician

BANGKOK: A Thai court yesterday issued an arrest warrant for a man who shot dead a former Cambodian opposition lawmaker in a brazen attack in Bangkok's crowded old quarter.

Lim Kimya, 74, who had arrived in Thailand just hours earlier, was shot dead on Tuesday by a gunman who fired three shots, said a police officer, who declined to be named because he was not authorised to speak to media.

Lim Kimya, a Cambodian and French citizen,

Lim Kimya, a Cambodian and French citizen, had crossed into Thailand from Cambodia at noon on Tuesday with his wife and brother and travelled to Bangkok by bus.

travelled to Bangkok by bus.
Police Colonel Sanong Saengmanee, superintendent of the local precinct, said an

arrest warrant had been issued for a 41-year-old motorcycle taxi driver for premeditated murder.

Bangkok police chief General Siam Boonsom said investigations indicate the killer was a hit man. Lim Kimya was a member of the Cambodia

National Rescue Party, the popular opposition that was dissolved by a court ahead of a 2018 election over an alleged treason plot. The CNRP said at the time that the charges against it were fabricated by the ruling Cambodian People's Party.

Surrounded by a pool of blood, Lim Kimya lay on his back, clad in a blue polo shirt and white shorts, as a policeman attempted to revive him, according a photo shared by first responders. A

small blue suitcase lay nearby.
"Thai authorities should investigate and prosecute those responsible," said Bryony Lau, deputy Asia director at Human Rights Watch.
"The Cambodian government has

"The Cambodian government has intimidated, surveilled and harassed former CNRP members – including those living in exile."

Cambodian government spokesperson Pen Bona said the killing was a matter for the authorities of Thailand. He said the Cambodian government was often accused by opposition "extremists" of being behind incidents.

Lim Kimya was not a prominent member of the opposition. – Reuters

Vietnam to reward snitches reporting traffic offences

HANOI: Vietnam is to pay residents who snitch on traffic offenders up to five million dong (RM900) as the Southeast Asian country strives to bring rule-breaking drivers into line on its notoriously chaotic roads.

on its notoriously chaotic roads.

Since the beginning of the year, authorities have dramatically increased the fines to an almost unaffordable level for the average driver for traffic violations including running a red light and using a mobile phone.

Under the new rules, anyone who reports a verified traffic offence in Vietnam can now collect up to 10% of fines levied, up to a ceiling of five million dong.

The identities of informants will be kept

the identities of informants will be kept confidential "to ensure their privacy", the law said.

No one has so far been rewarded, according to state media, who cited police.

In a country where the average monthly income is around 7.7 million dong, running a red light with a motorcycle now costs more than six million dong, six times the previous

If a car driver does the same, it will set them back them close to 20 million dong, up from six million dong.

Fines have also doubled for using a mobile phone behind the wheel.

"I was shocked by the fine levels," said Grab rider Nguyen Quoc Phong, who confessed he regularly ran red lights in the capital Hanoi.

"I am scared now. I have started to obey the rules strictly." Phong said, adding that he hated the idea of being filmed and reported to police by a fellow Hanoian. One police officer in Hanoi said he had

One police officer in Hanoi said he had seen several drivers break down in tears when handed a fine.

Around 77 million motorcycles and 6.3 million cars rule Vietnam's roads, official statistics showed.

In 2024, road accidents claimed 30 lives a day, while traffic – particularly in major cities – is horrendously slow as drivers move with little regard for traffic lights or road signs and rules. – AFP

Chinese actor found in Myanmar suspected to be trafficking victim

BANGKOK: A Chinese actor who went missing last week near the Thai-Myanmar border has been found in Myanmar and may have been the victim of human trafficking, Thai authorities said

on Tuesday.

Wang Xing, 22, was reported missing in northern Thailand's Tak province bordering Myanmar, an area known for large-scale criminal enterprises and human trafficking by organised gangs.

gangs.
"From initial inquiry, we believe he was a victim of human trafficking," said police Inspector General Thatchai Pitaneelaboot.

He was told there was a casting in Thailand,

but instead was trained to scam other Chinese people, Thatchai said, adding he was not assaulted or abused.

Wang has now been returned to Thailand. The case was widely shared on Chinese social media raising concerns that it could dent Thailand's hospitality and tourism industry, a key driver of Southeast Asia's second-largest economy and for which China is the main source market

"We have to manage this well so it does not impact Thai tourism," Thai Prime Minister Paetongtarn Shinawatra said.

Last year, Thailand welcomed 35.55 million

foreign arrivals with 6.74 million from China.

China's Foreign Ministry said it was in touch with its embassies and would "continue to follow up on the incident".

Border towns in Thailand, Myanmar and Laos have become sites for telecom and other online fraud, according to the United Nations, which says hundreds of thousands of people have been trafficked to work in scam centres.

Says Infinited to Work in scam centres.

Most of the trafficking victims were from Southeast Asian countries as well as China, Taiwan and Hong Kong, but others came from as far away as Africa and Latin America, according to the UN. – Reuters

Mahout charged over death of Spanish tourist

BANGKOK: Thai police charged a mahout with negligence yesterday after an elephant killed a Spanish tourist at a sanctuary in southern Thailand last week.

The 23-year-old Spanish woman died after a "panic-stricken" elephant struck her with its trunk at the Koh Yao Elephant Care Centre in Phang Nga province.

Phang Nga province.
Police charged the mahout, an employee of the sanctuary, with negligence and failing to prevent the fatal incident.

"We charged him with negligence causing

death and he will be taken to court today," said local police chief Jaran Bangprasert.

The mahout, identified by local media as a 38-year-old Thai, faces up to 10 years in prison and a fine of 200 000 babt (PM25 637)

and a fine of 200,000 baht (RM25,637).
Wild elephants have killed 227 people, including tourists, in the past 12 years, according to the Department of National Parks, Wildlife and Plant Conservation.

An elephant killed a 49-year-old woman at a national park in Loei province in northern Thailand last month. While encounters between villagers and wild elephants are common, attacks at sanctuaries remain rare.

Bathing elephants is a popular activity among visitors in Thailand, where about 2,800 elephants are held for tourism purposes across the country, according to World Animal Protection.

However, animal rights groups argue that bathing elephants can cause them distress and some sanctuaries in the country do not allow it.







Wildfire sparks panicked evacuations in LA suburb

Biden approves federal emergency aid for California

LOS ANGELES: A ferocious wildfire in a Los Angeles suburb devoured buildings and sparked panicked evacuations on Tuesday, as hurricane-force winds tore through the

Frightened residents abandoned their cars on one of the only roads in and out of the upscale Pacific Palisades area, fleeing on foot from the 1,200ha blaze engulfing an area packed with multimillion-dollar homes in the

Santa Monica Mountains.

Firefighters used bulldozers to push dozens of vehicles – including expensive models such as BMWs, Teslas and Mercedes – to post ideal beginning to the procession of t to one side, leaving many crumpled and with

their alarms blaring.

Los Angeles Fire Department Chief Kristin Crowley said despite the chaotic evacuation, there were no immediate reports of deaths or

Hundreds of firefighters swarmed the area, attacking the blaze from the ground and the air, while crews worked through steep terrain

arr, while crews worked through steep terrain to cut back vegetation and create firebreaks.

Around 30,000 people were ordered to evacuate the fast-spreading flames, which levelled homes as powerful winds spread embers far and wide.

"We are not out of danger," said Los Angeles County Fire Chief Anthony Marrone, speaking at an afternoon press conference, adding that the winds are expected to pick up.

Across town, on the northern edge of Los Angeles, another fire broke out in Eaton Canyon, near Pasadena, quickly consuming 81ha on Tuesday night, according to Angeles National Forest officials.

President Joe Biden said he was being frequently briefed on the wildfires and has offered "any federal assistance that is needed".

The fire erupted midmorning and swelled quickly, taking many residents by surprise.

One man, who gave his name as Gary, told broadcaster KTLA that hot ashes were raining down on his community of Sea Ridge.

"There was smoke in the distance, and I

was assured that it would not come over the hill ... Five minutes later, it's coming down the hill," he said.

"Everyone panicked, that's when everybody made a run and went to go and

pack their houses up."

Evacuee Kelsey Trainor said she saw the

fire explode in size as she was fleeing.

"By the time we got to the bottom of the hill, which is about two or three miles, there were flames on both sides of the road, and it became gridlocked," she said.

"No one knew what to do. Everyone was honking their horns. There's flames all around

"I could see people walking with suitcases, with their dogs, children. An elderly woman was really visibly upset and in tears."

The fire came as the area was being hit by asonal Santa Ana winds that forecasters said could develop into the worst windstorm in a decade, with gusts of up to 160kph expected.

California Governor Gavin Newsom said Biden has approved federal aid to help firefighters respond to the conflagration. - AFP



Rocket scientist takes over as space agency chief

BENGALURU: India appointed rocket scientist V. Narayanan as the new head of the Indian Space Research Organisation (Isro), the government said on Tuesday, a key role as

India works to become a space superpower.

Narayanan takes over from S. Somanath, who became chairman in 2022 and has been credited with making the 54-year-old space agency more approachable and opening it up to engage with the next generation.

Former colleagues describe Narayanan, who joined Isro in 1984, as a mild mannered but "strict" scientist with a track record of getting things done.

"The appointment is a surprise because we were expecting an extension for Somanath, but the choice makes sense, given Narayanan's track record," said a former Isro scientist and colleague, who did not want to be named because he is not authorised to speak to the

Naravanan, who has a doctorate in aerospace engineering, will take charge as Isro sets sights on building its own space station by 2035, and putting an Indian on the moon by

Prime Minister Narendra Modi has called on Isro to make India a profitable space superpower, and the agency has responded by looking to work with the private sector.

The Indian government estimates its share of the market is just US\$8 billion (RM36 billion), but it is aiming to increase that to US\$44 billion

over the next decade.

The US\$400 billion global commercial space market is expected to be worth US\$1

trillion by 2030.

and Narayanan did not respond to requests for Somanath immediately comment.

Narayanan, who has worked on the key rocket launches such as Isro's Polar Satellite Launch Vehicle and led the centre that designs and develops liquid propulsion systems for the agency, will take over on Jan 14 for a two-year

He was also the head of the analysis committee tasked with looking into the failure of Chandrayaan-2, where Isro lost contact with a spacecraft it was trying to land on the Moon.

The agency eventually launched the Chandrayaan-3 mission in 2023, becoming the first country to land on the rugged unexplored south pole of the moon. - Reuters

Seaplane crashes near tourist hotspot

SYDNEY: A small seaplane ferrying European tourists plunged into the ocean off Western Australia killing three people on board.

The plane crashed on Tuesday evening as it

left Rottnest Island, a tourist drawcard famous

for its friendly marsupials called quokkas.
As search teams fished the wreckage from the sea yesterday, state Premier Roger Cook confirmed three people had died and four

others survived.

One body recovered from flooded mine

GUWAHATI: The body of a miner was recovered from a flooded coal mine in a remote district of India's northeastern state of Assam vesterday two days into the search for nine men trapped

below ground.

The mine, which is 91.44m deep and has underground tunnels, is thought to have flooded on Monday morning after miners hit a water source.

The extent of the flooding hampered rescue work on Tuesday, but expert divers entered the mine again early yesterday and were able to retrieve a body, said Assam Chief Minister

Himanta Biswa Sarma. Officials have said the mine is illegal

"We didn't see the body, it was completely dark inside, we felt a body using our hands, and that's how we were able to recover them," one of the divers told a news channel after the body had been recovered.

The army has deployed divers, helicopters and engineers to help the rescue efforts in Assam's hilly Dima Hasao district.
"It is difficult to say how long the operation

will take, because we have been told there are rat holes in the mine," said H. P. S. Kandhari, a commandant in the National Disaster Relief

GMO mosquitoes solution proposed

SYDNEY: Genetically engineered mosquitoes with toxic semen could be a new weapon against tropical disease. Australian scientists said after trials of the novel pest control method.

The "toxic male technique" aims to breed mosquitoes that express venomous proteins in their semen, killing off females after mating.

Female mosquitoes are targeted because only they bite and drink blood, thereby

spreading diseases.
Scientist Sam Beach from Australia's Macquarie University said the method "could work as quickly as pesticides without also

harming beneficial species".

The first proof-of-concept trials used fruit flies, a common laboratory species favoured for its short two-week life cycle. Female flies that bred with "toxic" males had a

reduced lifespan, the scientists found.

The research was described in a paper published by Nature Communications. - AFP

Airstrikes kill dozens as US pushes for ceasefire

Hamas demands Israel end war

CAIRO: Israeli military strikes across Gaza killed at least 22 people yesterday, Palestinian medics said, as the US stepped up efforts to overcome sticking points between Israel and Hamas to reach a ceasefire to end the war.

One of the airstrikes killed at least 10 people in a multi-storey house in the Sheikh Radwan neighbourhood of Gaza City yesterday, while another killed five in the nearby Zeitoun suburb, medics said.

In Deir Al-Balah city in central

Gaza, where hundreds of thousands of Palestinians are sheltering, an Israeli airstrike killed three other

In Jabalia, where the army has operated for more than three weeks, an Israeli airstrike killed four people, medics said.

On Tuesday, Israeli military strikes killed at least 24 Palestinians across the Gaza Strip, medics said, with two airstrikes hitting tent encampments in Mawasi, to the west of the southern city of Khan Younis, killing 18 people. The dead included several women and children.

Israeli continued its

bombardments, the US, Qatar and Egypt were making the most intensive effort in months to reach a ceasefire, with one source close to the talks saying this was the most serious attempt to reach a deal so

The outgoing US administration has called for a final push for a deal before President Joe Biden leaves office, and many in the region view Donald Trump's inauguration on Jan 20 as an unofficial deadline.

"Things are better than ever before, but there is no deal yet," the source said.

But with the clock ticking, both sides accuse the other of blocking a deal by adhering to conditions that have torpedoed all previous peace efforts for more than a year.

On Tuesday, Hamas stood by its demand that it will only free its remaining hostages if Israel agrees

to end the war and withdraw all its troops from Gaza. Israel says it will not end the war until Hamas is dismantled and all hostages are free. Hamas also said Trump was rash to say there would be "hell to pay" unless the hostages go free by his inauguration.

Hamas official Osama Hamdan

said in Algiers: "The US president must make more disciplined and diplomatic statements." - Reuters

OpenAI chief denies abuse accusations

SAN FRANCISCO: Open AI CEO Sam Altman denied on Tuesday allegations from his sister Annie Altman, who has filed a complaint accusing him of childhood sexual abuse.

"... Annie has made deeply hurtful and entirely untrue claims about our family, especially Sam," the boss of the California startup said in a letter co-signed by his mother and two brothers.

"Our family loves Annie and is very concerned about her wellbeing. Caring for a family member who faces mental health challenges is incredibly difficult,"

The Altman family said that they have tried to help their daughter and sister, covering her expenses and guaranteeing her "monthly financial support, which we expect to continue for the rest of her life".

"Despite this, Annie continues to demand more money from us," they said, pointing out that they have decided to respond publicly following Anne's legal complaint filed on Monday.

"The worst allegation she has made is that she was sexually abused by Sam as a child.

"Her claims have evolved over time. Newly for this lawsuit, they now include allegations of incidents where Sam was over 18.

"All these claims are utterly untrue."

According to the complaint, Annie, who is nine years younger than Altman, alleges the assaults took place from 1997, when she was three, until 2006. - AFP

Alaska sues over oil and gas leases

WASHINGTON: The US state of Alaska has sued the Biden administration for what it calls administration for what it calls violations of a Congressional directive to allow oil and gas development in a portion of the federal Arctic National Wildlife Refuge (ANWR).

Monday's lawsuit in the US District Court in Alexa challenges the federal

Court in Alaska challenges the federal government's December 2024 decision to offer oil and gas drilling leases in an area known as the coastal plain with restrictions.

The lawsuit said curbs on surface use and occupancy make it "impossible or impracticable to develop" 162,000ha of land the US Interior Department plans to auction this month to oil and gas drillers. The limits would severely limit future oil exploration and drilling in

the refuge, it added.

"Interior's continued and irrational opposition to responsible energy development in the Arctic continues America on a path of energy

dependence instead of using the vast resources we have," Governor Mike Dunleavy said.

Alaska wants the court to set aside the December decision and prohibit the department from issuing leases at the auction.

The department did not immediately respond to a request for comment. A spokesperson for the Bureau of Land Management declined to comment.

When combined with the department's cancellation of leases granted during the waning days of Donald Trump's presidency, Alaska says it will receive just a fraction of the US\$1.1 billion (RM4.9 billion) the Congressional Budget Office estimated it would get in direct leaserelated revenues from energy development in the area.

The lawsuit is Alaska's latest legal response to the Biden administration's efforts to protect the 8-million-hectare ANWR for species such as polar bears and caribou.

An October 2023 lawsuit by the Alaska Industrial Development and Export Authority contested the administration's decision to cancel the seven leases it held. Another state lawsuit in July 2024 sought to recover

revenue lost as a result.

Drilling in the ANWR, the largest national wildlife refuge, was off-limits for decades and the subject of fierce ror decades and the subject of herce political fights between environmentalists and Alaska's political leaders, who have long supported development in the

coastal plain.

In 2017, Alaska lawmakers secured that opportunity through a provision in a tax cut Bill passed by Congress. In the final days of Trump's administration, it issued nine 10-year leases for drilling in ANWR.

Under Biden, two lease withdrew from their holdings in 2022. In September, the Interior Department cancelled the seven issued to the state industrial development body. – Reuters

Ex-president Carter lies in state

WASHINGTON: The body of late US president Jimmy Carter was transferred on Tuesday in a grand and solemn military ceremony to the US Capitol, where it will lie in state until a national funeral later this week. Carter, who died on Dec 29 at the

age of 100, served a single term from 1977 to 1981 and was widely praised for his post-presidential humanitarian efforts, for which he was awarded the Nobel Peace Prize in 2002

His body arrived at the snow-covered US Capitol, where it will remain until today, after a full day of ceremonious travel that began in his native Georgia.

Having been flown to Washington

aboard a presidential US Air Force jet, his flag-draped casket was carried his flag-draped casket was carried atop a gun carriage in a funeral procession from the US Navy Memorial – an ode to his military service on submarines – to Capitol Hill, tracing the opposite route he took during his inau

accompanied the procession down Pennsylvania Avenue.

Military pallbearers then carried his casket up to the Capitol Rotunda where a short service was held, with Carter's family, members of Congress and other dignitaries in attendance.

Carter is the 13th former US president to lie in state in the Capitol. A state funeral service will be held

today at the National Cathedral, an Episcopal church in Washington that also hosted funerals for former presidents Dwight Eisenhower, Ronald Reagan, Gerald Ford and George H.W. Bush.

President Joe Biden declared today as a national day of mourning, with federal government offices to be closed for the day.

He has also ordered flags to half-

staff for 30 days as is customary, which means that will be the case during Trump's Jan 20 inauguration.

UN calls for US\$370m in additional humanitarian aid to Lebanon

NEW YORK: The United Nations joined the Lebanese government on Tuesday to appeal for an additional US\$371.4 million (RM1.7 billion) in humanitarian aid for people displaced by the conflict between Israel and Hezbollah.

The extension builds on an initial aid appeal for US\$426 million

launched in October, as all-out war flared between the two sides and sent hundreds of thousands in Lebanon fleeing their homes.

That appeal raised about US\$250 million, according to the UN.

Following nearly a year of exchanges of cross-border fire initiated by Hezbollah over the war in

Gaza, Israel in September stepped up its bombing campaign and later sent troops into Lebanon.

After two months of warring, in which Hezbollah's influential chief Hassan Nasrallah and other leaders were killed, a ceasefire deal was reached that went into effect in late

"While the cessation of hostilities offers hope, over 125,000 people remain displaced, and hundreds of thousands more face immense challenges rebuilding their lives," said Imran Riza, the UN humanitarian coordinator in Lebanon.

The additional funding "is urgently

required to sustain life-saving efforts

and prevent further deterioration of an already dire situation", he said. The appeal is primarily aimed to

assist an estimated one million Lebanese, Syrian and Palestinian refugees affected by the conflict, funding a three-month period of emergency efforts through March 2025. – AFP

BSENTEEISM among students sitting for the Sijil Pelajaran Malaysia (SPM) examination is a growing concern in schools nationwide, with a record of 2.7% to 3% absentees for 2023 and 2024.

These numbers are alarming as there have been no actions taken so far to reduce the percentage of absentees among SPM candidates

among SPM candidates.

SPM is a pivotal milestone in students' academic journeys; it serves as a gateway to higher education and future career opportunities. Despite its importance, schools continue to report significant absentee rates during the examination period.

The removal of the Ujian Penilaian Sekolah Rendah (UPSR) and Pentaksiran Tingkatan Tiga (PT3), for example, has significantly altered the academic trajectory for students. Without these foundational exams, some students may struggle to adapt to the rigour of SPM, leading to disengagement and absenteeism.

The lack of intermediate benchmarks, such as UPSR and PT3, may also contribute to a decline in motivation and preparedness.

Other factors such as financial difficulties may force some of the SPM candidates to prioritise work or family responsibilities over education.

In some cases, parents may be unable to afford transportation or exam-related expenses, discouraging students from attending school, indirectly making them opt out from the SPM exam.

The pressure to excel in SPM can also heighten anxiety and stress levels. Without proper support systems, students may choose to avoid school altogether, viewing absenteeism as an escape from overwhelming expectations.

Furthermore, a lack of interest in studies, often stemming from ineffective teaching methods or non-inclusive curricula, can cause students to disengage and skip school.

Peer pressure also plays a significant role in absenteeism. Students who are part of groups that devalue education or prioritise social activities over academic commitment may adopt similar behaviours.

Family issues such as divorce, illness or caregiving responsibilities can also contribute to absenteeism as students may feel obligated to stay home, leading

them to lose focus on their education.

The emergence of the gig economy also contributes to absenteeism among SPM candidates as the idea of needing an academic certificate to pursue a career in areas like e-hailing, food delivery and content creation is no longer seen as essential.

Absenteeism has far-reaching consequences, not only for students but also for schools and society as a whole. Students who miss classes are likely to fall behind academically, leading to lower grades and decreased opportunities for future careers.

opportunities for future careers.
Schools may also face challenges in meeting performance benchmarks, which can impact funding and resources.

To address absenteeism effectively, a multipronged approach is necessary. In light of the abolishment of UPSR and PT3, schools should provide additional support to students. This could include offering bridging programmes to help students transition effectively and supplementary lessons to reinforce foundational knowledge.

Schools and government bodies

Schools and government bodies could provide subsidies for transportation, meals and exam fees to ease the financial burden of needy students and their families. Introducing counselling services and

Introducing counselling services and stress management workshops can help students cope with exam-related anxiety.

Creating a supportive environment encourages open communication about mental health. Adopting interactive and practical teaching strategies can make learning more enjoyable and relevant, helping students stay motivated.

Schools could host workshops to educate parents on the importance of consistent attendance, and provide strategies to support their children's education.

Implementing attendance tracking systems can help schools identify at-risk

students early. Engaging with these students through mentorship programmes and home visits can prevent chronic absenteeism.

Another major improvement that relevant agencies could undertake is the reintroduction of an improved version of UPSR and PT3.

Reintroducing the UPSR and PT3 is pivotal in strengthening Malaysia's education system, especially as a

foundational exam for SPM.

UPSR and PT3 exams are essential to restore structure and accountability in Malaysia's education system as these exams serve as crucial milestones to gauge students' progress and identify learning gaps early. They motivate consistent effort, provide a clear academic pathway and ensure fair and standardised evaluations across schools.

Furthermore, these assessments promote discipline, time management and preparedness, reducing disengagement and absenteeism while enabling educators and policymakers to monitor educational standards effectively.

By reinstating these examinations, students will be better equipped for SPM and future academic or career challenges.

Strong action needs to be taken to ensure that the absenteeism rate is reduced in the near future. As educators, parents and policymakers, it is our collective responsibility to ensure every SPM candidate has the opportunity to succeed.

By addressing the root causes of this absenteeism and creating a supportive ecosystem for learning, this issue can be mitigated.

The future of our youngsters is in our hands. The government, through the Education Ministry and other relevant agencies, should prioritise addressing this issue to ensure a steady reduction in absenteeism rates over time.

It was also because of his failure to leverage the strengths and enormous resources of the country to build a better future for Americans, which in turn could have had positive ripple effects on the rest of the world.

integrity and courage. His readiness to move away from the more orthodox foreign policy line adopted by both Democrats and Republicans back in the 1970s over the Arab-Israeli conflict triggered fundamental shifts in how the world approached that conflict, with the plight of

the Palestinians as its core.
"Carter's life embodied the American dream while transcending it through his dedication to global service. His one term as president (1977-1981), even though he was often criticised during his tenure, yielded lasting diplomatic triumphs, most notably the Camp David Accords between Israel and Egypt - an achievement that earned him respect as a peacemaker long after he left

"His 2002 Nobel Peace Prize recognised his diplomatic achievements and his lifelong dedication to advancing human dignity and peace. Throughout his life, Carter maintained a reputation for integrity that stood as a beacon in American public life.

"His plainspoken manner and modest lifestyle reflected his belief that true greatness lies in serving others. Even as he faced criticism for his political positions, few questioned his sincerity or commitment to his principles.

Biden had the opportunity to leave a similar positive impact on America and the world. Unfortunately, he was not made of the same stuff as Jimmy Carter.

Liew: Asean must unite on GMT implementation

for Asean member states to work towards an agreement not to circumvent the global minimum tax (GMT) as countries begin to adopt the tax, said Deputy Investment, Trade and Industry Minister Liew Chin Tong.

He also urged Asean member states not to enter into a race to the bottom in terms of wages, tax cuts, or tax holidays but instead to uphold environmental standards.

Liew noted that Asean should emerge as a middle-class society over the next two decades and thus become a sizable consumer market, not just as production sites in the add formulation of converted. in the old formulation of export-led industrialisation.

"It (Asean) is used to the old export-led

industrialisation model in which we help multinationals suppress wages to make us a cheap production destination. It is also used give tax cuts or tax holidays to multinationals.

"We will have to stand together and tell the

multinationals that we need to collect these taxes for the greater good of our people and for Asean to emerge as a middle-class society. which in turn will be a huge market for all, including the multinationals," he said in his opening remarks at the Asean Economic

Liew said the GMT was one of the issues the Ministry of Investment, Trade and Industry (Miti) would discuss during Malaysia's Asean chairmanship.

"But the broader objective is to strengthen the supply chain, strengthen ourselves as a middle power as well as Asean as a strong middle-class society which thus becomes strong consumer market because, for the longest of time, we have to be dependent on export-led industrialisation," he added.

Liew said that if the global supply chain were left to the major powers, it would eventually bifurcate as the United States and China extricate themselves from each other.

"It is not in the interest of the rest of the world to see the supply chain bifurcates.

"Therefore, Asean, together with the European Union, the Global South and others, need to do the heavy lifting to ensure that the middle ground or the common

ground is big enough to resist supply chain bifurcation," he said.

In this context, he said, the Johor-Singapore Special Economic Zone has the potential to create an exciting future and a role model.

The deputy minister added that more Asean-wide joint investment projects or subregional cooperation will help to make the Asean supply chain stronger. Liew said that Asean's non-aligned stance

was not born out of a vacuum as it was established precisely because the founders thought that Asean should not be aligned with either side during the Cold War.

"The 2020s is exactly such a moment that we in Asean need to hang together so as not

to be hung separately.

"We need to work with each other very closely, and we need to ensure that each Asean member state is economically secure and well-to-do to form a much stronger regional solidarity," he added. - Bernama

Local economy seen growing 5% this year, propelled by investments

KUALA LUMPUR: The Malaysian economy is expected to maintain a sustainable growth rate of 5% in 2025 from an estimated 4.9% in 2024, supported by a stable labour market condition, conducive fiscal and monetary policies amid lingering external uncertainties, said an economist.

Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid economist Dr Mohd Atzanizam Abdul Rashid told Bernama that investment activities are likely to be the main driver for growth as the government is committed to transitioning Malaysia into a developed nation.

In this regard, the government-linked investment companies through the GEAR-uP initiative are set to allocate RM120 billion to direct domestic investment over five years.

"The initiative will unlock Malaysia's growth potential through investments in high-growth potential through investments in high-growth high-value sectors such as the energy transition, advanced manufacturing, especially in the semiconductor industry, and across all life cycles of firms from startups and venture capital to mid-tier companies," he said.

Mohd Afzanizam said the growing prominence of artificial intelligence has shifted

greater focus to the technology sector, positioning it as a key driver for boosting

productivity and efficiency in the economy.

He highlighted the development of data centres, driven by significant private sector investment, as a crucial growth catalyst.

These projects directly benefit industries "Inese projects directly benefit industries such as construction, property, energy, water, and other supporting services," he said, adding that Malaysia's semiconductor-related exports are expected to align with sustained global demand in 2025.

Citing World Semiconductor Trade Statistics, Mohd Afzanizam said global semiconductor sales are projected to grow at a robust rate of 11.2% in

2025, after a strong 19% growth last year. Mohd Afzanizam noted that, beyond technology, increased government development expenditure, with a total allocation of RM86 billion for 2025 would also provide significant

Support for domestic growth.

He said the Public-Private Partnership
Masterplan 2030 aims to enhance project
governance and accelerate execution.

"Major infrastructure projects under this initiative including motorways, railways, ports, and airports, are set to drive economic development and connectivity," he added.

Additionally, state-level economic initiatives such as the Johor-Singapore Special Economic Zone, the Malaysia IC Design Park in Selangor, and the Blue Economy initiative on the East Coast

and the blue Localisms inhance of the Last Colast are expected to serve as key growth catalysts. Mohd Afzanizam identified geopolitics, particularly the ongoing conflict in the Middle East and Ukraine, as the primary concern for 2025, which could significantly impact financial market sentiments and potentially disrupt the supply chain.

He also expressed concerns about the potential United States import tariffs under the new administration, which could exacerbate inflation and compel the Federal Reserve to

maintain a restrictive monetary policy stance.

Domestically, he said, a possible reversal of key economic reforms, especially the rationalisation of fuel subsidies, could undermine market confidence.



Swift Energy unfazed by Petronas cuts

Industrial automation and power systems company cites diversified revenue streams with balanced reliance on oil and gas, edible oils and utilities

KUALA LUMPUR: Swift Energy Technology Bhd, a provider of industrial automation and power systems, is unfazed by capital expenditure cuts at Petroliam Nasional Bhd (Petronas), thanks to its diversified revenue streams.

CEO Tan Bin Chee said Swift

Energy has diversified revenue streams with balanced reliance on oil and gas, edible oils and utilities with clients across various industries and countries.

"Each year, different national oil companies or engineering, pro-curement, construction, and com-missioning (EPCC) players will take turns to be a prominent contributor to our business revenue. This year, it could be Petronas, next year Shell and the year after that Wilmar, for example. In 2021, our edible oil business contributed 39% of our revenue, and this primarily comes from the oil and grains business," he told a press conference after its

listing yesterday.

He stressed, "All the national oil

companies are very important customers to us. All the EPCC customers are very important to us but we are not overly dependent on either one. We don't rely on a single customer to dominate our revenue sources.'

Tan said Swift Energy has served many national oil companies over the past 22 years. It has also worked with numerous international EPCC companies from South Korea, Europe and Asean countries. "At the same time, we have major edible oil customers such as IOI and KLK. In Indonesia, we work with Mosin Mask, Sinarmas, and PT Smart. This diversification ensures we are not overly reliant on any single EPCC or national oil company.

Tan highlighted the company's Tan highlighted the company's focus on greener energy sources, particularly natural gas. "Our Ex Solar PV systems are designed to provide off-grid power supply requirements for production activities on wellhead platforms specifically built for natural gas production."

Furthermore, Tan said, Swift Energy is negotiating for several Ex

FMM: Malaysia's economy to post steady growth in 2025

LUMPUR: Malaysia's economy is poised for steady growth this year, driven by strong domestic demand, robust investment activities and growth in exports and tourism despite potential global uncertainties, according to the Federation

of Malaysian Manufacturers (FMM). In a statement yesterday, its president Tan Sri Soh Thian Lai noted that in the second quarter and third quarter of 2024, Malaysia's gross domestic product (GDP) grew at 5.9%

and 5.3%, respectively. He added that the nation's GDP growth is forecast to be between 4.5% and 5% this year.

"However, risks remain, including slower recovery in China, potential shifts in the United States' policy, global commodity price fluctuations and domestic inflation pressures," he said.

Nonetheless, exports are anticipated to continue doing well this year, with key sectors like electrical and electronics, semiconductors, palm oil, machinery and chemicals driving this expansion.

On the same note, he said the impact of potential US tariffs on Malaysia's exports is expected to be limited, based on historical data.

"However, inflation is forecast to rise to approximately 3% in 2025, influenced by domestic factors such as an increase in the minimum wage, changes in the Employees Provident Fund contributions for foreign workers, the extension of the Sales and Service Tax and subsidy rationalisation efforts.

"Nevertheless, inflation expected to remain within the Ministry of Finance's target range of 2-3.5%," he said.

FMM also expects the ringgit to remain firm in 2025, supported by strong domestic demand and an improved tourism sector. "Factors such as the US Federal Reserve rate cuts, labour supply changes and inflation will influence the currency's strength," he said. - Bernama

China 2024 box office revenue plunges

▶ Hopes for post-pandemic uptick dashed but comedies among successes

BEIJING: China's 2024 box office revenue slumped by almost a quarter from the previous year, official data showed, dealing a blow to a limping domestic industry yet to fully recover from the pandemic.

Box office revenue totalled 42.502 billion yuan (RM26.21 billion), according to the

China Film Administration.

That is down 22.6% from 54.915 billion yuan in 2023, and 34% lower than the pre-pandemic peak in 2019.

Of that, box office revenue of domestic films totalled 33.439 billion yuan, plunging 27.3% from 46.005 billion yuan in 2023.

Hopes for a post-pandemic uptick in box office revenue for the second year were dashed despite successes including *YOLO*, a comedy on how a reclusive woman reconnected with society through boxing, and *Successor*, another comedy, about how a couple hid their wealth from their son to promote character building.

The slump was caused by a mix of factors a decline in the number of feature films. competition from online offerings including micro dramas and a slowdown in the world's

second-largest economy.

For the whole of 2024, the number of moviegoers in urban theatres totalled 1.01 billion, down from 1.299 billion a year earlier. A total of 612 feature films were produced last year, down from 792 in 2023.

With the local film industry on a wobbly footing, foreign movies made a comeback.

Hollywood blockbuster Godzilla x Kong. The New Empire and Japanese animated feature The Boy and the Heron made their

mark in the top 10, securing the ninth and 10th spots, respectively.

In contrast, the top 10 list of movies by revenue in 2023 was entirely dominated by local titles, according to the state-run Xinhua news agency.

Other foreign successes included Alien:

The sci-fi horror flick raked in 786 million yuan, making China its biggest global revenue contributor, Xinhua reported.

The decline in Chinese offerings last year reflects ebbing investment and output capacity in an industry still struggling with the aftermath of strict Covid-19 restrictions, which

disrupted movie production from 2020 to 2022. Box office revenue on New Year's Day in

2025 was a little over 200 million yuan.

That was a far cry from the record 1.53 billion yuan during the previous New Year's Day holiday, which was two days longer thanks to a weekend. - Reuters

Q4 profit to miss forecasts Samsung warns

SEOUL: South Korea's Samsung Electronics said yesterday it expected fourth-quarter profits to fall sharply from the previous quarter and miss forecasts as it struggled to meet robust demand for chips used in artificial intelligence

The announcement comes after the world's largest memory-chip maker issued a rare apology in October acknowledging it was facing a "crisis" and that questions had arisen about its "fundamental technological competitiveness and the future of the company".

The company said in a regulatory filing that October-December operating profits were expected to come in at 6.5 trillion won (RM20.26 billion), up 130.5% from a year carlier.

But that is down nearly 30% from 9.18 trillion won in the previous three months and 16% below the average estimate, according to the Yonhap news agency, which cited its own financial data firm

Sales were seen increasing 10.7% on-year to approximately 75 trillion won, which was also lower than the previous quarter.

"In light of the preliminary fourth-quarter 2024 results significantly falling short of market expectations, we aim to mitigate confusion among the market and investors until the final results are announced," Samsung's management

said in an explanation page.
It noted that Samsung's Device Solutions division, which is in charge of memory and foundry business units, among others, "reported declines in sales and profits due to worsening market conditions, particularly for IT-related products".

"Despite achieving record-high quarterly revenue in the fourth quarter, driven by strong sales of high-capacity products, weak demand for conventional PC and mobile products weighed on overall performance," it said.

Non-Memory Business performance also declined because of "weak demand from key applications" and "increased R&D spending".

Samsung's consumer electronics division, which includes mobile phones, also experienced a decline owing to "reduced impact from new mobile product launches and intensified competition".

The firm's Seoul-listed shares rose 0.72% yesterday despite the report.

The firm is the flagship subsidiary of South Korean giant Samsung Group, by far the largest of the family-controlled conglomerates that dominate business in Asia's fourth-largest

The company is expected to release its final earnings report at the end of this month.

HDFC Bank says Q3 deposit growth outpaces loan growth

MUMBAI: India's HDFC Bank saw quarter-on-quarter deposit growth outpace loan growth in the three months to Dec 31, the country's biggest private lender said.

Deposits rose 4.2% to 24.53 trillion Indian rupees (1.29 trillion), slowing from 5.1% rise in July-September quarter, the Mumbai-based

Its low-cost current and savings account deposits rose 1.1%, it said.
Gross advances, or loans sanctioned and

disbursed, rose 0.9% to 25.43 trillion rupees, slowing from 1.3% sequential growth in the

previous quarter.

HDFC Bank has the most assets among all

private banks in India.

It merged with its parent HDFC in July 2023, adding a large pool of loans to its portfolio but a much smaller volume of denosits

After the merger, HDFC Bank's loan-to-deposit ratio rose to around 110%, the putting it under pressure to boost deposits or slow loan growth

Over the past few months, it has offered retail loans for sale to reduce its loan-to-deposit ratio, a key metric for banks to assess their liquidity position.

In the December quarter, HDFC Bank securitised 216 billion rupees of loans "as a strategic initiative", it said.

Overall loan growth for Indian banks moderated for a fifth straight month in November, as lenders continued to rein in unsecured and personal loans after a central

bank crackdown on "exuberant" lending.
Separately, HDFC Bank said the Reserve Bank of India had allowed it to acquire a stake of up to 9.5% in Kotak Mahindra Bank, AU Small Finance Bank and Capital Small Finance Bank within a year from the approval date. –

Apple still barred from selling iPhone 16 in Indonesia: Minister

JAKARTA: Apple still cannot sell its iPhone 16 in Indonesia despite striking a deal to build a local production facility there, as it has not met domestic content rules, Industry Minister Agus Gumiwang Kartasasmita said yesterday.

Last year, Indonesia banned iPhone 16 sales after Apple failed to meet requirements that smartphones sold domestically should comprise at least 35% locally-made parts.
The minister said Apple had struck a deal

to build a facility producing its Airtag tracking device on Indonesia's Batam island, close to

Singapore, but that still would not count as a locally-made iPhone part.

"There is no basis for the ministry to issue a local content certification as a way for Apple to have the permission to sell iPhone 16 because (the facility) has no direct relations," he said adding the ministry would poly count he said, adding the ministry would only count phone components.

Indonesia's Investment Minister Rosan Roeslani said late on Tuesday the factory would be worth US\$1 billion (RM4.5 billion) and that it would start operations next year.

Agus, who held two days of meetings with

Apple's vice-president of global government affairs Nick Ammann, said Apple had proposed "innovative investment" which Indonesia had countered.

Apple has no manufacturing facilities in Indonesia, a country of about 280 million people, but has since 2018 set up application developer academies. – Reuters

WASHINGTON: Tech leaders continue to fall in line around Donald Trump, with Facebook's announcement that it would end its US fact-checking programme the latest victory for the president-elect and his billionaire adviser Elon

Facebook parent Meta's move into fact-checking came in the wake of Trump's shock election in 2016, which critics said was enabled by rampant disinformation on Facebook and interference by foreign actors, including Russia, on the platform.

The programme has long been

criticised by conservatives who found themselves ensnared in its anti-disinformation work.

Its paring down comes days before Trump's inauguration, and after several US tech barons have pushed for a comfortable relationship with the incoming president.

Since the November election, a stream of senior moguls have travelled to meet with Trump at his Florida estate, including Meta boss Mark Zuckerberg as well as Apple CEO Tim Cook and Amazon founder and space tech executive

Amazon and Meta have both announced US\$1 million donations to Trump's inauguration fund, as reportedly has Apple's Cook, in a personal capacity.

Musk, meanwhile, owner of influential social media platform X and the world's richest person, is one of the president-elect's closest advisers

It is all a far cry from when the Republican saw himself kicked off of Facebook and Twitter for the risk of inciting violence, following the storming of the US Capitol by supporters hoping to reverse the

2020 election results. Four years later, tech companies are coming off a Joe Biden administration that shook up much of the sector with antitrust investigations - with the free speech, deregulatory outlook pushed by those in Trump's orbit holding fresh appeal.

The fact-checking shake-up is "a decision that advances Zuckerberg's business goals: fact-checking is difficult, expensive and controversial," Ethan Zuckerman, a public policy professor who recently sued Meta over its algorithm policies, told AFP.

But for those in the right-wing

tech sphere, the decision is a course correction.

"For those of us who have been ror those of us who have been fighting the free speech wars for years, this feels like a major victory and turning point," investor David Sacks, set to take an artificial. intelligence portfolio in Trump's government, said.

He went on to thank the incoming president "for creating

Trump has been a harsh critic of Meta and Zuckerberg for years, accusing the company of bias against him and threatening to retaliate once back in office.

Zuckerberg and Trump has been a long time coming: Meta also recently put Trump ally Dana White on its board.

That decision, and the move to

slash the fact-checking operations, came after Trump's Federal Communications Commission pick, Brendan Carr, accused Facebook,

Google and Apple of "playing central roles" in a "censorship cartel".

Sam Altman, CEO at OpenAI, has meanwhile sent his own signals to the incoming administration, telling conservative broadcaster Fox News last month he was confident Trump would keep the United States a

leading player in the artificial intelligence sector.

His response to Musk's influence in the incoming administration –

which has sparked warnings of conflicts of interest - was also warm. "It would be profoundly un-American to use political power to hurt your competitors and advantage your own businesses," Altman said

"I believe pretty strongly that Elon will do the right thing." Brown University political

science professor Wendy Schiller is not surprised that social media companies like Meta are walking away from fact-checking because political parties and social media companies thrive when there is division.

He adds, however, that "the saving grace may be that there are still a number of competitive social media outlets so that no single person or company controls all the flow of information, and that includes government".

Facebook will be replacing its

fact-checking programme with a "community notes" style feature, similar to the one used on Musk's X

Musk quickly signalled his approval, calling the change "cool."

AI-influenced shopping boosts online holiday sales

FRANCISCO: intelligence-powered chatbots helped consumers purchase and return products during the 2024 holiday season, boosting online sales in the United States by nearly 4% year-over-year, according to a report by Salesforce. Retailers turned to nifty

conversational customer services – or chatbots – among others such as targeted promotions, product recommendations and loyalty programmes, to influence customers

hunting for trending products and best bargains.

Online sales rose to US\$282 billion (RM1.2 billion) in the United States between Nov 1 and Dec 31 from US\$272 billion a year ago, ahead of Salesforce's forecast of 2% growth, even as discounts were tempered.

Shoppers used Al-based chatbot ervices 42% more than a year ago, according to Salesforce, which analysed data from 1.6 trillion page views on its platform.

Al influenced-sales rose to US\$229

billion of global online sales between Nov 1 and Dec 31 from US\$199 billion in 2023, the report said. However, a high rate of product

returns by customers at 28%, compared with 20% in 2023 was a "significant concern" and could reduce the overall profit margins for retailers, said Caila Schwartz, director of Consumer Insights at Salesforce.

"Retailers who have embraced AI and agents are already seeing the benefits, but these tools will be even more critical in the new year as retailers aim to minimise revenue losses on returns and re-engage with

shoppers," Schwartz added.
Orders placed through smartphones peaked on Christmas day, as customers set out to do some last-minute shopping, with 79% of all orders being placed through mobile devices during the helicitudes are set of the source o

the holiday season, the report said. Apart from AI, retailers used social media sites such as TikTok Shop and Instagram to help generate interest, with social media driving 14% of all traffic to e-commerce sites. - Reuters

US to clear hurdles for civil nuclear tie-up with Indian firms

NEW DELHI: The United States is finalising steps to clear hurdles for civil nuclear partnership with Indian firms, US national security adviser Jake Sullivan said, seeking to give fresh momentum to a landmark deal between the two countries.

Washington and New Delhi have been discussing the supply of US nuclear reactors to energy-hungry India since the mid-2000s.

India since the mid-2000s.
But a long-standing obstacle has been the need to bring Indian liability rules in line with global norms which require the costs of any accident to be channelled to the operator rather than the maker of a nuclear power plant.

The deal was signed by then President George W. Bush in 2007, a major step toward allowing the United States to sell civilian nuclear

technology to India.
"United States is now finalising the necessary steps to remove long-standing regulations that have prevented civil nuclear cooperation between India's leading nuclear entities and US companies," Sullivan

said during his visit to New Delhi. Washington expects the impact of Chinese upstream dams, artificial intelligence, space, military licensing and Chinese economic overcapacity to be discussed while Sullivan is in New Delhi, a US official earlier said.

The two countries agreed in 2019 to build six US nuclear power

plants in India.

The South Asian nation's stringent nuclear compensation laws have previously hurt deals with foreign power plant builders, subsequently deferring India's target to add 20,000 MW of nuclear power from 2020 to

WuXi Biologics to sell Ireland facility to Merck

DUBLIN: China's WuXi Biologics said it will sell its vaccine facility in Ireland to Merck for about US\$500 million (RM2.2 billion).

WuXi had previously said it was planning to sell some of its operations as the company, along with other Chinese firms, has been at the centre of new US laws aimed at restricting their businesses in the United States due to national security concerns.

The bill, called the Biosecure Act, which was passed by the US House of Representatives in September, is designed to keep Americans' personal health and genetic information from foreign adversaries and to push local pharmaceutical and biotech companies to reduce their reliance on China for everything from drug ingredient manufacturing to early

WuXi AppTec had said in December its subsidiaries had signed a deal with US-based private equity firm Altaris LLC for the sale of its cell and gene therapy manufacturing unit, WuXi Advanced Therapies, for an undisclosed sum

UK firms lose momentum, cut staff in December

Slump in corporate morale after govt's budget rumbles on

LONDON: British business activity growth slowed to a crawl in December and employers cut staffing at the fastest rate in almost four years as a slump in corporate morale after the government's budget rumbled on, a survey

The final headline UK S&P Composite Purchasing Managers' Index (PMI) inched down to 50.4 from 50.5 in November, its lowest since October 2023. A preliminary reading for December had also been 50.5.

The survey is barely above the 50 dividing line between growth and contraction and adds to a run of lacklustre economic indicators since Chancellor of the Exchequer Rachel Reeves announced the biggest tax rises since 1993 in October.

British Chambers of Commerce reported that confidence fell to its lowest since just after former prime minister Liz Truss' "mini-budget" in 2022 while concern about tax rises was the highest since at least 2017.

Britain's economy stagnated in the three months to September and the Bank of England

(BoE) has estimated that it will flatline again in the fourth.

While the central bank thinks higher public

spending will temporarily boost growth this year, a big question for its policymakers as they consider how quickly to cut interest rates is whether Reeves' tax rises lead mostly to lower employment, higher prices or reduced profits and investment.

Investors are pricing in just two quarter-point rate cuts by the BoE in 2025 as

inflation pressures remain sticky.
"A post-budget slump in business optimism persisted in December, with output growth expectations for the year ahead unchanged from November's 23-month low," said Tim Moore, economics director at S&P Global Market Intelligence.

Elliott Jordan-Doak, senior economist at Pantheon Macroeconomics, said PMI data over the fourth quarter was consistent with economic growth of 0.1%-0.3%, slightly stronger than the BoE's forecast but still a weak level of momentum for the economy as it starts 2025. "The drop in the PMI now looks more driven by a genuine deterioration in growth rather than

the usual over-reaction to uncertainty."

The PMI showed businesses shed jobs at the fastest rate since January 2021, during a Covid-19 lockdown.

Companies that had cut staffing in

December overwhelmingly cited rising costs, in particular due to Reeves' increase in employer

social insurance contributions from April.

The PMI's gauge of future output fell to its lowest level since December 2022 while costs faced by businesses increased at the fastest pace

since April.

"Nearly one-in-four survey respondents saw an overall decline in their payroll numbers.
Excluding the pandemic, this represented the steepest pace of job shedding for more than 15 years." Moore said.

The BCC survey of nearly 5,000 businesses showed that 55% of firms planned to raise prices, up from 39% the quarter before, while 24% intended to cut investment, up from 18% previously.

A separate survey by the Federation of Small Businesses showed that 67% of respondents planned to recruit fewer staff and 32% intended to reduce headcount. – Reuters

Musk offers secure services to Italy

MILAN: Elon Musk said he was ready to provide Italy with secure communication services after Prime Minister Giorgia Meloni denied that the issue had come up during a weekend visit to the United States

Meloni has developed a strong relationship with Musk, a close ally of incoming US President Donald Trump, and Rome is evaluating potential supply accords with the tech billionaire's Starlink business, part of his SpaceX company.

However, Meloni's office denied any agreement had been reached on the supply of new services and dismissed attempts to link the issue to her surprise visit to meet Trump at his Mar-a-Lago residence in Florida last Saturday.

"The prime minister's office categorically denies, considering it ridiculous, that SpaceX was a topic during the meeting with US

President-elect Donald Trump," Meloni's office said in a note.

"Contacts with SpaceX are part of regular discussions that state departments have with companies, in this instance those that provide protected connections such as data encryption.

Bloomberg News reported earlier that Italy's discussions with SpaceX, "which had stalled until recently, appeared to move forward" after Meloni's meeting with Trump.

Musk was happy to promote his services. He said in a post on X that he was "ready to

provide Italy the most secure and advanced connectivity!". Musk's aerospace business SpaceX owns

Starlink, a telecommunications provider that relies on a network of low Earth orbit satellites.

Starlink has been offering its services in Italy

since 2021, but its business in the euro zone's third-largest economy is modest, with a customer base of around 50,000.

Italy is considering using Starlink services to boost Internet penetration in remote areas in response to slow progress in public-funded fibre rollout programmes.

Deputy Prime Minister Matteo Salvini urged

the government to accelerate efforts to do a deal with Musk "to guarantee connectivity and with Musk "to guarantee connectivity and modernise all of Italy". "A potential accord would not be a danger but

an opportunity," the League party leader said. In October, the Foreign Ministry said Italy was also evaluating using Starlink systems to enhance communications for Italian diplomats and defence officials operating in risky areas across the Mediterranean. - Reuters

German inflation rises more than expected

BERLIN: German inflation rose more than forecast to 2.9% in December, preliminary data from the federal statistics office showed.

Analysts polled by Reuters had forecast a reading of 2.6% in December, after a year-on-year increase in consumer prices of 2.4% in November, based on data harmonised to compare with other European Union countries.

Core inflation, which excludes volatile food and energy prices, went up to 3.1% from 3% in November.

Energy prices fell by 1.7% compared with the previous year, while food prices rose by 2% year-on-year in December, data from the statistics office showed.

Economists pay close attention to national inflation data, as Germany publishes its figures just before the euro zone inflation data release.

Euro zone inflation is expected to rise to 2.4% in December from 2.2% in November.

Eurozone investor morale at lowest in over a year

FRANKFURT: Investor morale in the eurozone fell in January to its lowest in more than a year, a survey showed, with Germany remaining a continued drag on

the bloc.
The Sentix index for the eurozone dropped to -17.7 in

January from -17.5 in December.
That is the lowest level since November 2023, though it was not as bad as the -18 forecast by analysts polled by Reuters.

"In the eurozone, the economic engine is threatening to freeze up for the long-term," the survey said, adding that Germany's recessionary economy "is hanging on to the eurozone

The survey of 1,121 investors from Jan 2 to Jan 4 showed expectations slightly improved to -5.0 in January from -5.8 points last month.

But that gain was outweighed by the worsening view of the current situation, which sagged to -29.5 in January from -28.5 in December. That is the lowest level

since October 2022.

The survey also found that Germany – Europe's largest economy and one facing federal elections next month - appears to be in recession and is unlikely to emerge from it any time soon

FBM KLCI closes at intraday low on profit-taking

THE FBM KLCI reversed Tuesday's gains to close lower yesterday as investors took profit amid the negative performance of regional peers.

At 5pm, the FBM KLCI fell 14.96 points or 0.92% to end at its intraday low of 1,614.83 from Tuesday's close of 1,629.79.

The benchmark index opened 0.87 of-a-point easier at 1,628.92 and hit an intraday high of 1,631.15 during the early morning session.

Decliners trounced advancers 827 to 285 on the broader market, while 497 counters were unchanged, 761 untraded, and 10 others suspended.

Turnover narrowed to 3.59 billion units valued at RM3.06 billion against Tuesday's 3.91 billion units valued at RM3.29 billion.

UOB Kay Hían Wealth Advisors head of investment research Mohd Sedek Jantan noted that major Asian indices followed Wall Street's downbeat performance, driven by the ripple effects of a broad-based selloff in US Treasuries.

He said investors remained cautious, with many refraining from taking significant positions ahead of key US employment data due later this week. Adding to the uncertainty is whether incoming President Donald Trump will shift towards a looser tariff policy.

Among the heavyweights, Petronas Gas added six sen to RM17.82 and YTL Power gained one sen to RM4.51, while Tenaga Nasional and Press Metal were flat at RM14.32 and RM4.79 respectively.

For active stocks, ACE Market debutant Swift Energy increased 11.5 sen to 39.5 sen, UEM Sunrise went up four sen to RM1.14, while Dagang NeXchange and Bumi Armada slid one sen each to 41.5 sen and 67.5 sen respectively. – Bernama

TOP GLOVE is optimistic of a strong sequential rebound in earnings recovery in Q2'25 due to the absence of high-priced inventory, a slight increase in ASP, and favourable forex. However, it expects flattish volume sale in the months of Jan and Feb 2025 due to the frontloading effects of US customers purchasing from Chinese glove makers before the 50% tariff imposition effective Jan 2025 compared to a 8%-10% M-o-M growth in Nov and Dec 2024. Thereafter, the group expects order shipments from the US customers to accelerate from end-Feb 2025.

The company noted that a more pronounced effects of rising ASP will only be felt after Feb 2025 due to the frontloading effects of US customers purchasing from Chinese glove makers. We conservatively assume ASP of US\$2071,000 pieces in our earnings model. It is optimistic that ASPs are expected to inch up gradually by 3% each month from Nov 2024 onwards. However, due to the lag effect, ASP increases will only be felt gradually starting from Dec 2024. Typically, ASP for the US market is higher by US\$1.00/1,000 pieces compared to the rest of the world. Currently, the ASP is at US\$19-20/1,000 pieces. We conservatively assumed ASP of US\$20/1,000 pieces in our earnings model.

It has seen more enquiries from its US customers. The group highlighted that its exports to the US are continuing to show improvement which rose 21% QoQ in Q1'25. US sales accounted for 18% of total group volume sales, above the 15% mix for FY24, but still below the pre-pandemic average of 20–30%.

Ringgit ends lower as positive US data boosts greenback

THE ringgit retreated from Tuesday's gains to close lower against the US dollar yesterday, as positive data from the US prompted investors to return to the greenback

investors to return to the greenback.

At 6pm, the ringgit slid to 4.5000/5050 against the greenback from Monday's close of 4.4850/4900.

Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid told Bernama that the ringgit was mostly flat against the greenback with USD/MYR ranges between RM4.4885 and RM4.5005.

"Positive data points in the US last night, such as Job Openings and ISM Index for the non-manufacturing sector, have bolstered the case for a gradual monetary easing by the US Federal Reserve. "As such, markets will observe incoming information such as

"As such, markets will observe incoming information such as the Federal Open Market Committee minutes and the labour market data in December. The Nonfarm Payroll statistics will be released on Friday with consensus pencilling in for 154,000 jobs creation in December, lower than 227,000 in November," he said.

Meanwhile, the ringgit closed higher against other currencies. It strengthened versus the Japanese yen to 2.8449/8482 from Tuesday's close of 2.8458/8492, advanced against the British pound to 5.6020/6083 from 5.6341/6403 and rose vis-a-vis the euro to 4.6431/6483 from 4.6756/6808.

The local note also traded higher against Asean currencies. It climbed against the Thai baht to 12.9949/13.0168 from 13.0045/0258 at the previous close and was higher vis-a-vis the Indonesian rupiah at 277.5/278.0 compared with 277.7/278.2.

The ringgit appreciated marginally versus the Singapore dollar to 3.2919/2958 from 3.2983/3022 and also against the Philippine peso to 7.70/7.72 from 7.71/7.72 on Tuesday. – Bernama



WE view the latest signing of the Johor-Singapore Special Economic Zone (JS-SEZ) as positive for the construction sector, as a key goal is to attract 100 projects in the first 10 years, that are on sectors like aerospace, electronics and tourism. Malaysia will establish an infrastructure support fund related to the JS-SEZ while Singapore will design funding support to facilitate Singapore companies' expansion in the JS-SEZ.

In our view, infrastructure support which relates to contractors

In our view, infrastructure support which relates to contractors would cover road connectivity as the JS-SEZ is spread across nine flagship areas: Johor Bahru (JB) City Centre, Iskandar Puteri, Tanjung Pelepas-Tanjung Bin, Pasir Gudang, Senai-Skudai, Sedenak, Forest City, Pengerang Integrated Petroleum Complex and Desaru. A key contractor involved in road-related projects in Johor is Kimlun Corp (KICB MK, NR) via the upgrade of Senai-Desaru Expressway from Jambatan Sungai Johor to Sungai Semenchu.

Priority sectors under the JS-SEZ that may benefit contractors include logistics, electrical and electronics and manufacturing a midst the need to construct industrial buildings such as logistic hubs and factories. Data from the National Property Information Centre (Napic) shows that the overhang in industrial buildings has been on a downtrend.

We envisage contractors such as SCGB and JJM to be at the forefront of such related industrial opportunities. SCGB has clinched MYR3.9bn worth of data centre (DC) jobs in Johor, which could put it in a strategic position to aim for other industrial buildings, namely warehouses and semiconductor manufacturing jobs. Meanwhile, JJM only has started building DCs in Iskandar Puteri and Gelang Patah in Johor but we are reassured by its presence in building semiconductor facilities in Penang and warehousing logistic hubs in Selangor, which could make JJM a good fit. – RHB Research, Jan 8

How math could make moving sofas effortless

WHO has not struggled to haul a sofa through a tight corner or a cramped stairwell? This seemingly trivial conundrum presents one of the most fascinating mathematical problems our time. Now a South mathematician claims to have solved this

themselves in Episode 16 of Season 5 of the hit TV show *Friends*, when Ross, Rachel and Chandler struggle to squeeze a sofa through the stairwell of their apartment building. After many unsuccessful attempts, the three friends reluctantly decide to cut the sofa in half – a radical decision that could have been avoided, according to mathematician Jineon Baek

The researcher from Yonsei University, South Korea, claimed to have solved the famous "moving sofa problem" – a mathematical conundrum first formulated in 1966 by Austrian-Canadian mathematician Leo Moser, to find the largest sofa size that could fit around a corner of a given width. Baek based his work on the Gerver sofa model, developed in 1992 by Rutgers University professor Joseph Gerver. This theoretical form, with its elaborate design, combines a U-shaped front, a flat back with rounded edges and armrests with straight front faces. The strange shape makes for the largest possible area that could move around a right-angled

corner of a hallway with a unit width of one.

After numerous calculations, Baek
determined that the maximum surface area of
a Gerver sofa is 2.2195 square units. Beyond this size, a sofa would no longer be able to get past a right-angled corner in a narrow corridor, as he explains in a detailed, over 100-page paper published on the ArXiv platform. In other words, to avoid getting stuck, it is best to opt for a horseshoe-shaped sofa

Baek's work is not yet complete, however. His solution must now be scrutinised by other mathematicians to confirm its validity. If his conclusions are given the thumbs-up, they will put an end to an enigma that has fascinated

mathematicians for almost 60 years.

Although this discovery may seem highly theoretical, it could have concrete applications. For example, designers could draw inspiration from this research to design sofas specially adapted to these kinds of constraints. And that could make moving house a whole lot easier. - ETX Studio

Water-based workouts ideal for those with joint problems

if the participant is overweight.

When recovering from joint pains and aches, you should not place too much stress on the affected areas. Hence water-based exercises are highly recommended as being in a swimming pool greatly reduces the pressure

Water is significantly more dense than air, making exercises performed in the former more demanding compared to those done on land. The increased resistance when walking in water enables you to work your muscles more effectively than with land-based exercises. It also helps you burn additional calories, which can contribute to weight loss. One of the simplest exercises is water

walking – a low-impact cardiovascular activity. Being gentle on bones and joints, it is a safer option for individuals with conditions like arthritis, osteoporosis or fibromyalgia.

To begin, try walking in water that reaches about your waist level. Concentrate on maintaining proper form by keeping your:

Core and back muscles engaged

- Back straight and lengthened Shoulders back
- Chin up, with your head facing straight ahead
- Ears aligned over your shoulders

- Also ensure that you:

 Steep your torso upright without leaning too
- far forward or to either side
- Walk with long strides
- Press into your heel first before rolling your weight onto your toes
- Swing your arms as you walk

Once you have mastered water-walking, you can move into deeper water. Begin by walking slowly and then gradually increase your speed. - by R. BALA



Alcaraz staring at Grand Slam final frontier

THERE is little doubt Carlos Alcaraz is one of the brightest stars of his generation with Grand Slam success on all three surfaces but the Spaniard will arrive at the Australian Open looking to conquer the final frontier of his

Should he lift the Norman Brookes Challenge Cup at Melbourne Park later this month, the 21-year-old French Open and Wimbledon champion will become the youngest man to complete a career Grand Slam

- the feat of winning all four major titles. Victory would put the 2022 US Open champion in the elite company of Fred Perry, Don Budge, Rod Laver, Roy Emerson, Andre Agassi, Roger Federer, Rafa Nadal and Novak Djokovic, cementing his status as a modern

Alcaraz has not gone beyond the quarterfinals in his three previous visits to Melbourne, but that has not stopped the world No. 3 from dreaming of glory in the Jan. 12-26

event.
"I have it in mind to get a tattoo of a kangaroo," Alcaraz told Spanish outlet *Marca* recently, referring to the tradition of immortalising his major triumphs on his skin. "The goal is to complete the Grand Slam in Melbourne.

"Every player wants to be in the final, to go as far as they can during tournaments. This year, I've played great tournaments and really bad tournaments," said Alcaraz, who responded to his critics by winning the China Open, beating Sinner in the final.

"My goal at the end is to be there all the time,

to at least reach the semifinals and final to give myself the chance to win tournaments.

"I have to work. I'm still super young, so I have or I hope to have many years to get there. Let's see in 2025, I hope to be a better player and

(show) more consistency."

Federer, who watched Alcaraz live for the first time during his triumphant Wimbledon defence shortly after his Roland Garros victory, believes the Spaniard has what it takes to capture the one major title that has eluded him

"He will win an Australian Open, the question is when," said Federer. "He's had the most incredible career already.

"It's fantastic that he's already got four Grand Slams without talking about all the other stuff that he's achieved. Fantastic effort." - Reuters

Five men to watch Down Under

NOVAK DJOKOVIC is targeting an 11th Australian Open title and record 25th Grand Slam crown but faces an uphill battle against Jannik Sinner and Carlos Alcaraz, Here are five potential winners of the first Grand Slam of the year, which begins on Sunday:

Novak Djokovic

He may be 37 but the Serb can never be written off on Melbourne Park's blue hardcourts. where he has enjoyed enormous success. Ranked seven in the world, Djokovic won Olympic gold in 2024 but failed to collect a major for the first time since 2017, leaving his bid to better Margaret Court's all-time 24 Slam titles unfulfilled. Beaten in the Melbourne semifinals last year by eventual champion Sinner, he has enlisted the help of long-time rival Andy Murray as coach to try and help him achieve the feat. Should he do so, it will be his 100th career title, just the third man in the Open era to reach the milestone behind Jimmy Connors (109) and Roger Federer (103).

Jannik Sinner

The Italian won his maiden Grand Slam title in Australia last year, beating Daniil Medvedev in the final, and went on to establish himself as the undisputed world No. 1. He won eight titles in 2024, including his second major at the US Open while making the semis at Roland Garros and Wimbledon. But the 23-year-old's season was rocked by doping accusations that he denies. He is still waiting for the outcome of a World Anti-Doping Agency appeal against his initial exoneration for twice testing positive for traces of the steroid clostebol in March.

Carlos Alcaraz

Still just 21, the Spaniard already owns four Grand Slam titles – including the French Open and Wimbledon last year – since bursting on the scene with victory at the US Open in 2022. Already the youngest man to claim majors on all three surfaces – clay, hard and grass – he will surpass compatriot Rafael Nadal as the youngest to complete a career Grand Slam should he triumph in Australia. Alcaraz, who has never lost a Grand Slam final, finished an injury-marred 2024 as the world No. 3 after winning four titles to take his career tally to 16.

Alexander Zverev

The German has been pursuing a Grand Slam breakthrough for nearly a decade, finishing runner-up at the French Open in 2024 and the US Open in 2020 but unable to take the final step. After suffering an ankle injury in the semifinal of Roland Garros in 2022, his return to the top was slow. In that time, Sinner and Alcaraz took up the mantle of Grand Slam kings. But the 27-year-old heads into the new season with renewed vigour after ending 2024 as world number two, winning more matches than anyone bar Sinner. A twotime semifinalist in Australia, including last year when he lost to Daniil Medvedev, Zverev knows he needs to win majors.

Daniii Medvedev

The feisty Russian failed to win a title last year. but has often done well at the opening Grand Slam of the year, reaching three of the last four finals. He was outplayed by Djokovic in 2021 before a heart-wrenching defeat to Rafael Nadal a year later, then imploded against Sinner in 2024, crashing in five sets after being two up. With Sinner and Alcaraz starting to dominate, the 28-year-old admitted in the off-season that he must "reinvent" himself, reducing his error-count and becoming more aggressive. The 2021 US Open champion is currently world No. 5 and will begin his bid for a second major title after a low-key build-up.

Point to prove

Djokovic fired up to prove mettle against young brigade at Australian Open

OVAK DJOKOVIC returns to the scene of his greatest triumphs this week at the Australian Open, adamant he is ready and able to see off the challenge from Jannik Sinner and Carlos Alcaraz in his pursuit of a record 25th Grand Slam crown.

Chinks in the armour of the 37-year-old former world No. 1 were exposed last year when he failed to clinch a major title for the first time since 2017, although he did win Olympic gold.

The Serb's fallibility was again on show when he was bundled out of the Brisbane International last week in the quarterfinals by American Reilly Opelka.

But with fellow great Rafael Nadal joining Roger Federer in retirement, Djokovic is fired up to prove he still has what it takes against the young brigade.

Djokovic has brought in former rival

Andy Murray as coach in an eye-catching move that he hopes will give him a winning edge.

"The way I'm feeling, I still think that I can go strong for years to come," said Djokovic, now ranked seven in the world.

"I still love this sport and I still love competing. I'm ready to compete, whatever it takes, however many hours it takes with the youngsters."

Few would bet against Djokovic on the blue hardcourts of Melbourne Park, where he has long been a dominant force, winning a record

Another would give him 25 major crowns to move him clear of Margaret Court as the outright leader.

Djokovic's stamina and skill will be put to the ultimate

test against world No. 1 and defending champion Sinner, just 23, and Alcaraz, already a fourtime Slam winner at 21.

While Djokovic warmed up in Brisbane, Italy's Sinner

and Spaniard Alcaraz opted against any competitive action with exhibition matches in Melbourne this week their main preparation.

Sinner won his maiden Slam in Australia last year, battling back from two sets down to beat Russia's Daniil Medvedev.

It lit the fuse to a sensational season where he became the first player since Federer in 2005 to go the year without a defeat in straight sets.

He made the semis at Roland Garros and Wimbledon, won the US Open and ATP Finals,

and surged to the top of the rankings.

Alcaraz won Wimbledon and the French Open last season to cement his status as the

future of the game, along with Sinner.

According to reports in Spain, Alcaraz has switched to a heavier racquet in the off-season to generate more speed with his forehand on

to generate more speed with his forenand on the Melbourne Park surface. "Everything is an extra weapon to counteract the game of rivals such as Jannik Sinner and Alexander Zverev, among others," said his coach Samuel Lopez. - AFP

DEFENDING champion Jannik Sinner should be riding the crest of a wave as he prepares for the Australian Open as the dominant force in men's tennis, but instead returns to the scene of his maiden Grand Slam title under a cloud

On the court, the 23-year-old Italian has opened a gap to his rivals, ending last year as the clear world No. 1 after a remarkable season in which he won eight titles and lost only six of the 79

matches he contested. He crowned 2024 with the ATP Finals title and also led Italy to a successive Davis Cup crown.

Sinner gives the impression of a player with all the answers against whoever he comes up against, but the off-court questions he is likely to face about the doping case that surfaced in August might be harder to shrug off.

He was cleared of any wrongdoing after failing two drug tests in March – an independent tribunal convened by the International Tennis Integrity Agency (Itia) accepting that the anabolic agent clostebol had inadvertently entered his system from a member of his support team through massages.

Sinner, who has always maintained his innocence, was docked the 400 ranking points and prize money he earned for reaching the semifinals at Indian Wells where the tests were carried out, but escaped a ban, raising eyebrows among some in the tennis community who cried double standards.

Sinner will attempt to continue to let his racket do the talking but with the world's glare on the year's first Grand Slam, the saga is unlikely to fade into

The two-time Grand Slam champion spent Christmas in the snow in northern Italy, conceding it was a tough time after the death of his aunt at the end of last

He has quickly warmed to the task of defending his Australian Open title since landing in Melbourne though, looking sharp in an exhibition match win over Australian Alexei Popyrin on Rod Laver Arena yesterday.
"Coming back here as the

reigning champion feels good, it's a different sensation, but I'm genuinely looking forward to it. Let's see how I can perform," Sinner said after that win.

"In my mind, I know how much work we have put in, which hopefully will give me confidence and we will see how it goes." Reuters

a lot. It's just different to the Premier League ball and we have to adapt to that. It flies different, the grip is very different as well."


